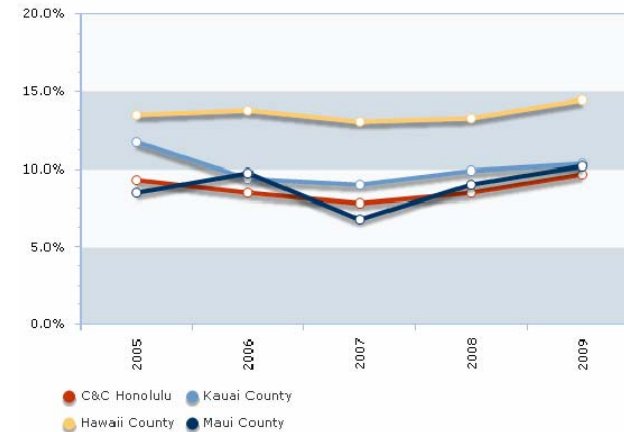

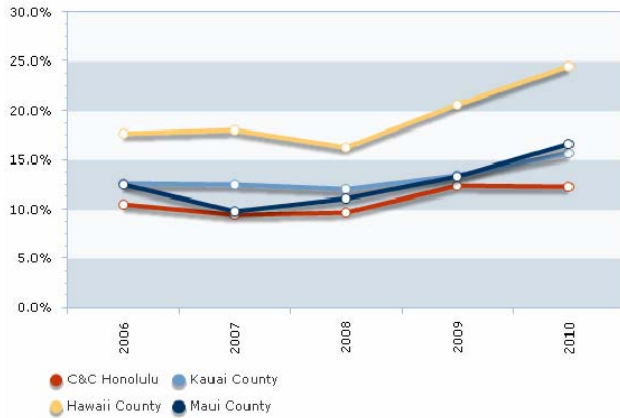

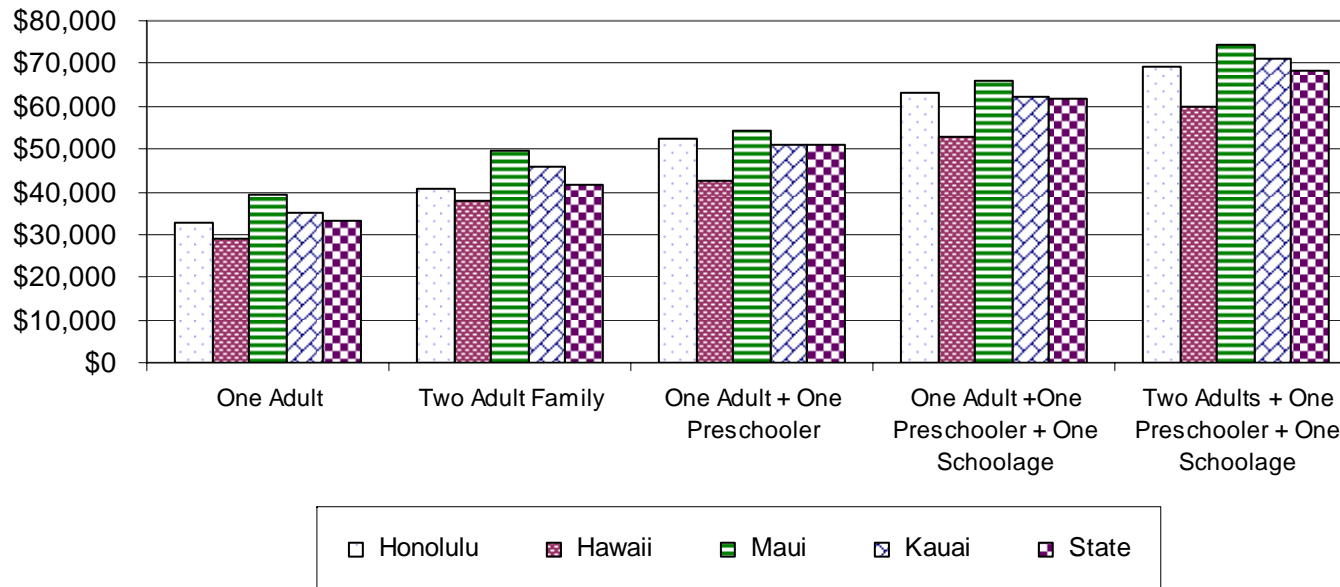

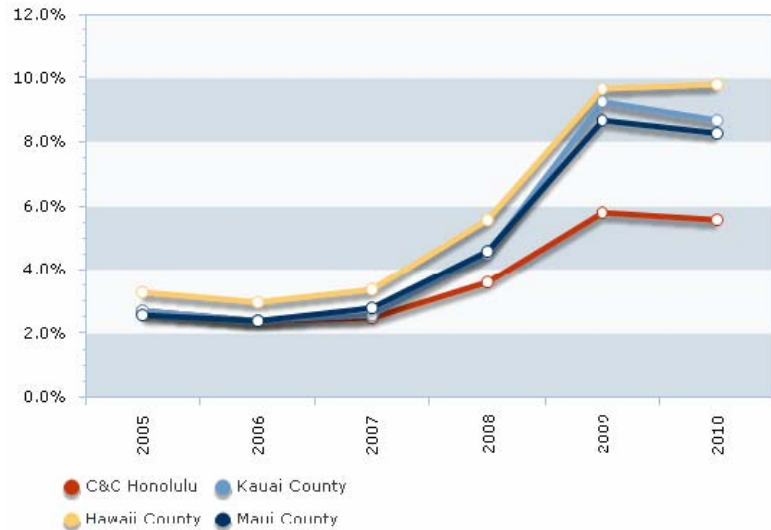

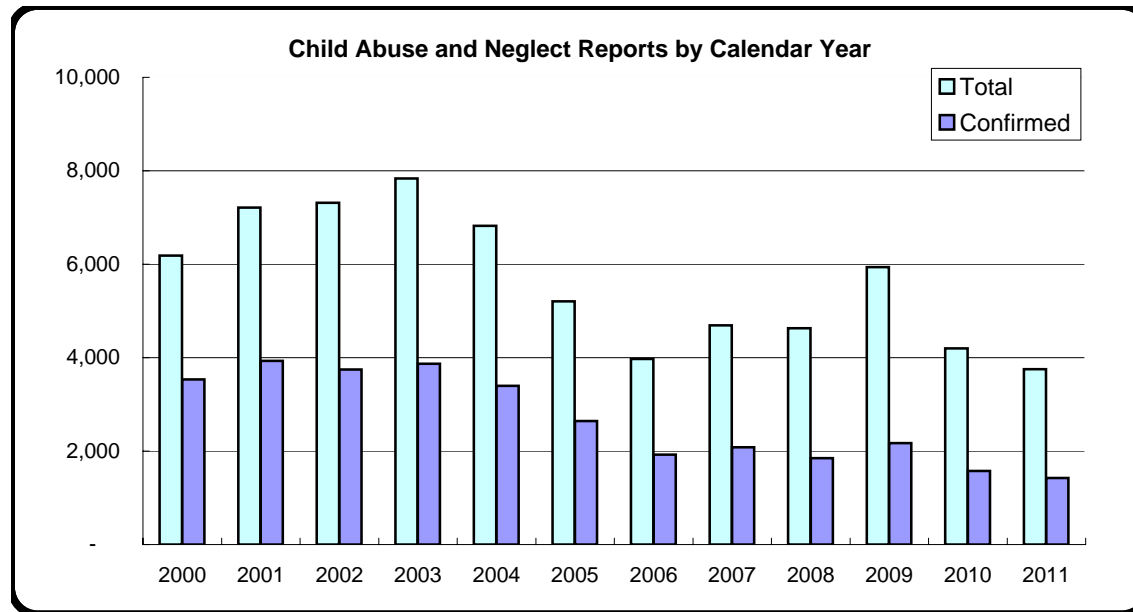

An intake usually refers to a family unit and may involve the possible maltreatment of more than one child. 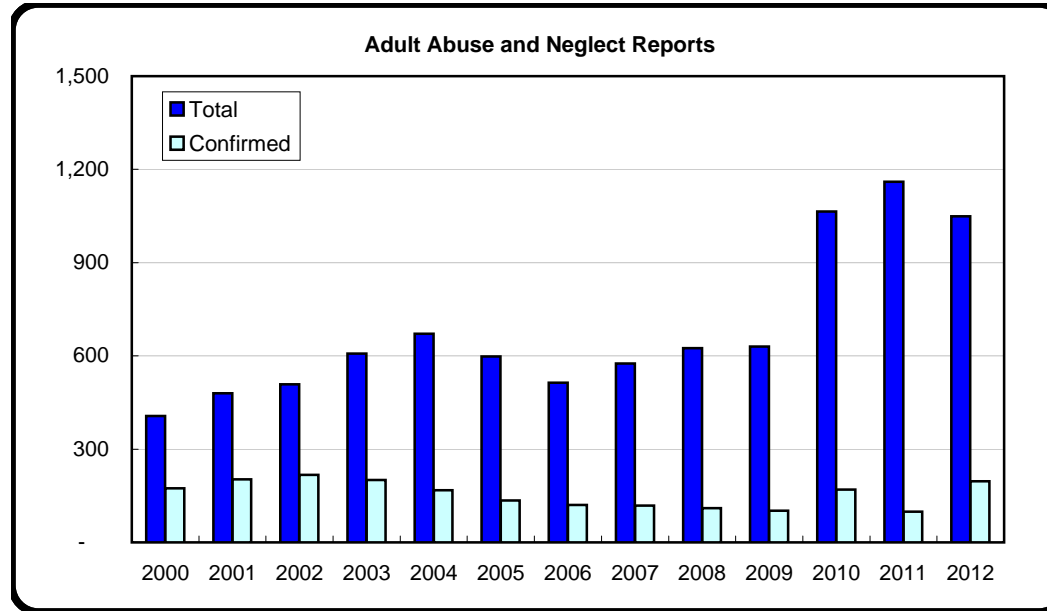

A vulnerable adult is defined as anyone 18 years or older with a mental, developmental or physical impairment who is also unable to:

- 1) communicate or make responsible decisions to manage his or her own care or resources
- 2) carry out or arrange for essential activities of daily living, or
- 3) protect oneself from abuse.

In addition, reports meet the standard whether the abuse has occurred or the vulnerable adult is in danger of abuse if immediate action is not taken.

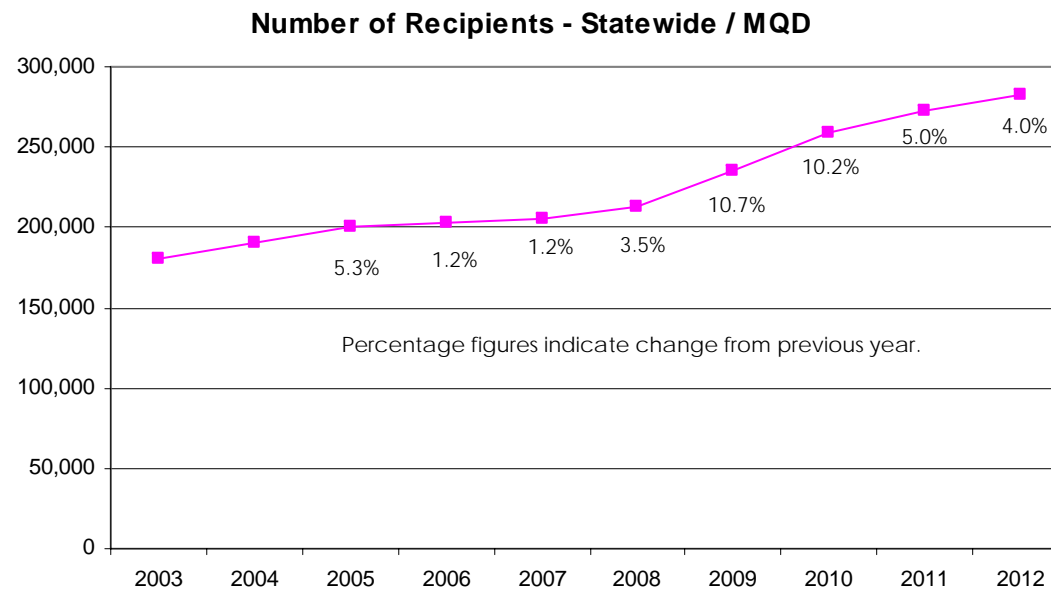

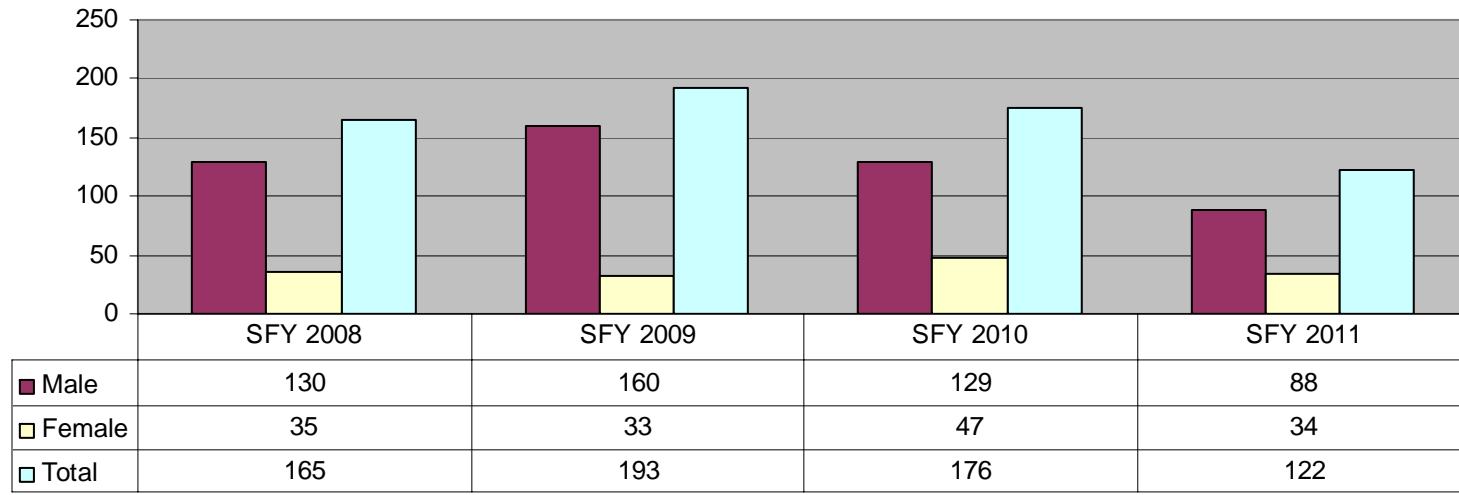
