## Overview

Hawaii's FFY 2023 APSR Data Booklet is an integral part of the FFY 2023 ASPR. The figures contained in this booklet are referenced throughout the FFY 2023 APSR and provide detail and graphic representation of the relevant data. Although, there may be occasional clarifying notes following the figures in this booklet, it is recommended that the data in this booklet be reviewed along with the accompanying narrative in the FFY 2023 APSR for proper context, and a more complete understanding.

The data contained in this booklet was gathered from internal Department of Human Services (DHS) sources, community stakeholders, partners, and contracted providers, then compiled and presented in these figures to help inform the reader.

The Child Welfare Services database, Child Protective Services System (CPSS), was the source of much of the data. Within CPSS, data does not remain static; rather it will experience some temporal flux due to the addition or modification of data following the extraction of data for a report. The data extracted farther from the period being reported is usually more stable than data extracted closer to the report period. Please consider this as you encounter discrepancies between the data in this booklet and other historic data reports.

### Extraction and reporting protocols:

- Hawaii's State Fiscal Year (SFY) begins on July 1 and runs through June 30 of the following year.
- Child's age is calculated as of: the last day of the report period if the child is still in care or receiving the service being reported; the date of exit from foster; or at the date of a specific event, *e.g.*, adoption or award of legal guardianship, depending on the information being reported.
- Child's age is reported in years, as an integer, *e.g.*, age 0 includes birth to the day before the child's first birthday, age 1 includes the first birthday to the day before the child's second birthday. [0.0 through 0.99 = 0, 1.0 through 1.99 = 1]
- Counts of children in care and recipients of services/benefits:
  - Monthly average, or more accurately average monthly, data looks at the total count for each month and then combines and averages the total over 12 months. This provides a more realistic measure/approach to service needs and capacity. Individuals are unduplicated within a month but might be duplicated in the total of all months.
  - Annual count, used in reporting per SFY, is an unduplicated count of all who received that service during the stated year.

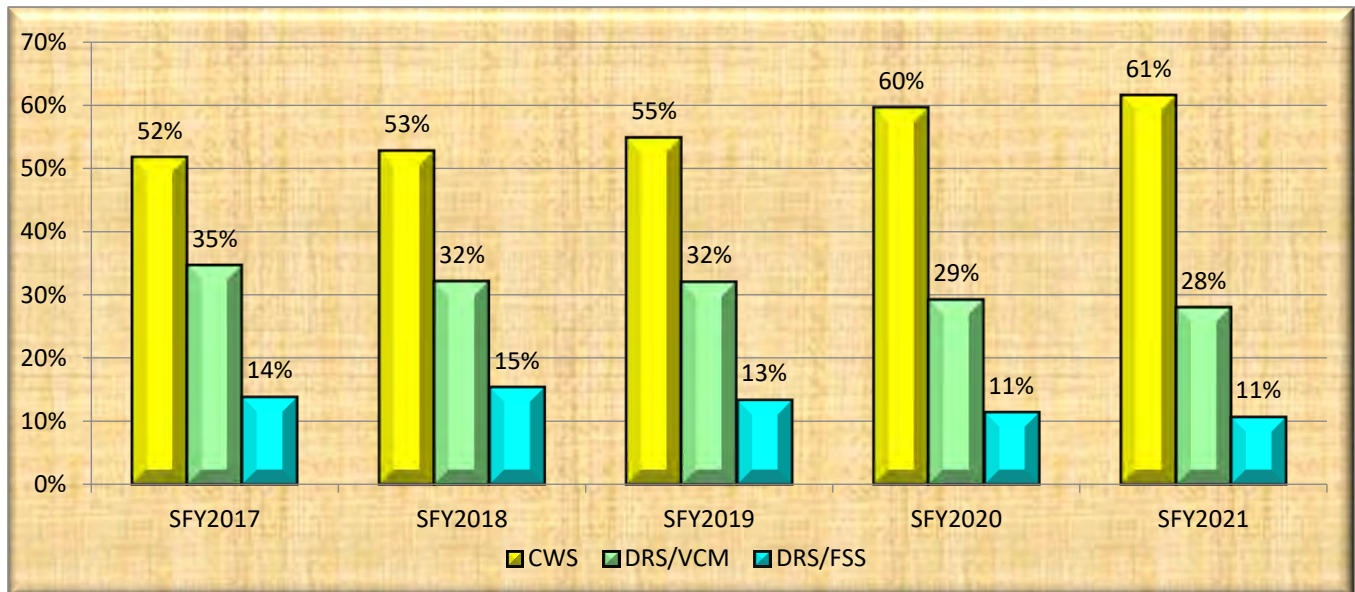

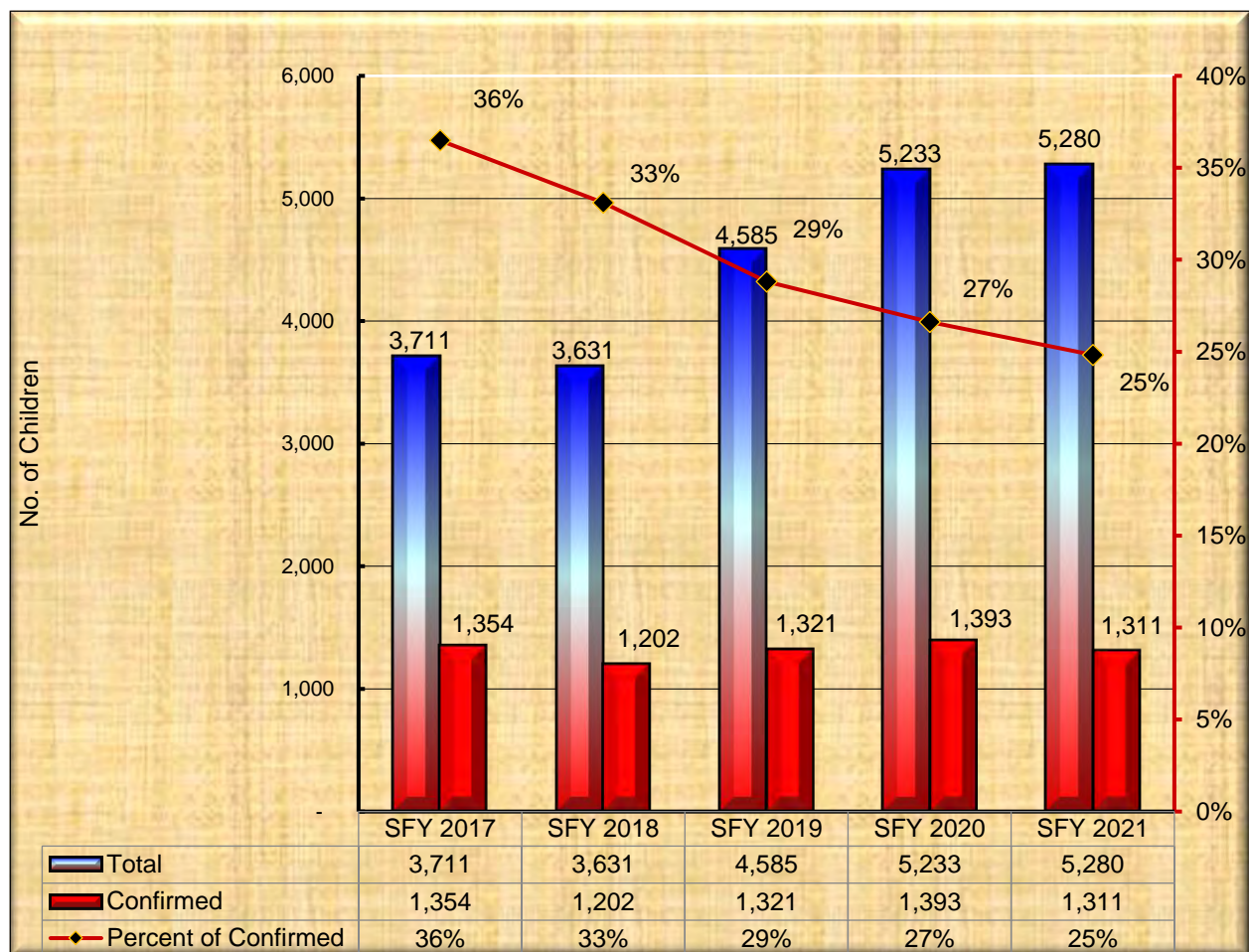

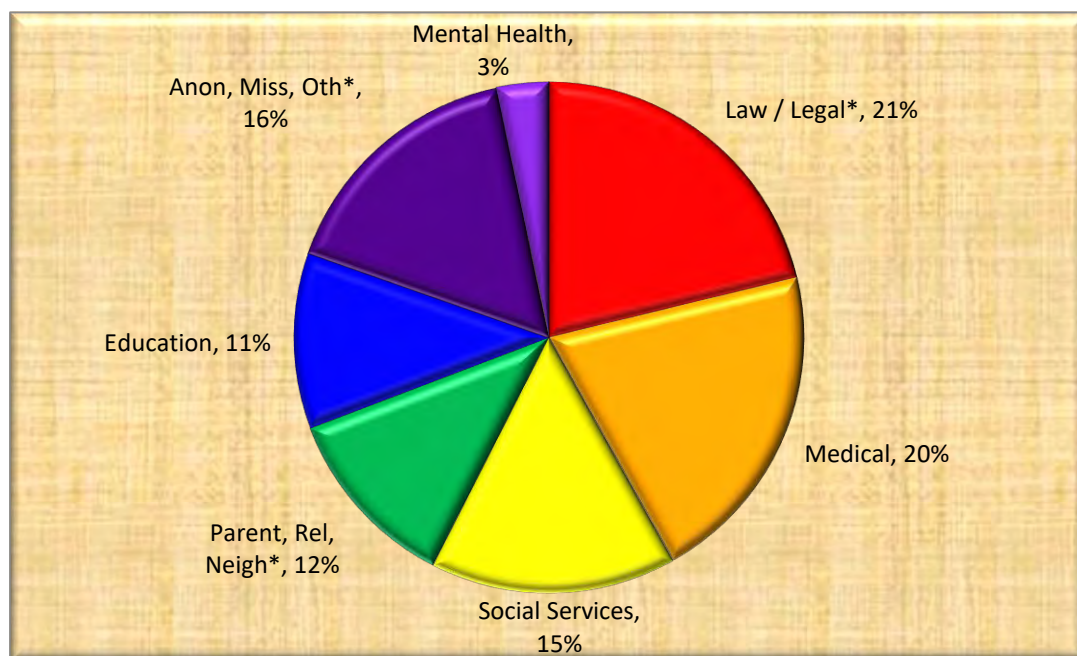
Figure 8: Report Sources of Total Reported Intakes with Disposition in SFYs 2017 – 2021 [Table]

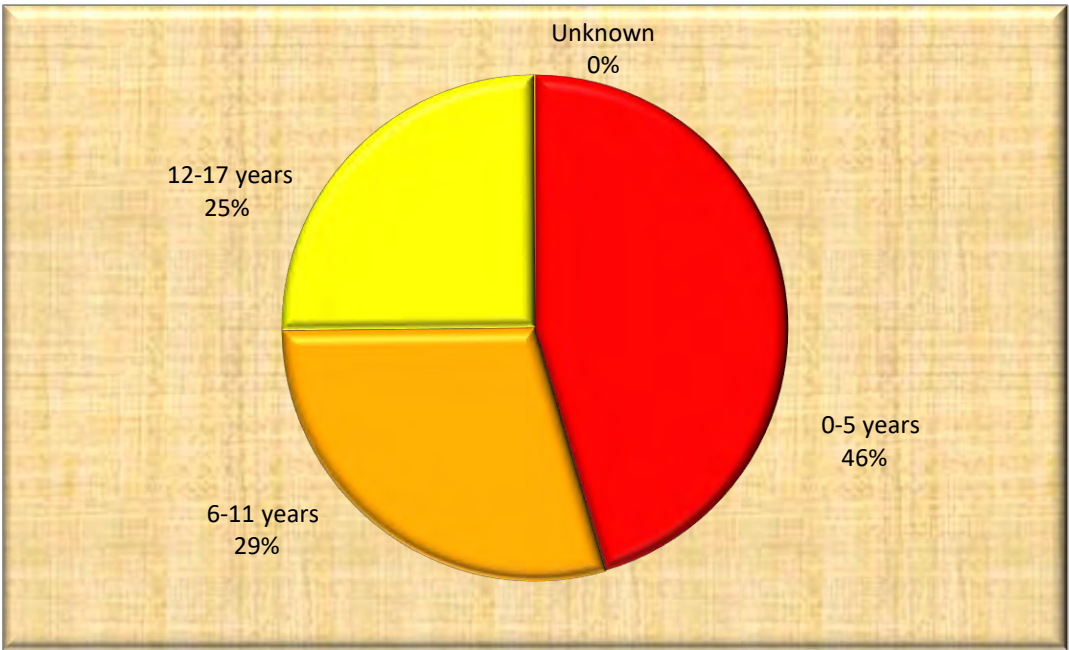
Figure 9: Report Sources of Total Reported Intakes with Disposition in SFYs 2017 – 2021 [Chart]

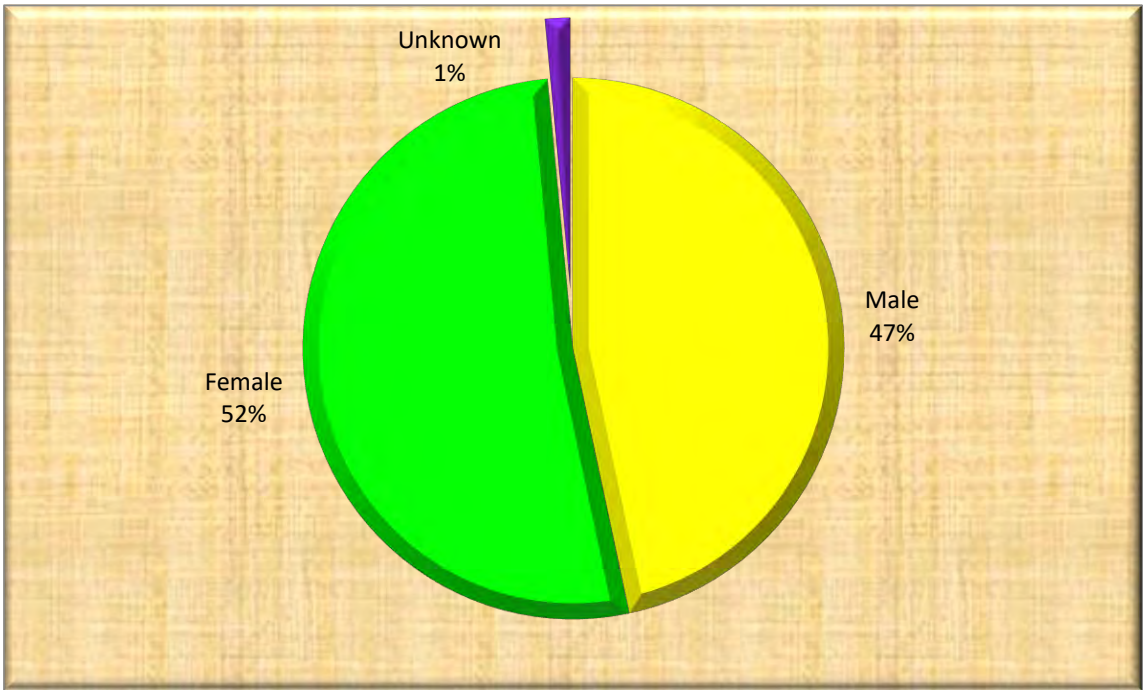

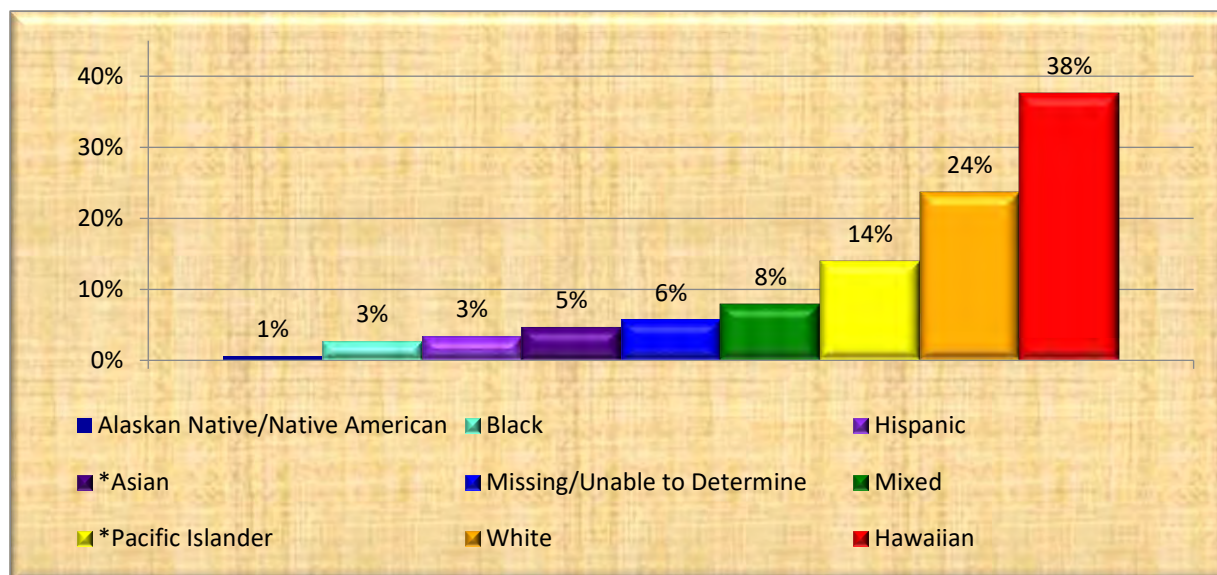


Figure 12: Ethnicity Distribution of Children with Confirmed Reports of Abuse or Neglect SFY2021

Figure 13: Ethnic Group Distribution of Children with Confirmed Reports of Abuse or Neglect SFY2021 [Chart]

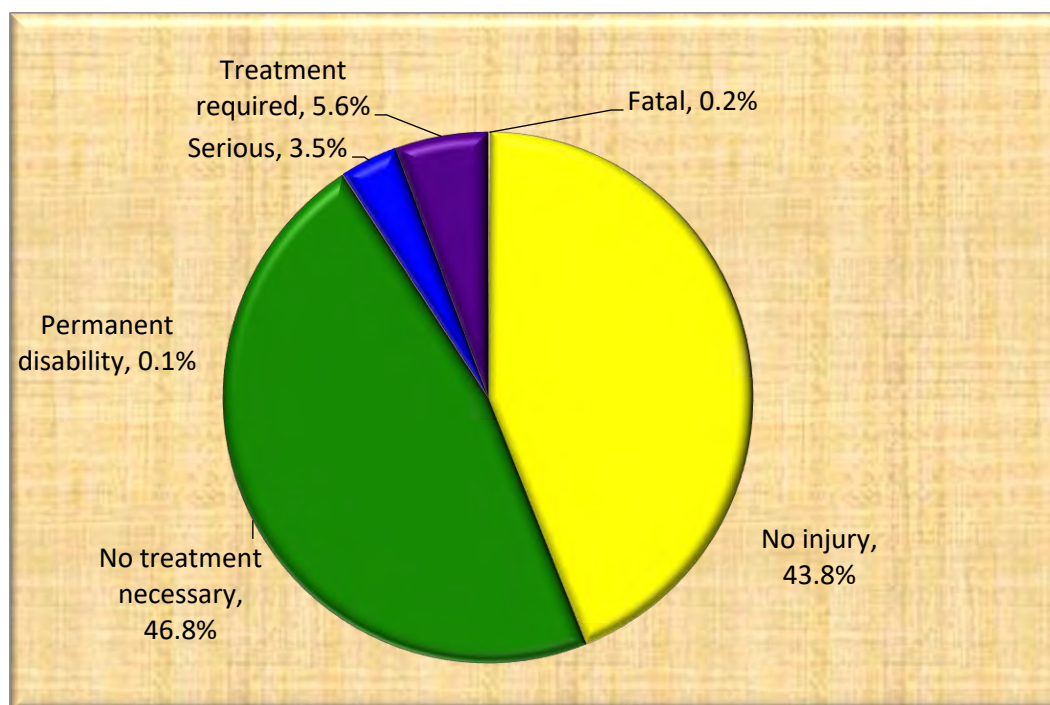

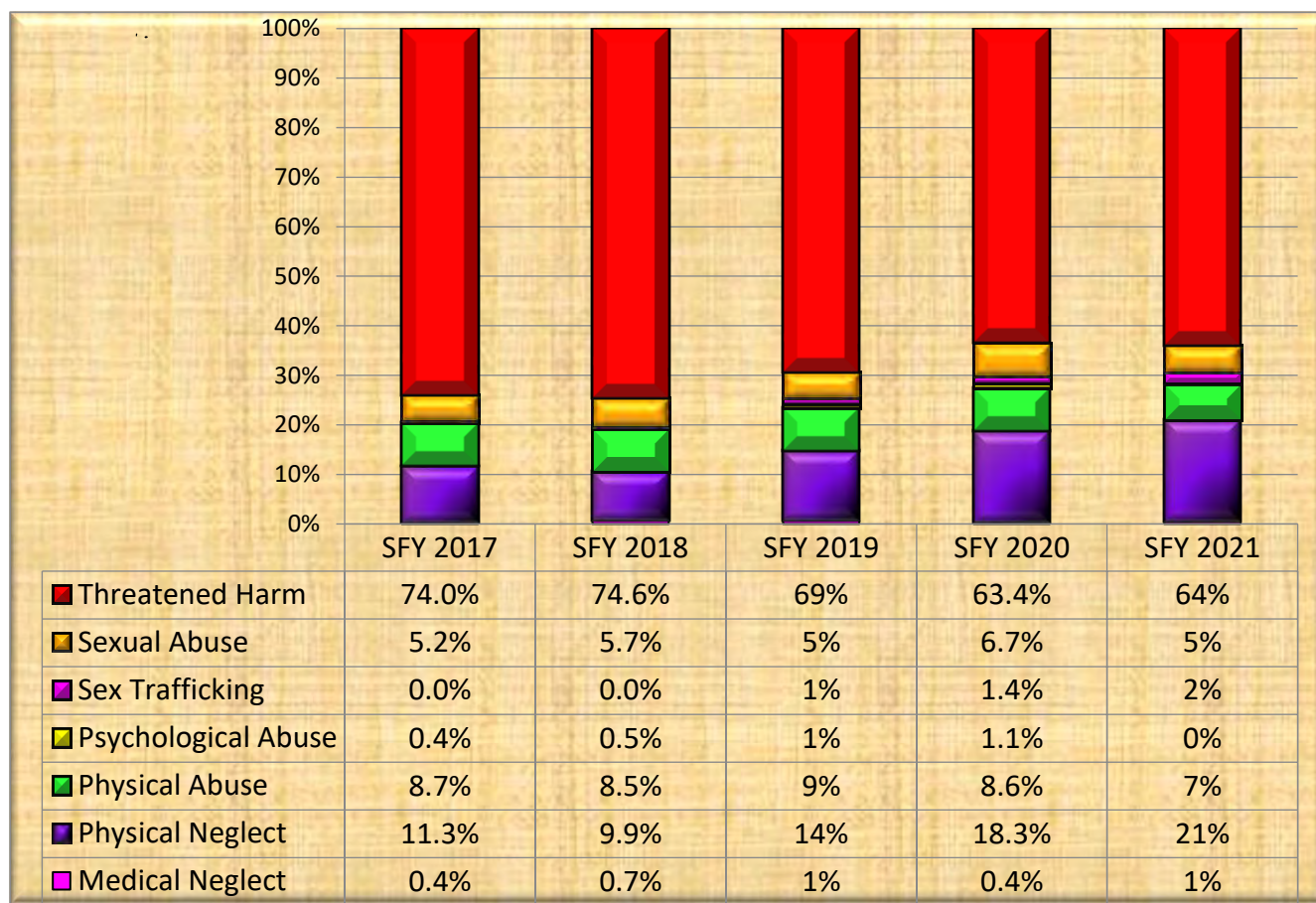
Figure 15: Statewide Confirmed Maltreatment by Type SFYs 2017-2021 [Table]

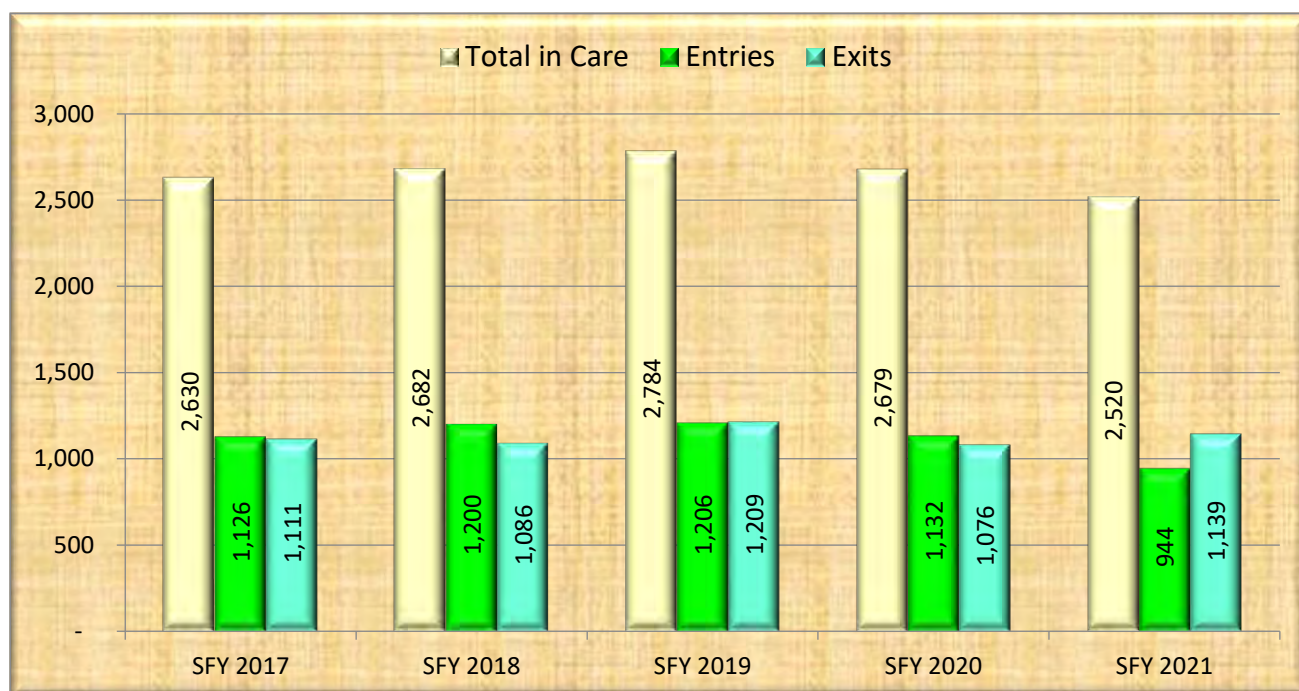

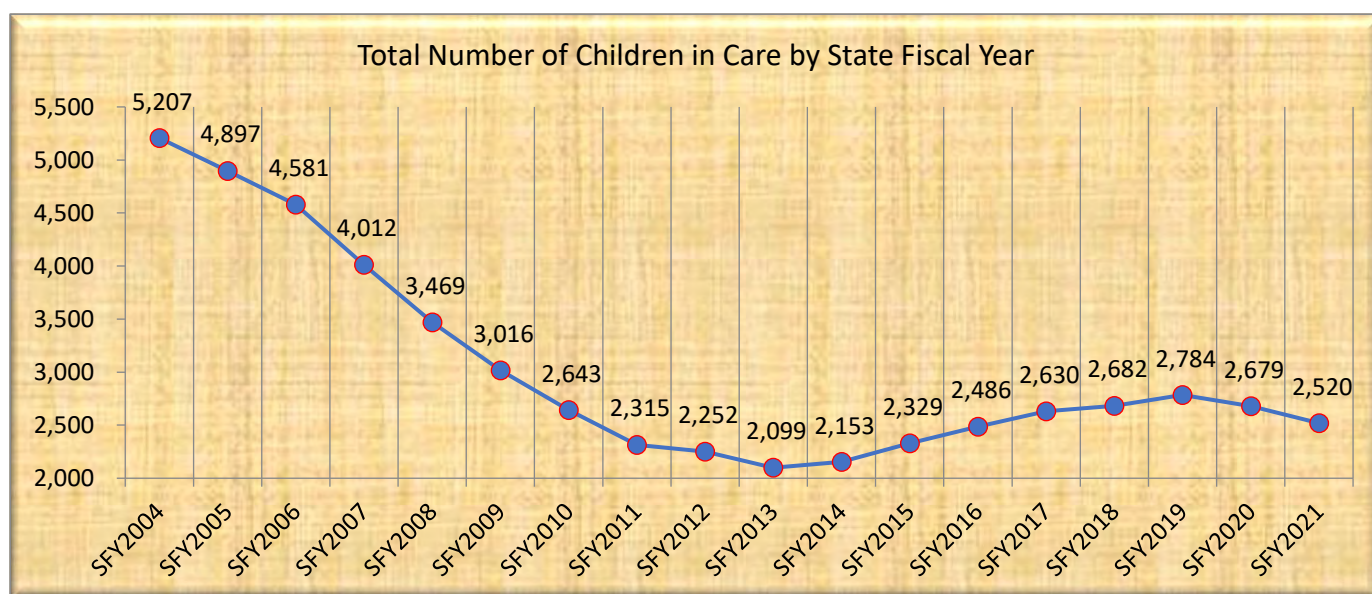

Figure 21: Statewide Children in Foster Care, Entries, and Exits – SFYs 2017-2021 [Chart]



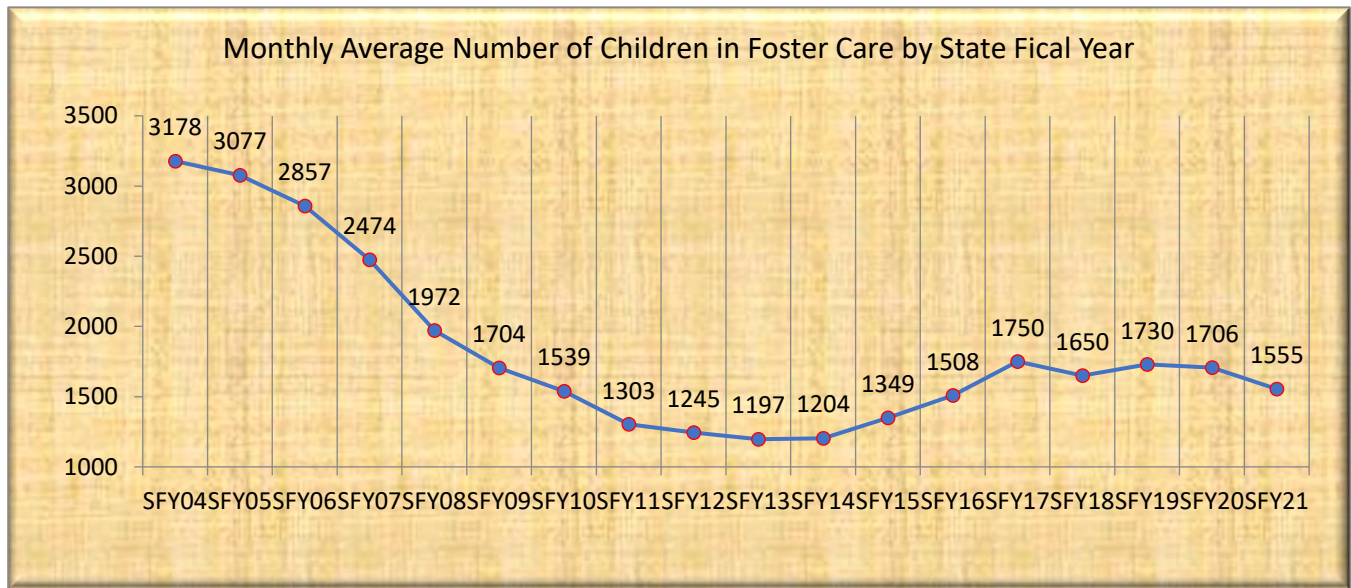

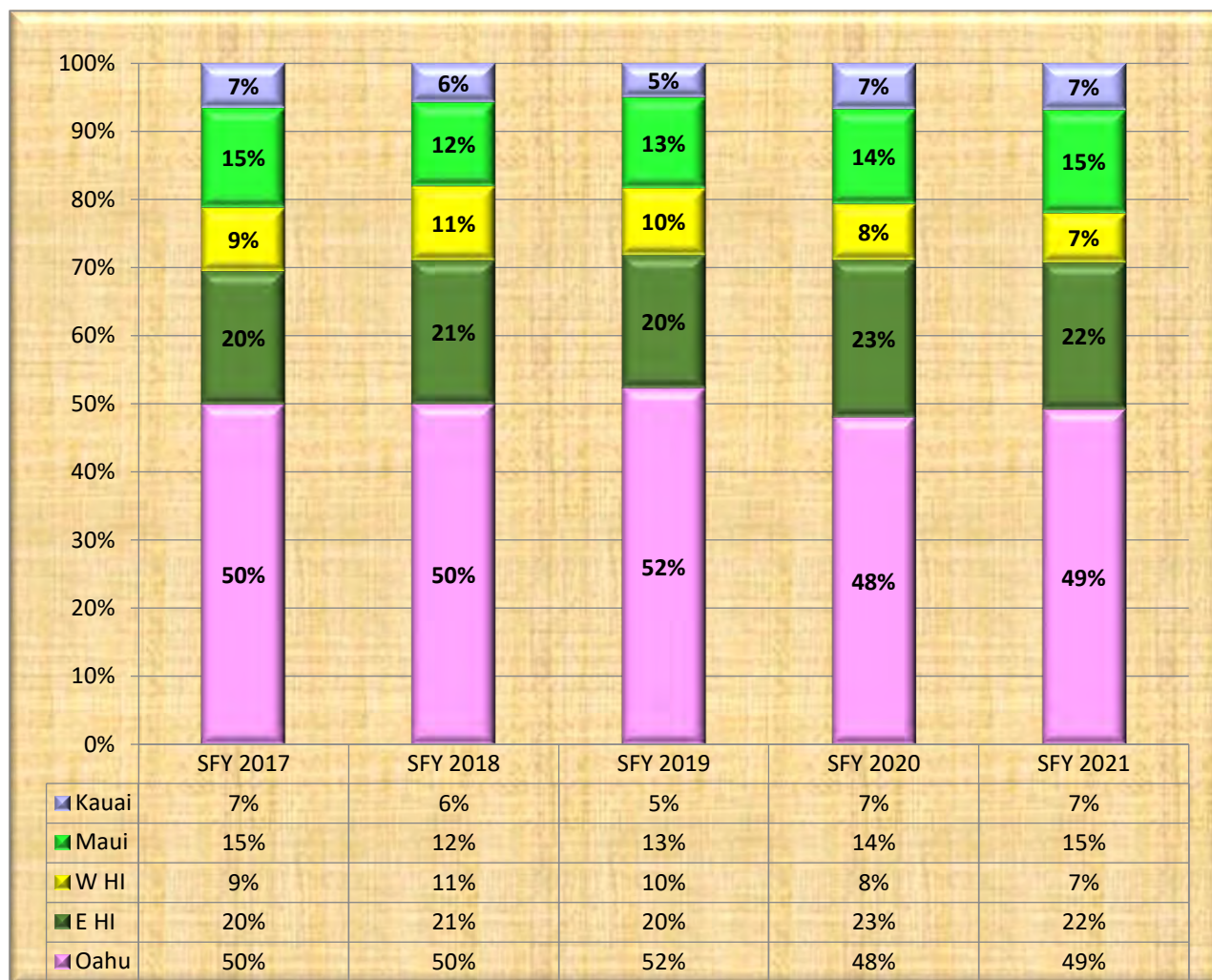

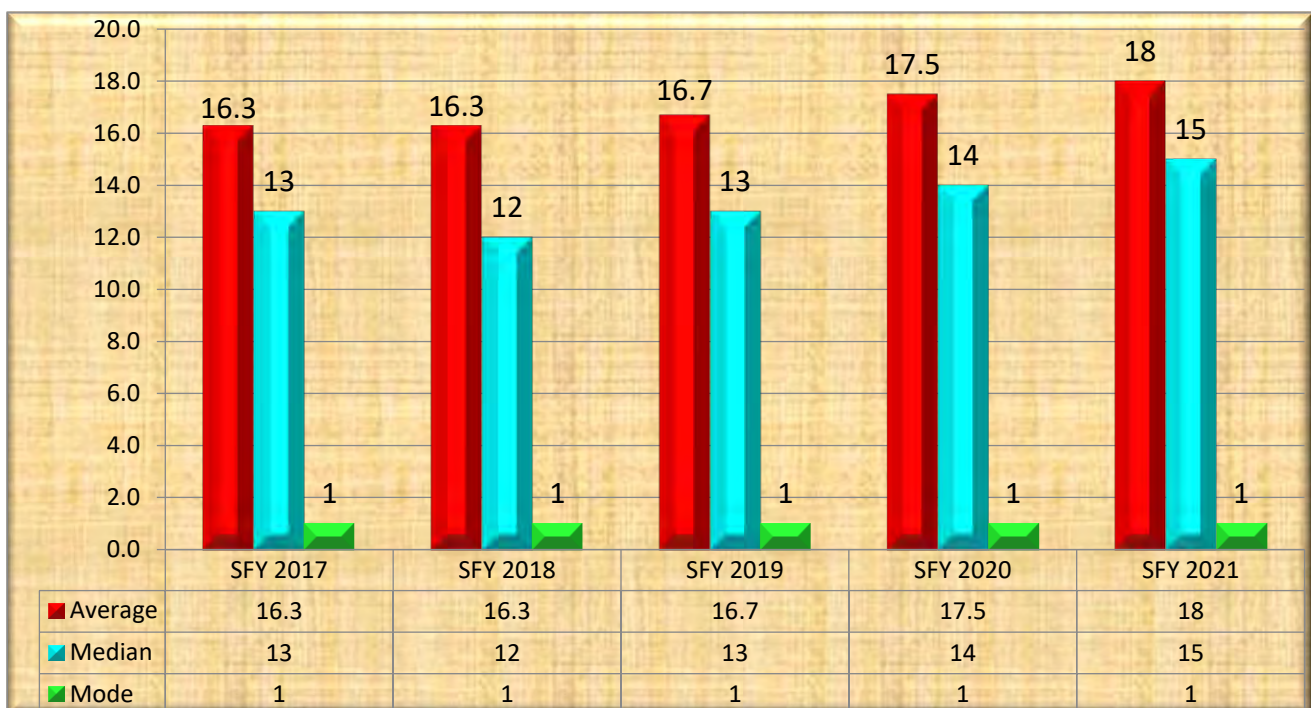

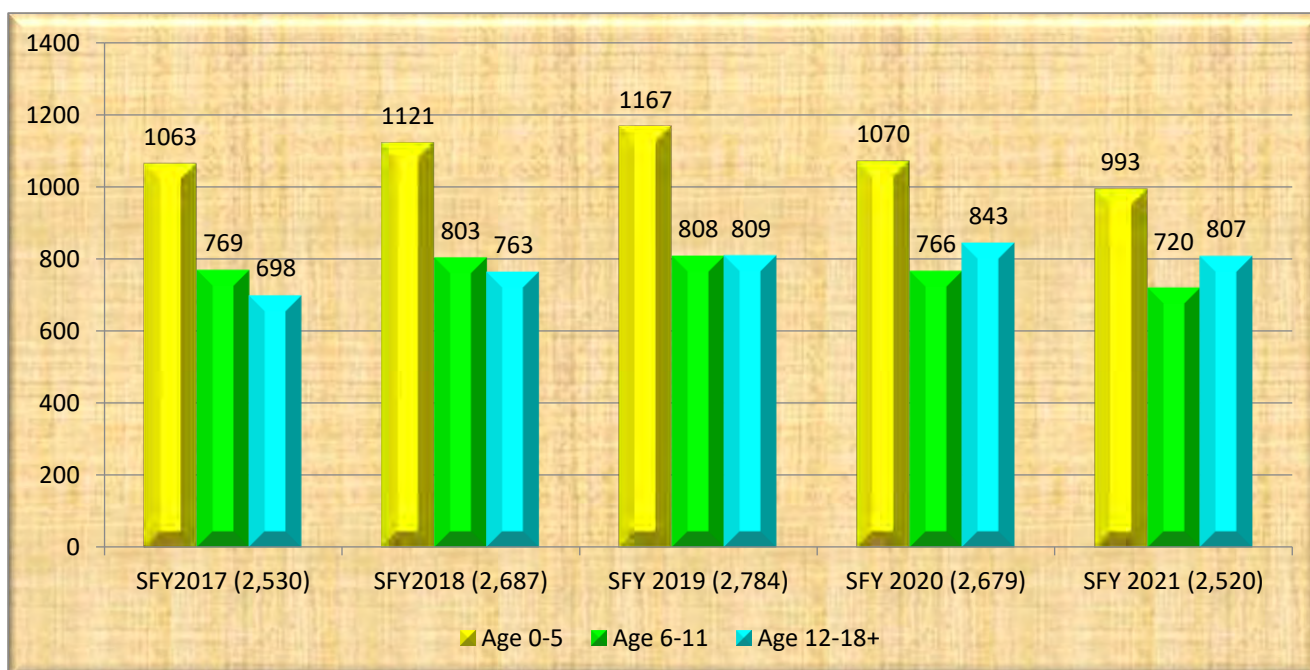

Figure 30: Number of Children in Care by Age Group: SFYs 2017-2021 [Chart]

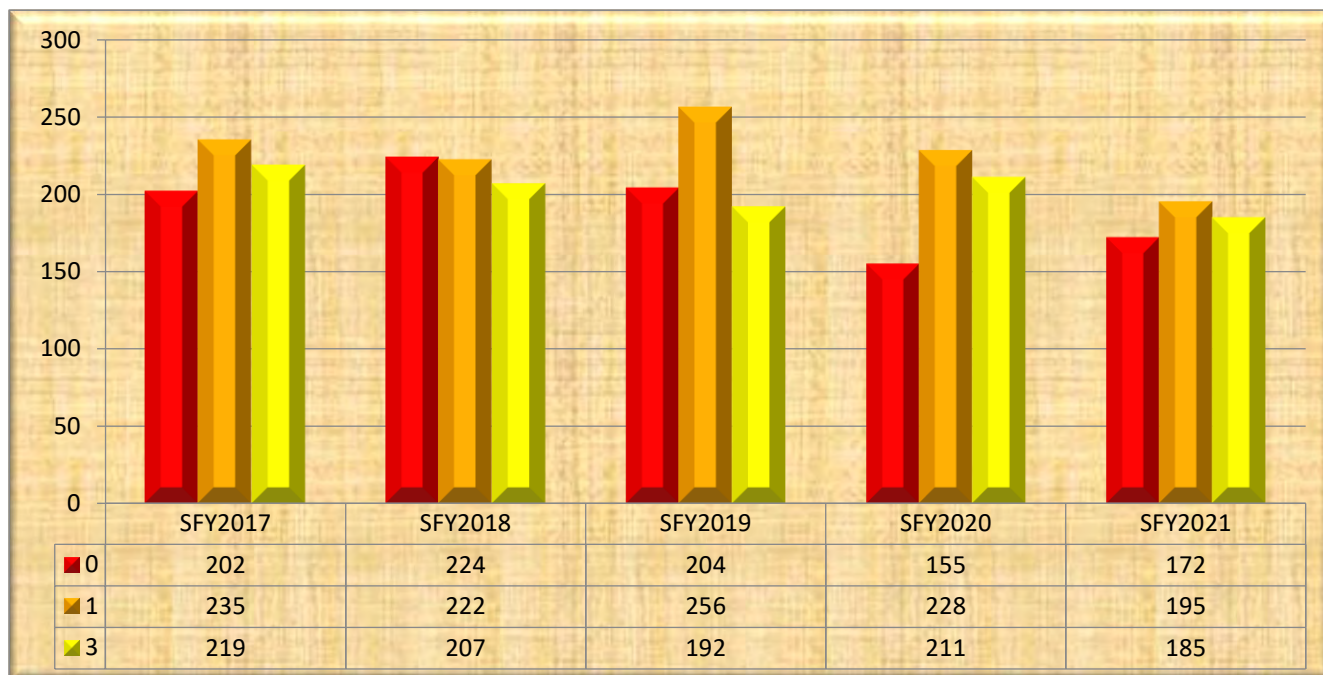

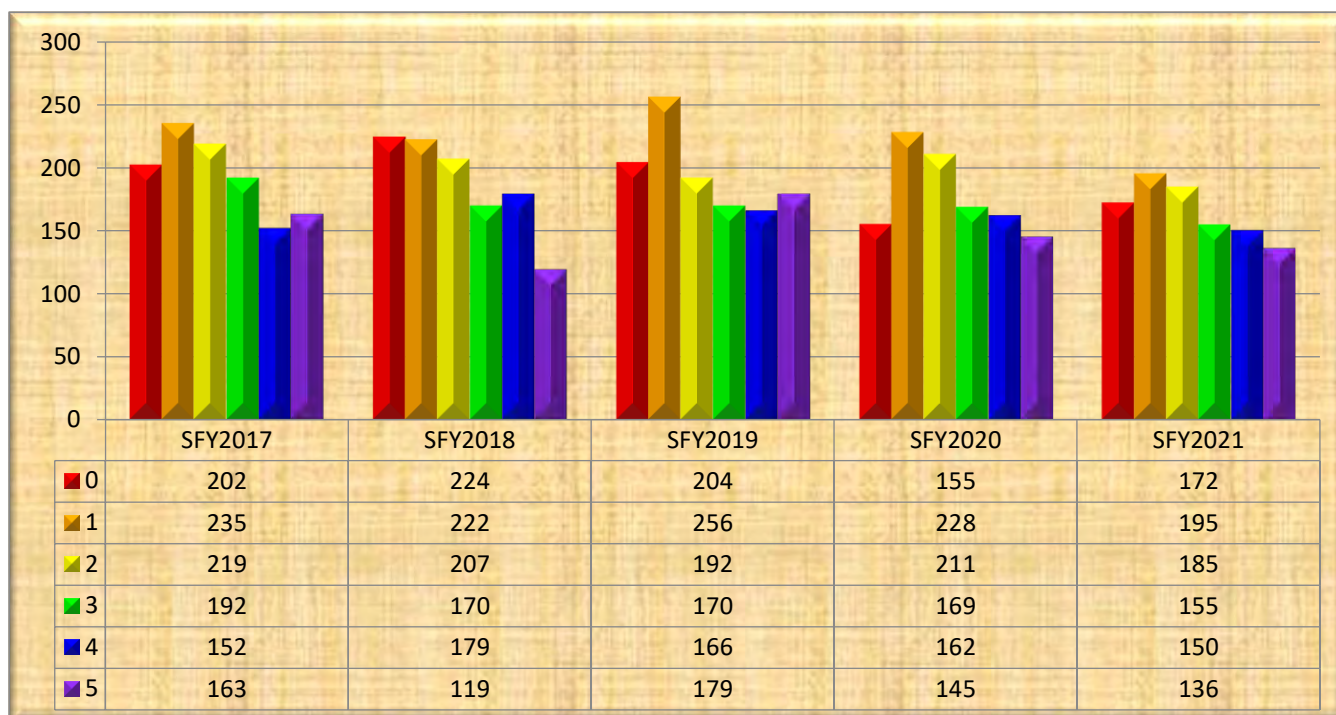

Figure 31: Age Distribution, Children Aged 0-2 in Foster Care SFYs 2017-2021 [Chart]



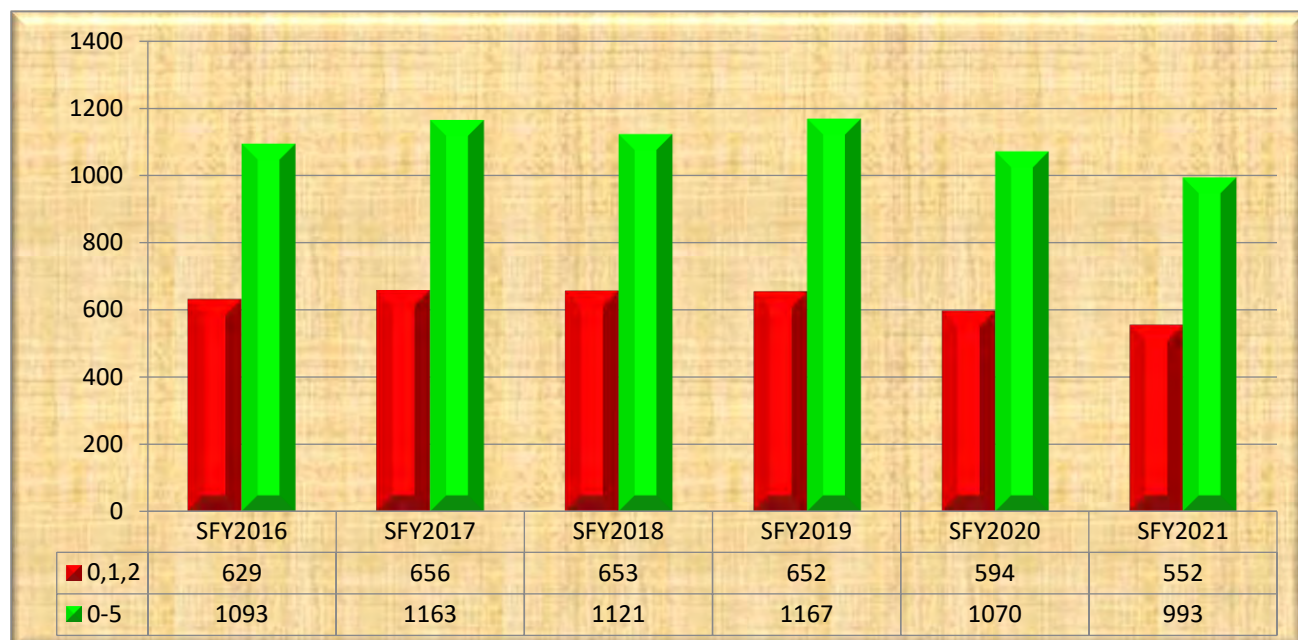

Figure 32: Age Distribution, Children Aged 0-5 in Foster Care SFYs 2017-2021 [Chart]



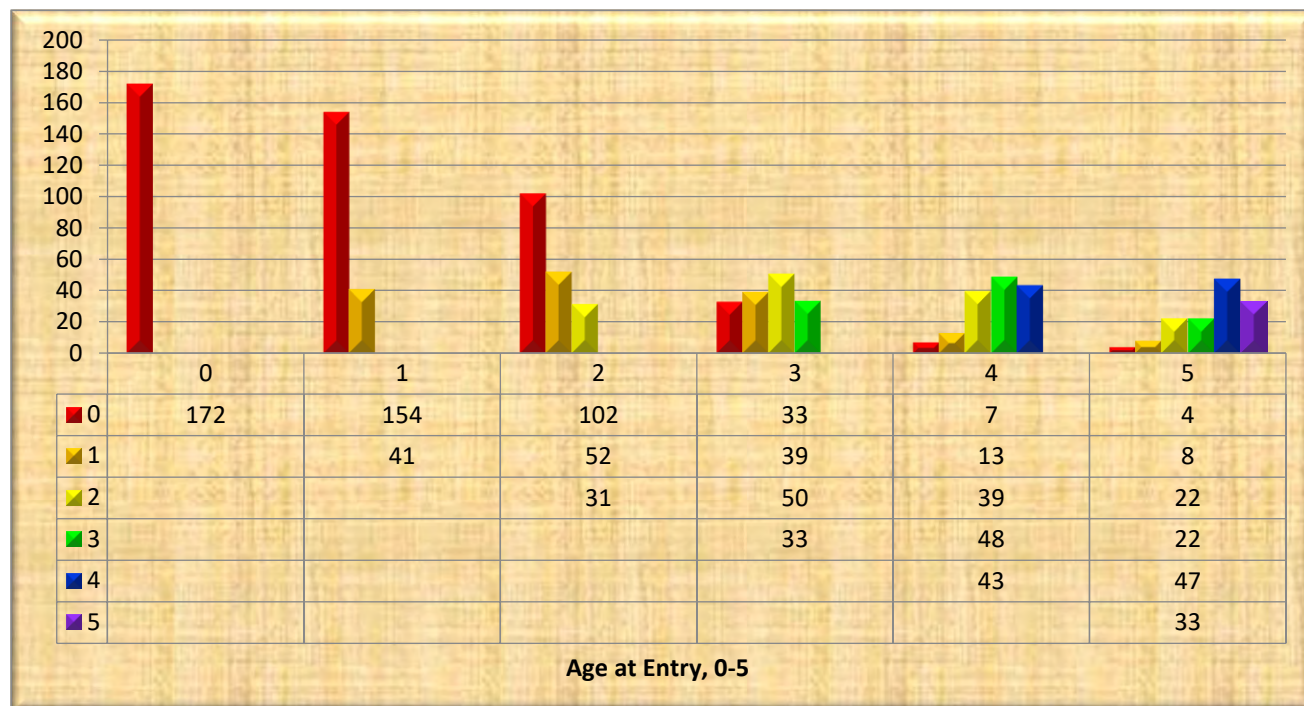

Figure 34: Age at Entry for Children in Foster Care Aged 0-5, SFY2021 [Chart]

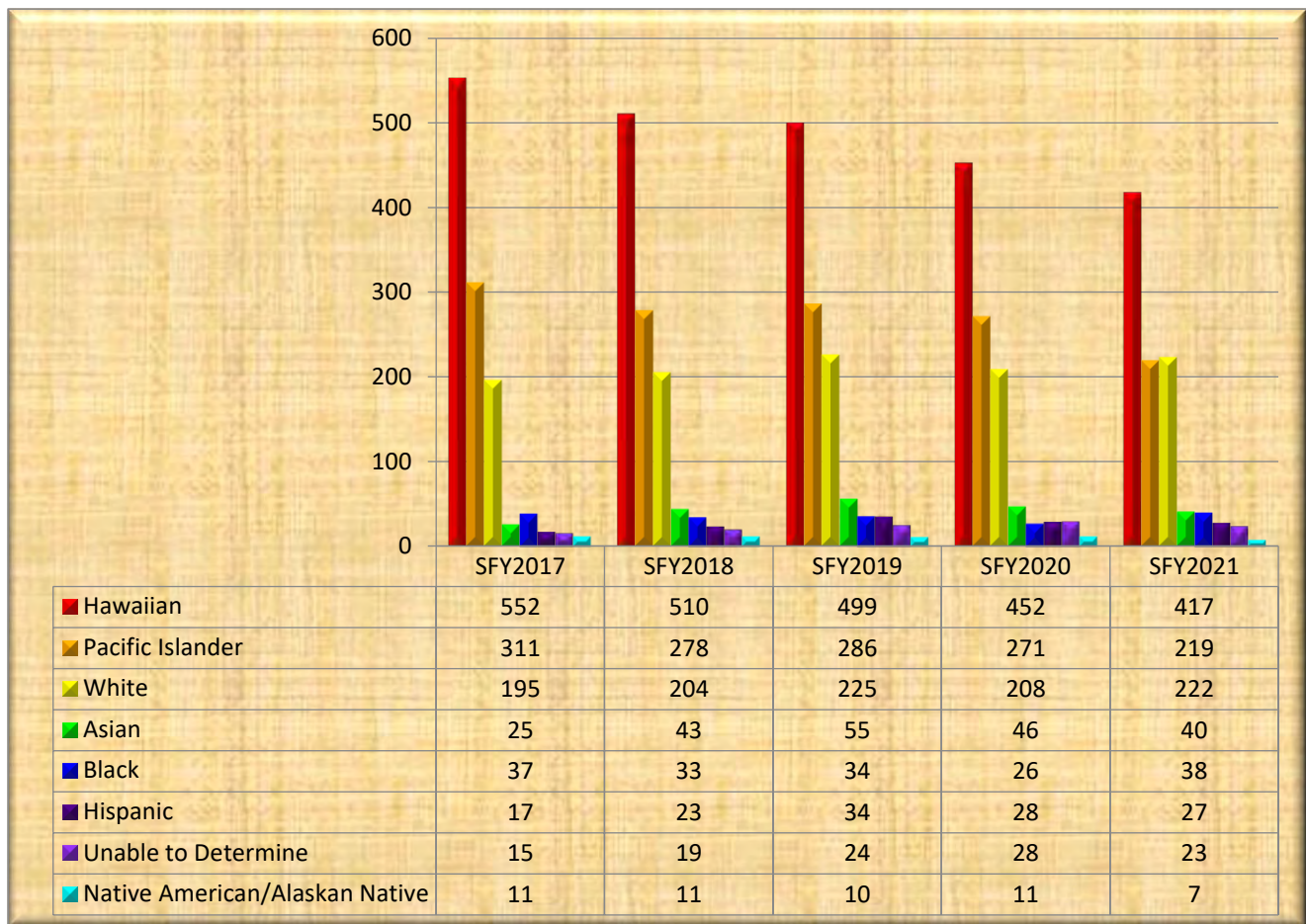

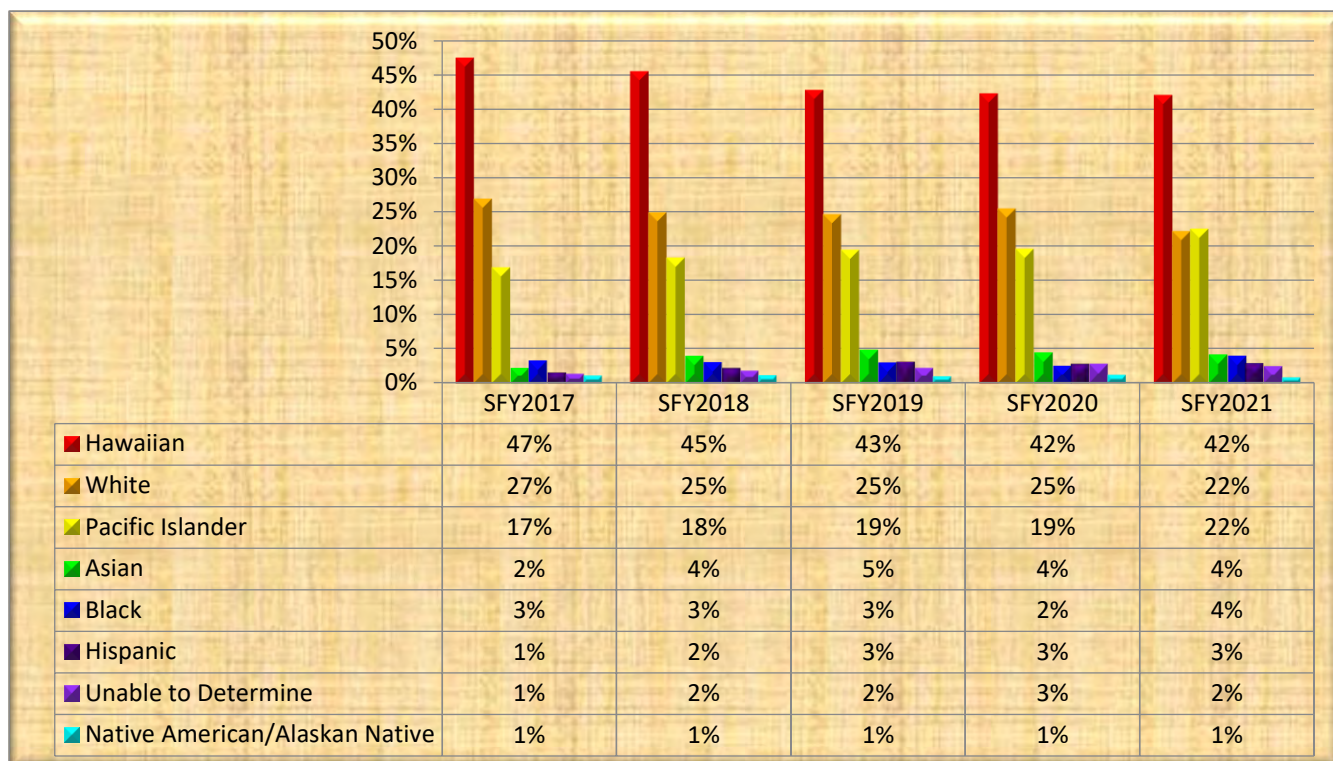
Figure 35: Grouped Ethnicity Distribution of Children in Foster Care Aged 0-5, SFYs 2017-2021

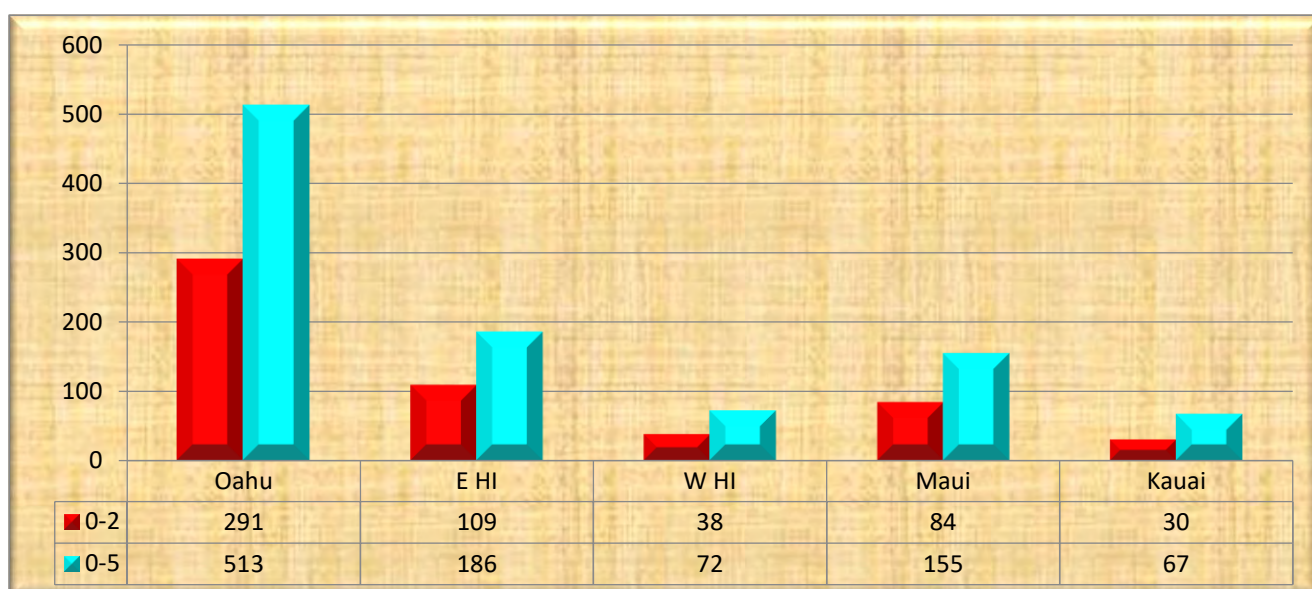

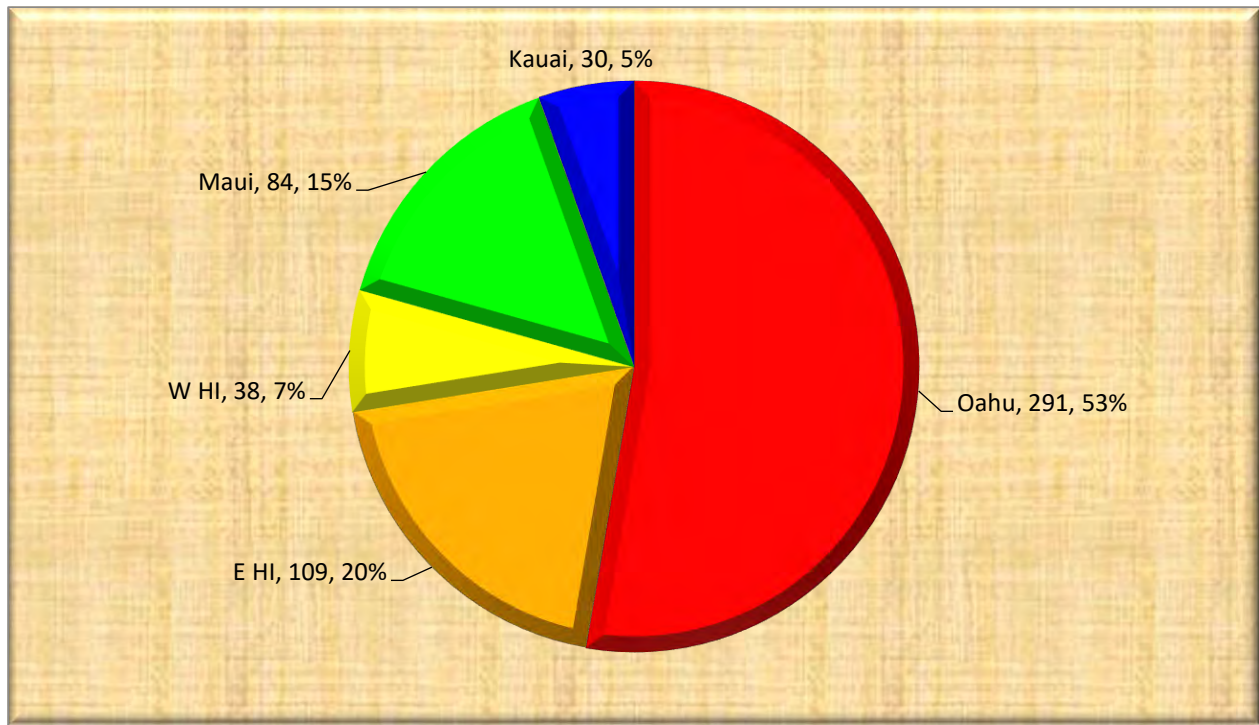
Figure 37: Geographic Distribution of Children Aged 0-2 and 0-5 in Foster Care in SFY 2021 [Chart]

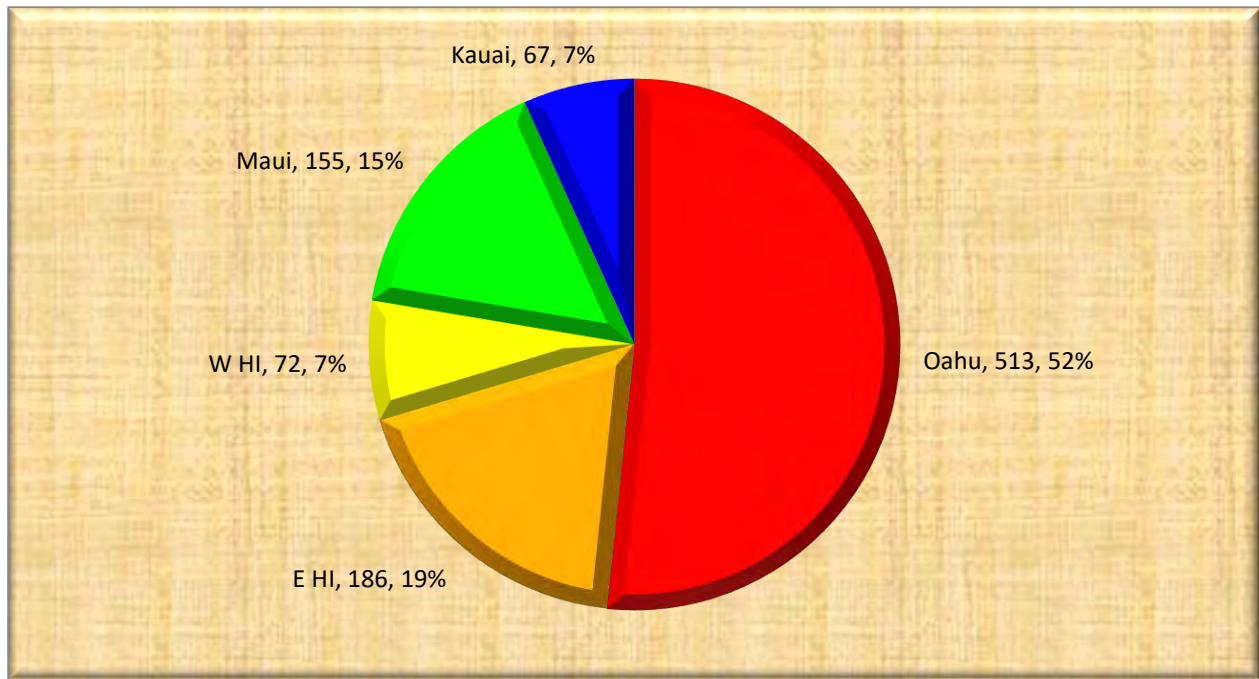


Figure 38: Geographic Distribution of Children Aged 0-2 in Foster Care, Composite SFY 2021 [Chart]

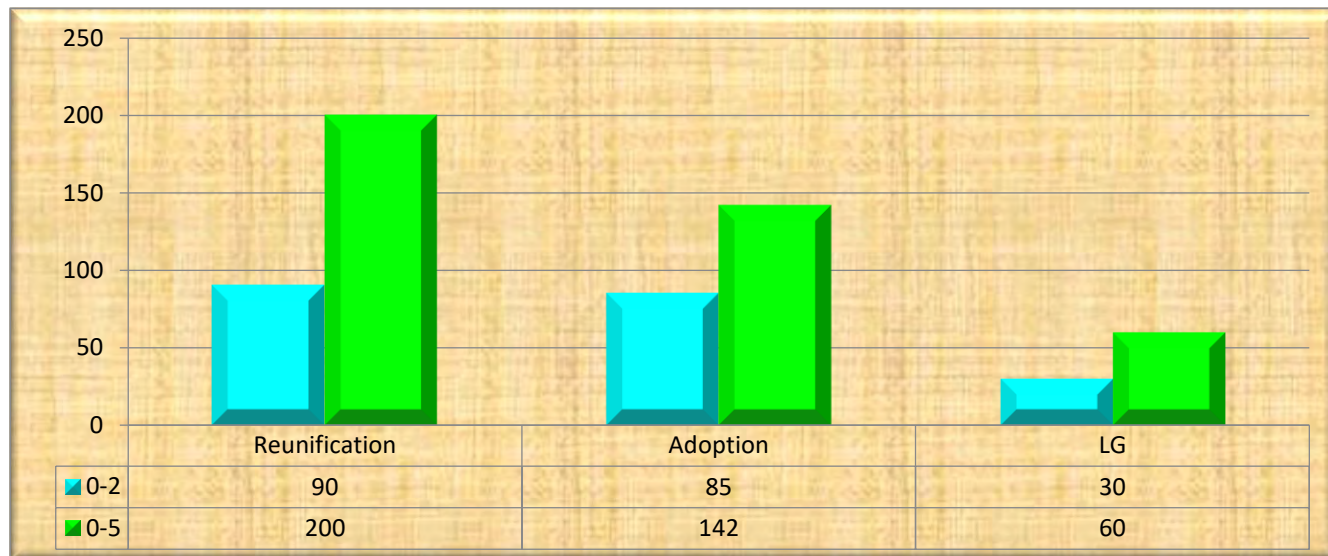
Figure 39: Geographic Distribution, Children Aged 0-5 in Foster Care Composite SFY 2021 [Chart]

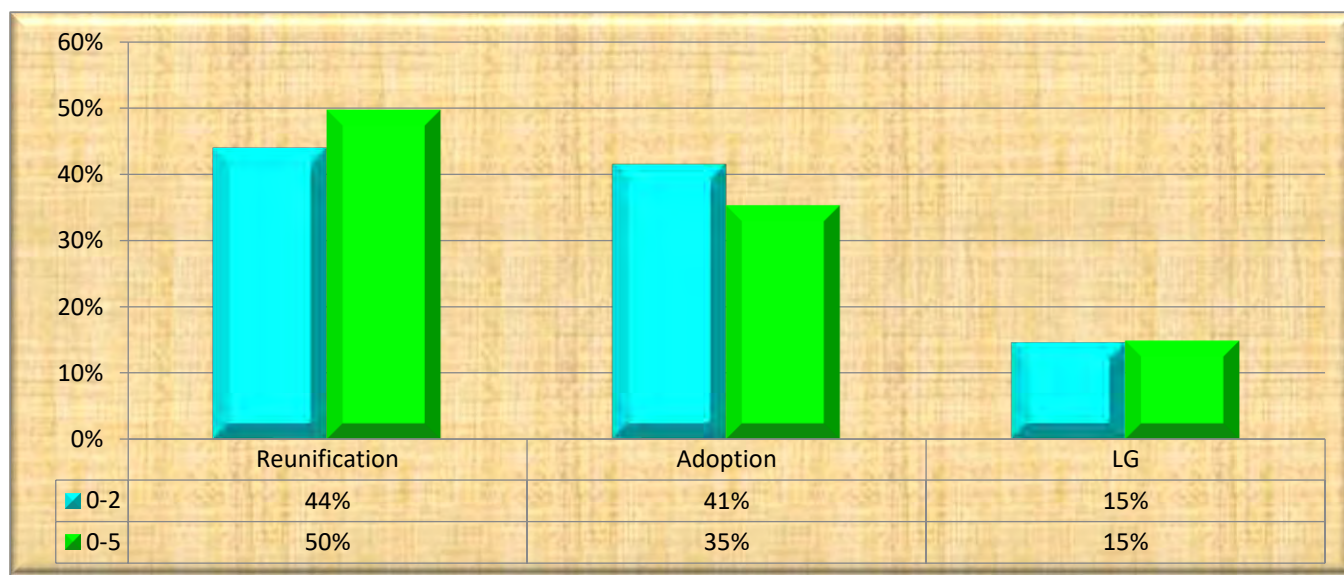

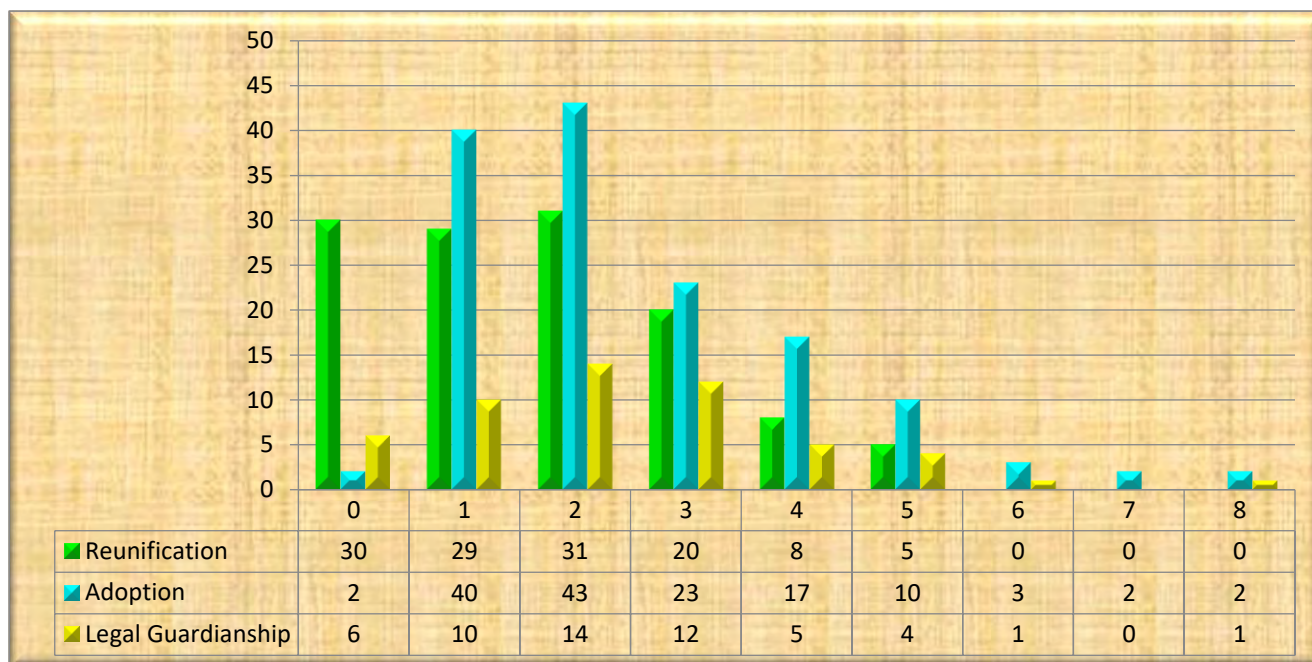
Figure 41: Type of Discharge from Foster Care during SFY 2021, for Children Aged 0-2 and 0-5 by Percentage of Exits [Chart]

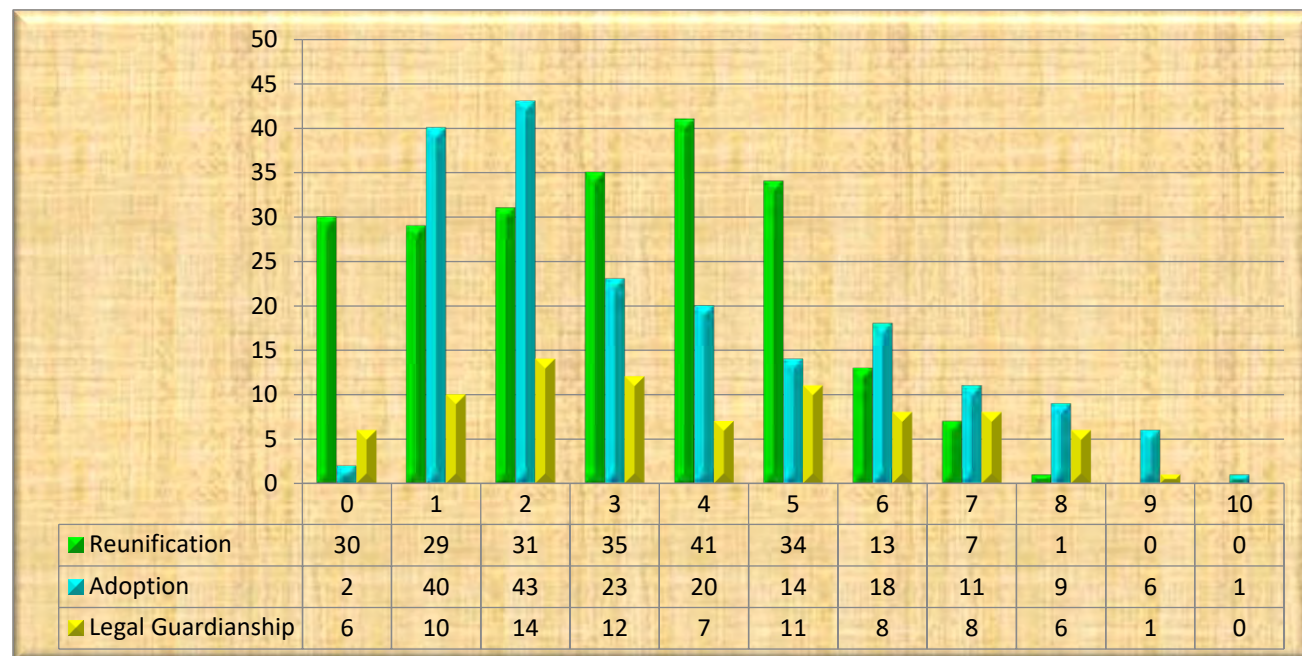


Figure 42: Type of Discharge and Age at Exit During SFY 2021, For Children Aged 0-2 At Time Of Entry [Chart]

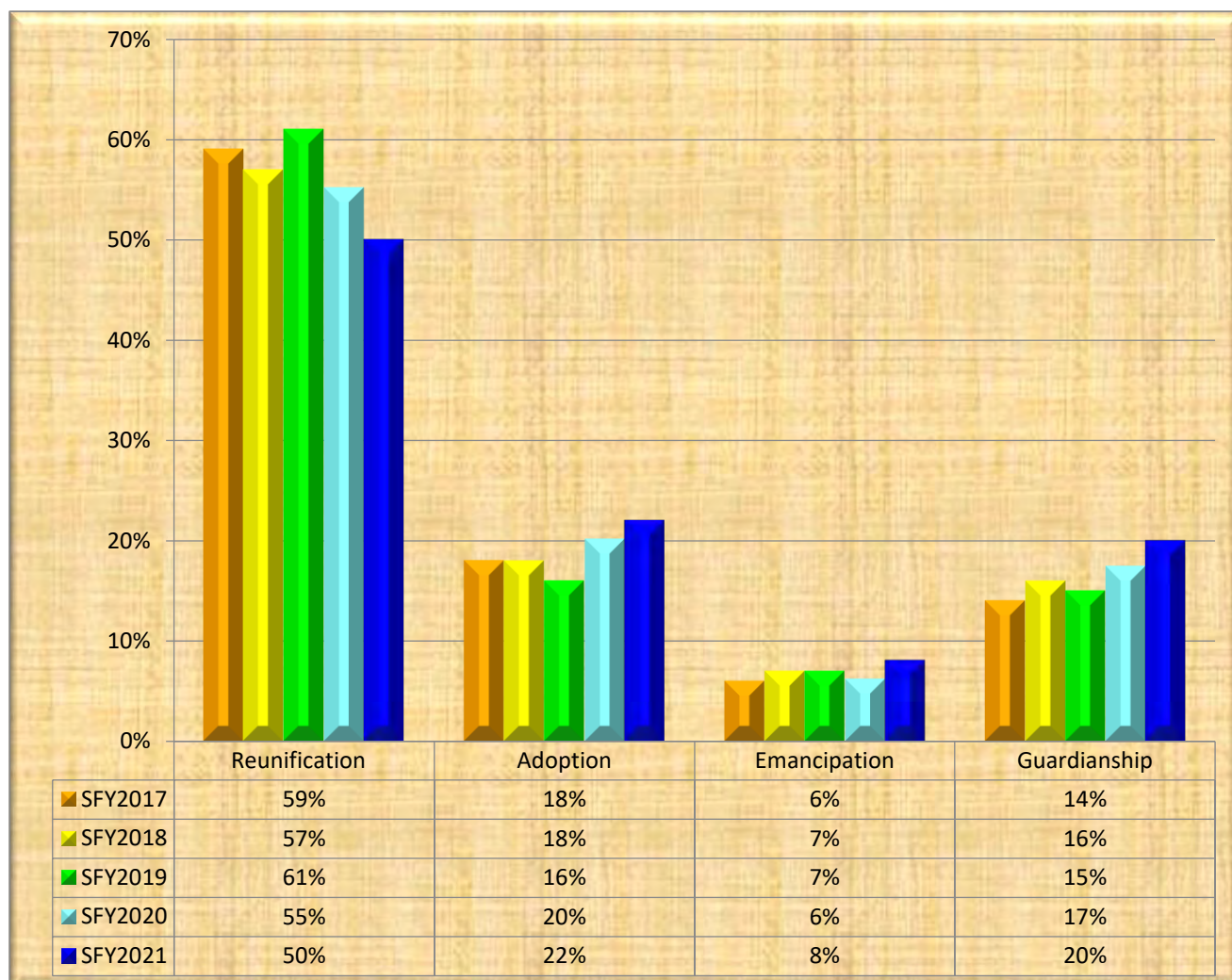
Figure 44: Termination Type by Age Group for SFYs 2017-2021 [Table]

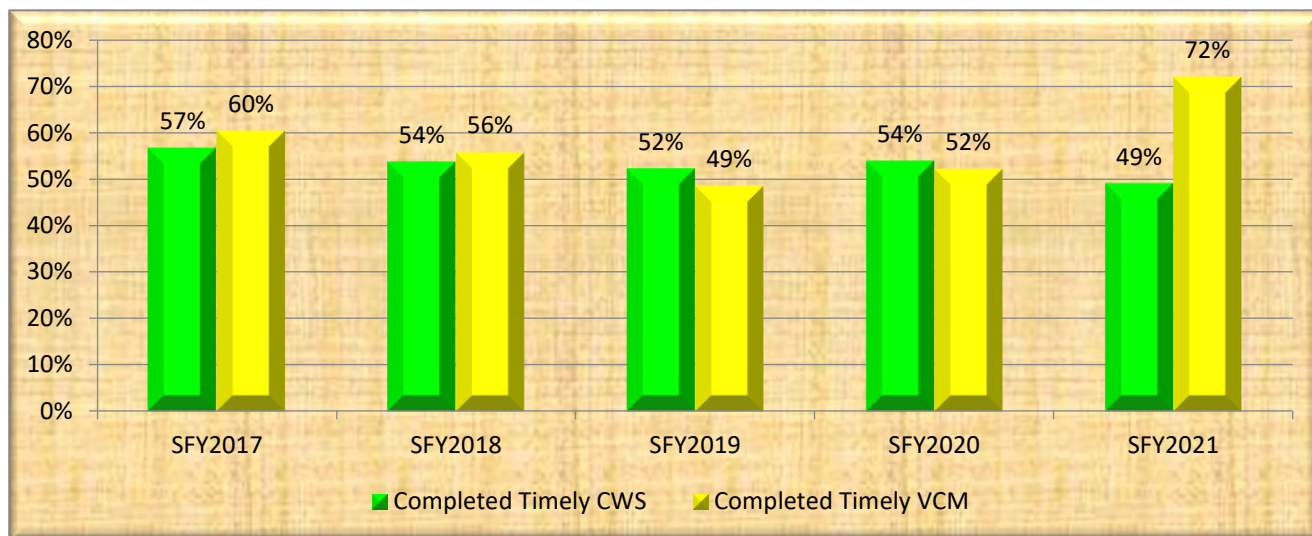

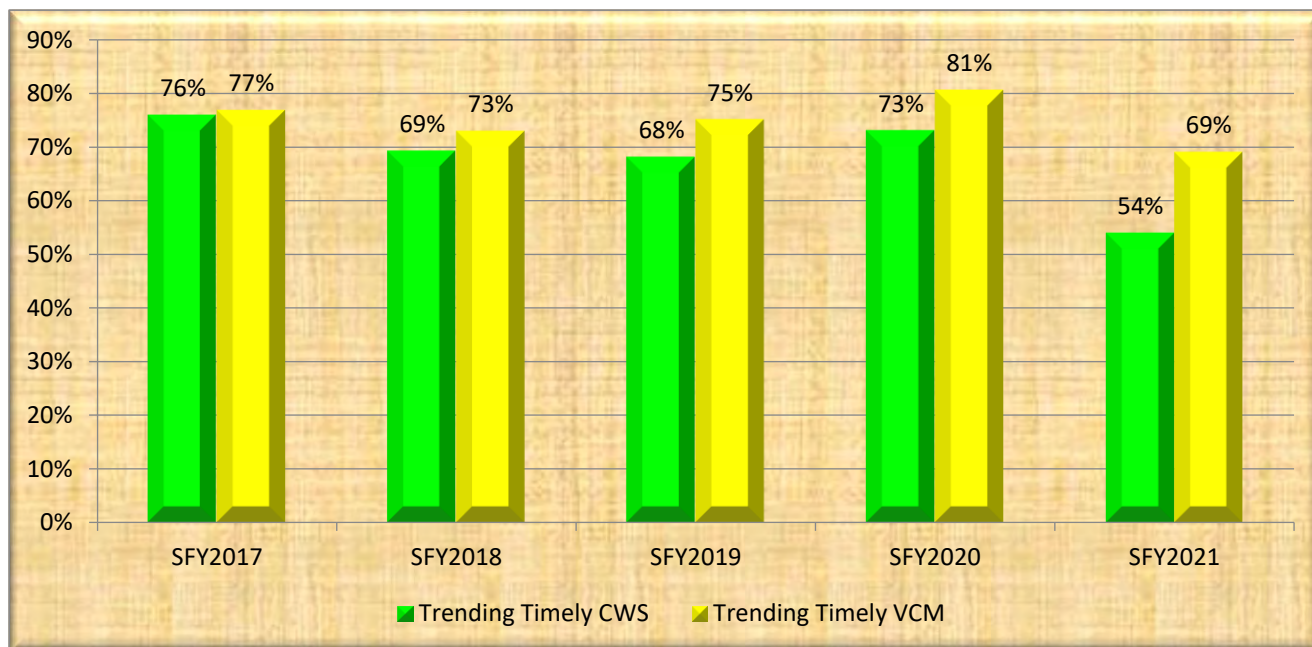

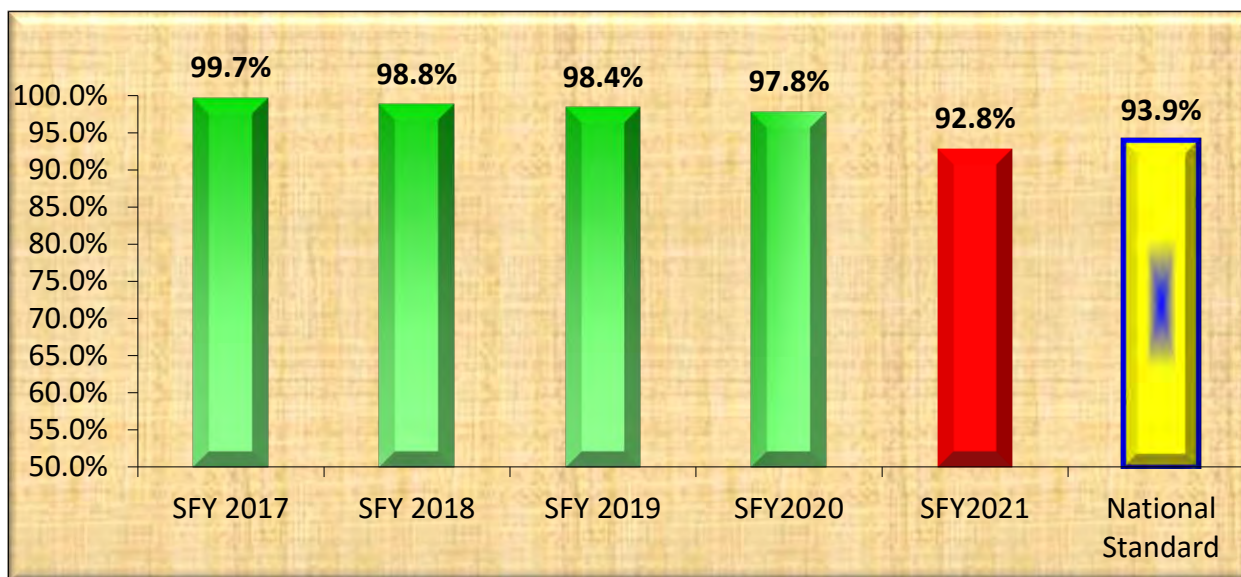
Figure 48: Trending Timely Responses [% of completed]– CWSB and VCM: SFYs 2017-2021 [Chart]

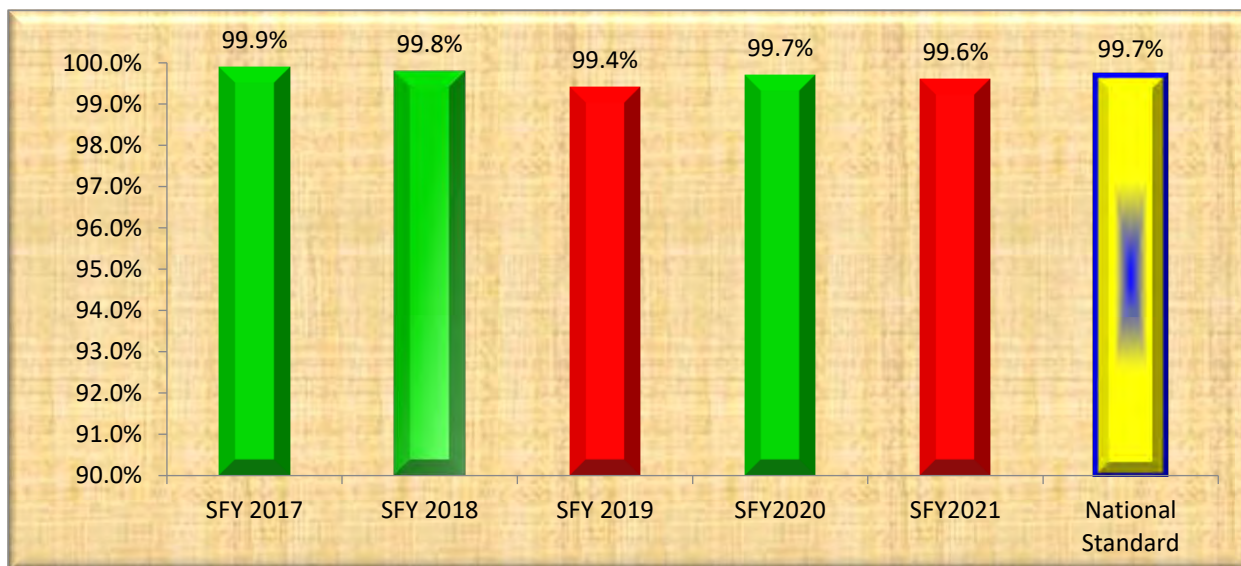
Figure 49: Absence of Recurrence of Child Abuse and Neglect SFYs 2017-2021 [Chart]

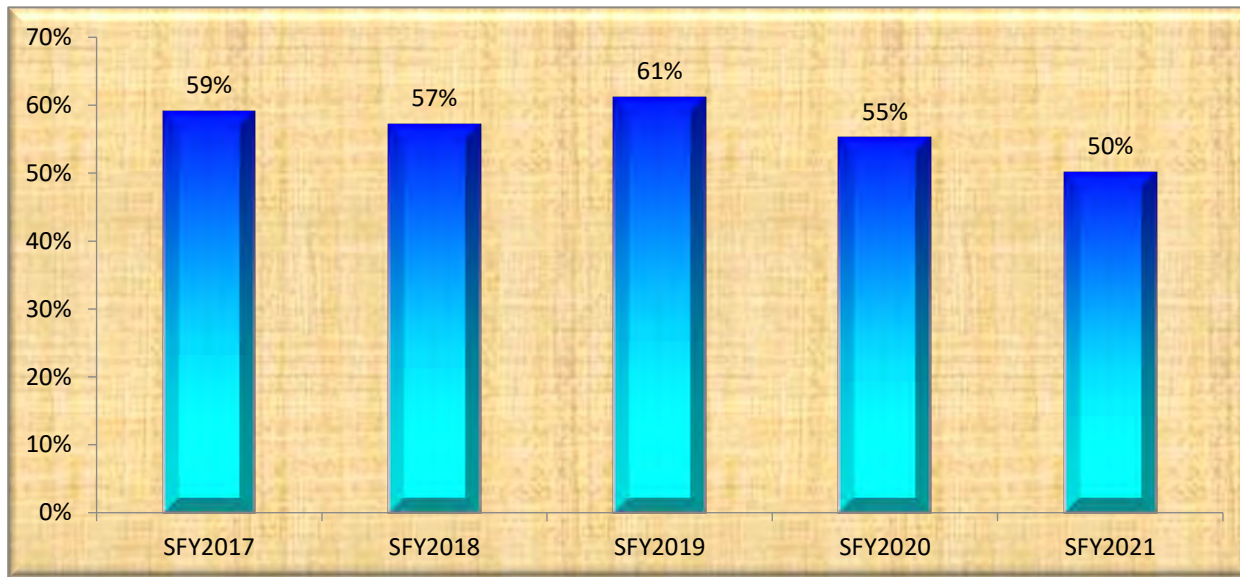

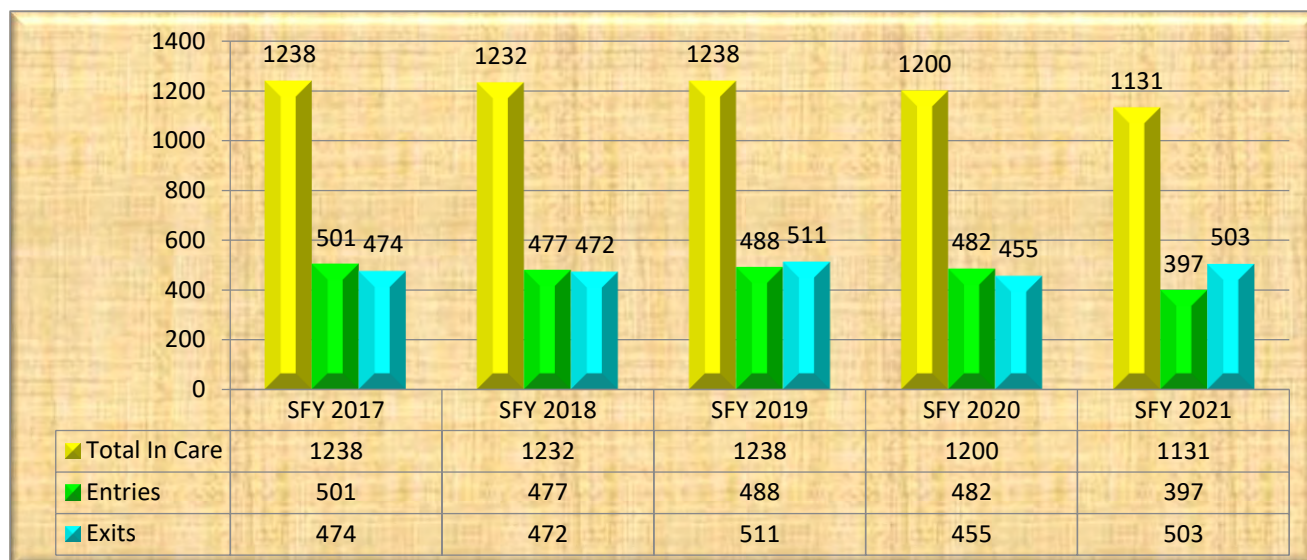
Figure 52: Hawaiian Children in Foster Care SFYs 2017-2021-[Table]

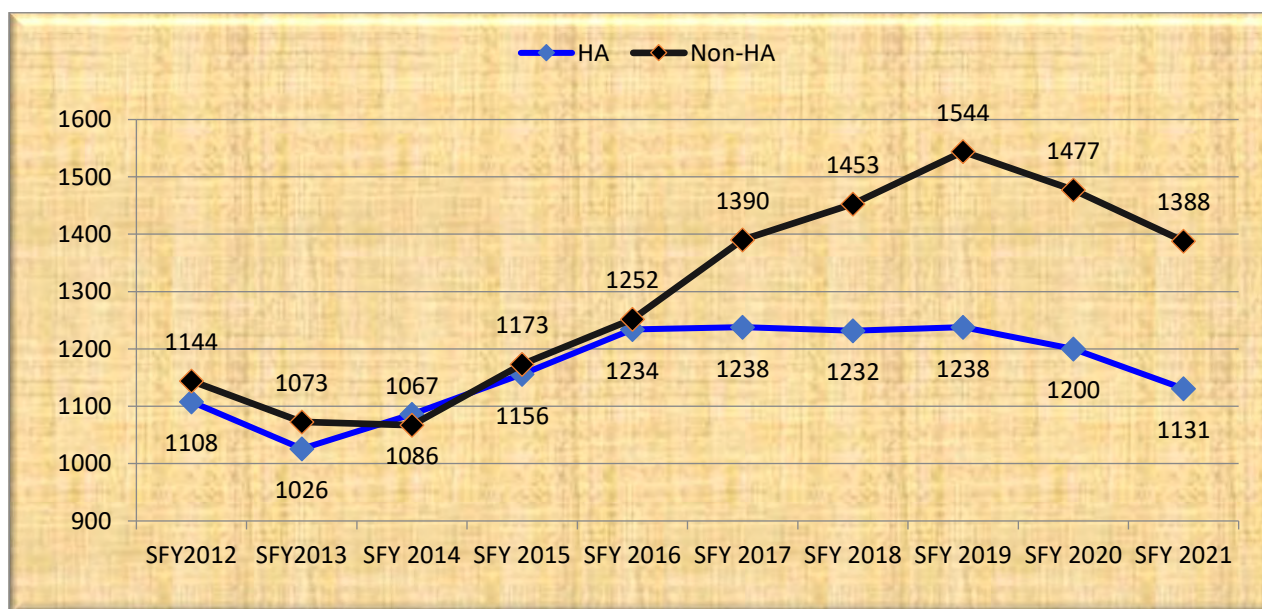
Figure 53: Hawaiian Children in Foster Care, Entries and Exits SFYs2017-2021[Chart]

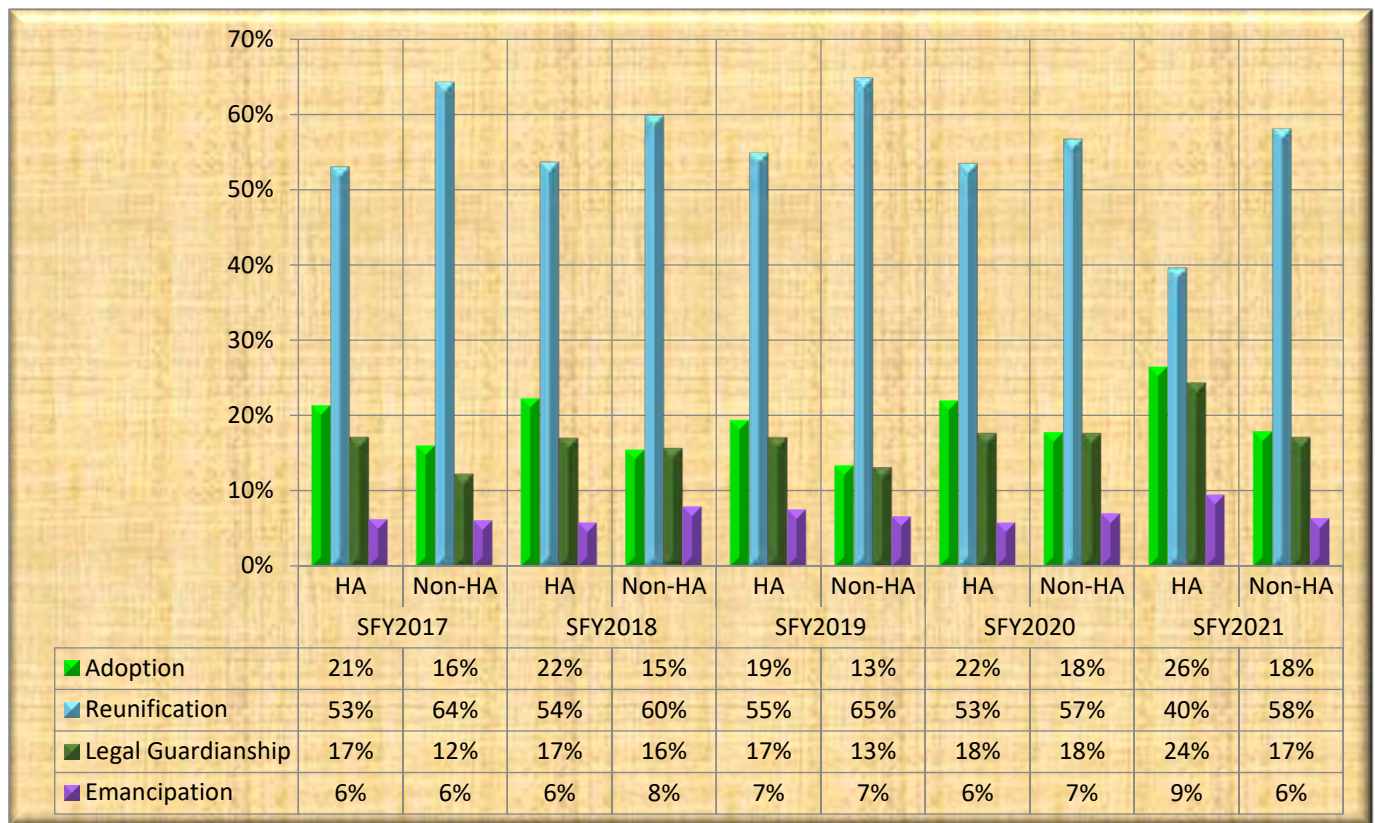
Figure 54: Hawaiian and Non-Hawaiian Children in Foster Care SFYs2012-2021 [Chart]

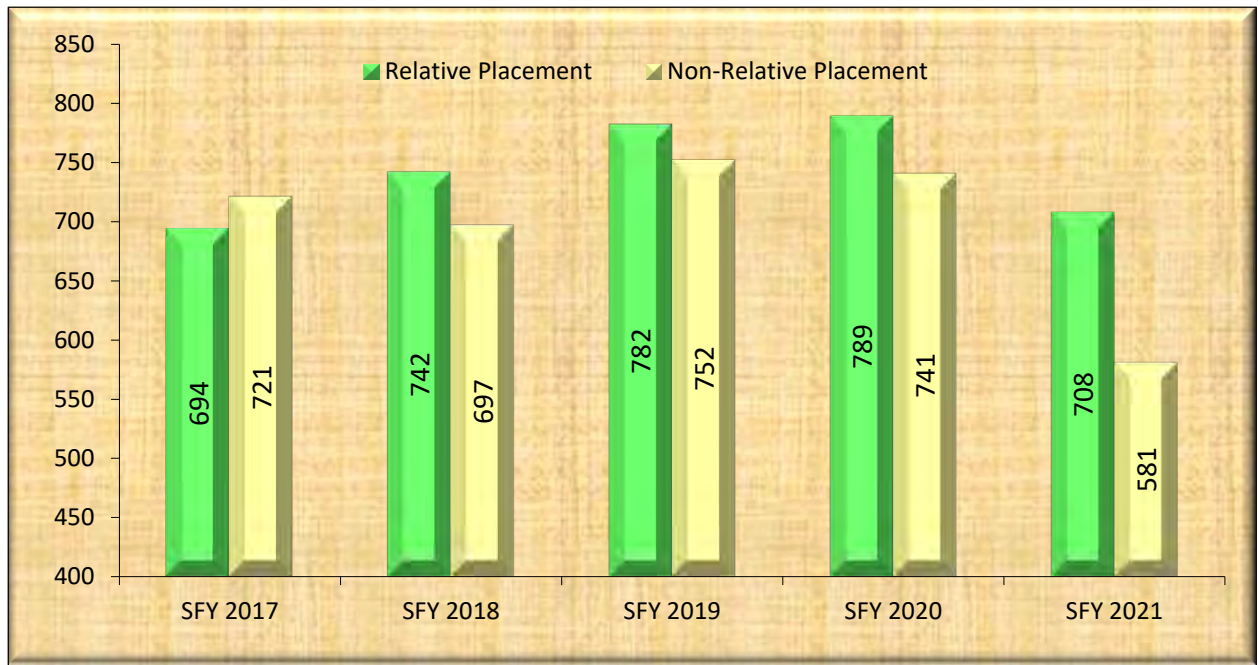
Figure 55: Discharge Type by Hawaiian and Non-Hawaiian Children, SFYs 2017-2021 [Chart]

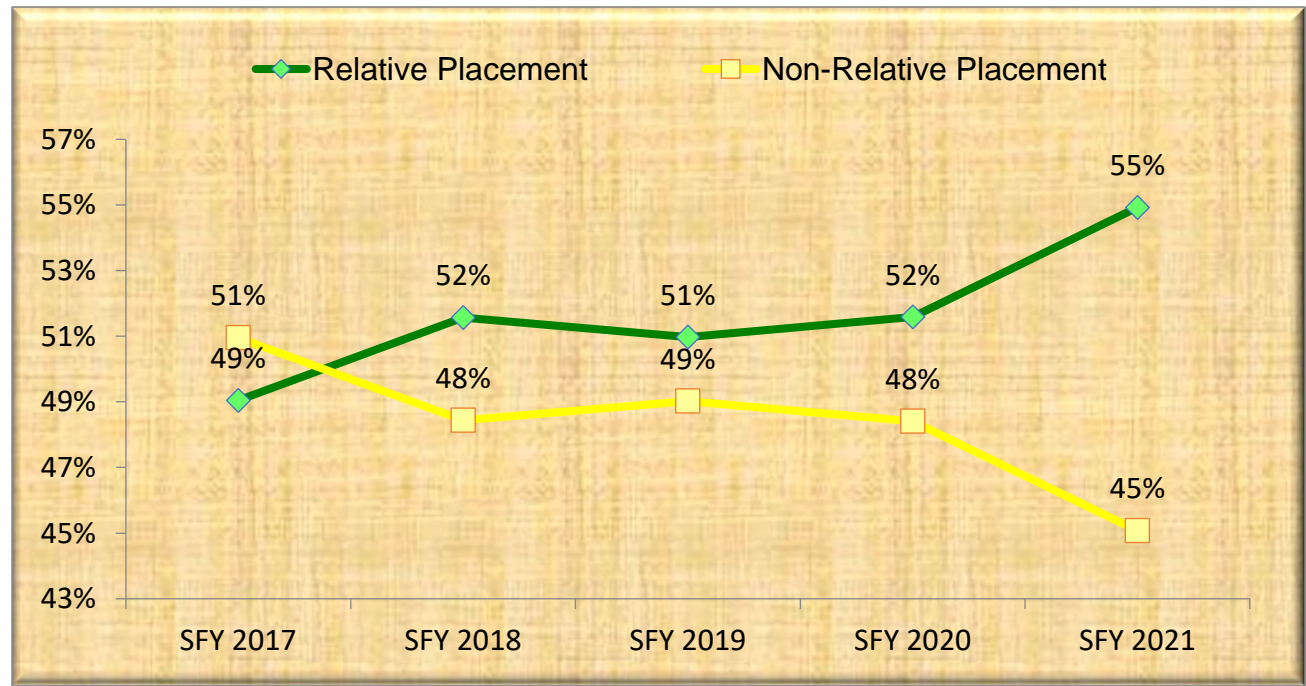

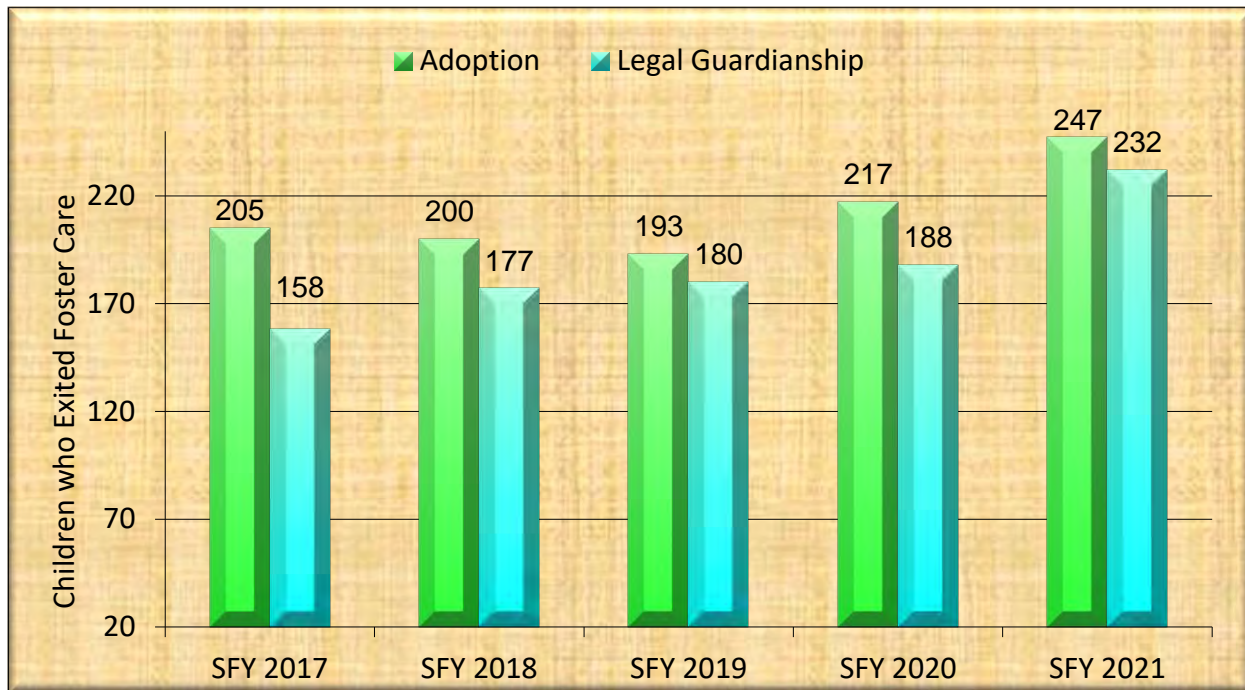
Figure 57: Monthly Averages Percentage of Children in Relative and Non-Relative Foster Care Placements SFYs 2017-2021 [Chart]

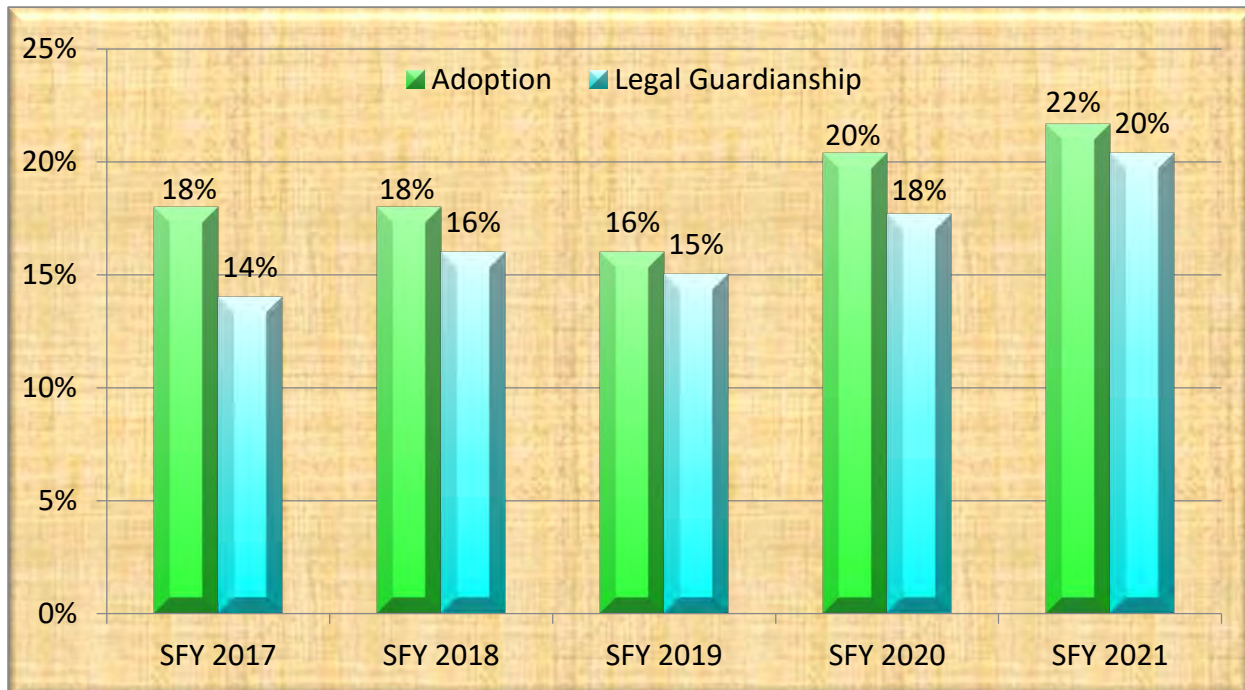


Figure 58: Exits by Adoption and Legal Guardianship SFYs 2017-2021 Numbers [Chart]

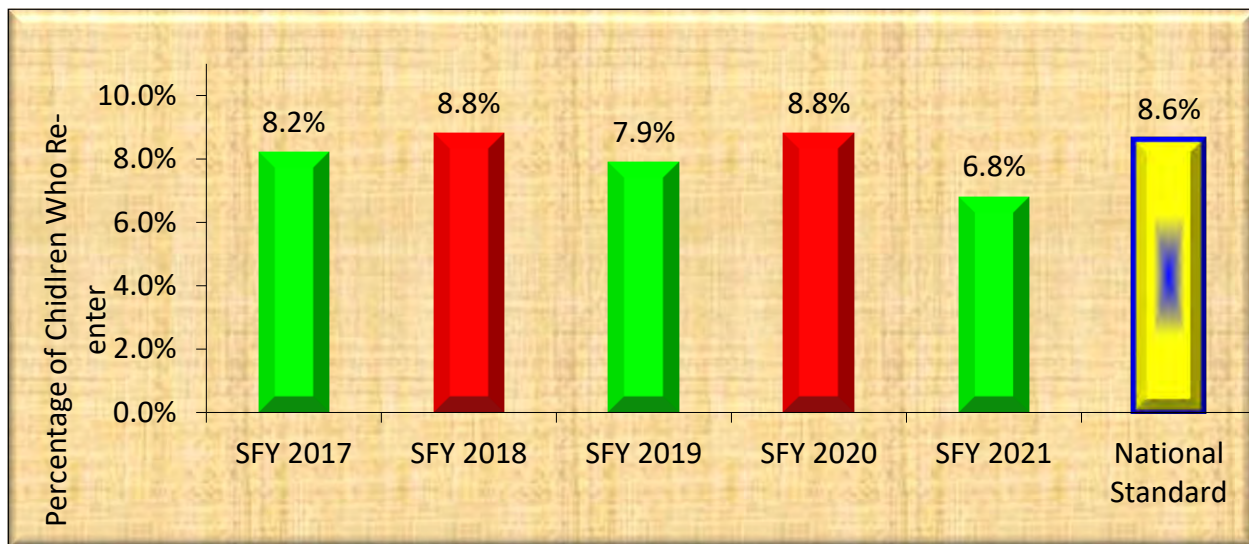

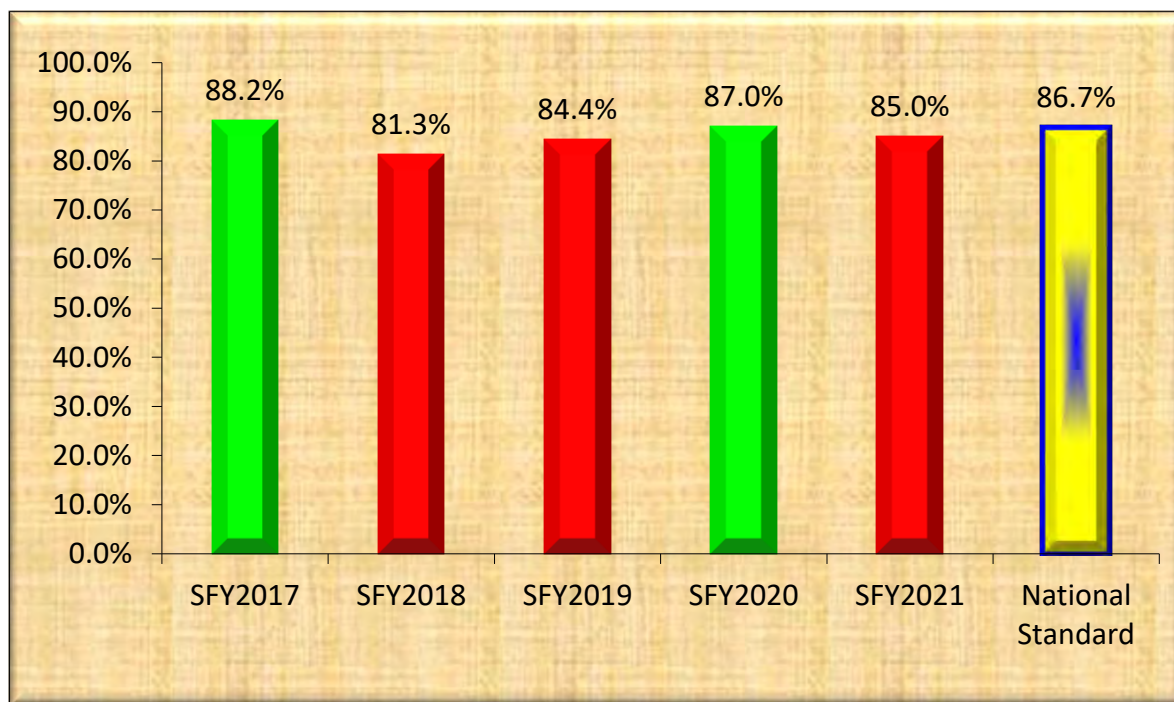
Figure 61: Re-entry into Foster Care within 12-months of Exit, SFYs 2017-2021 [Chart]

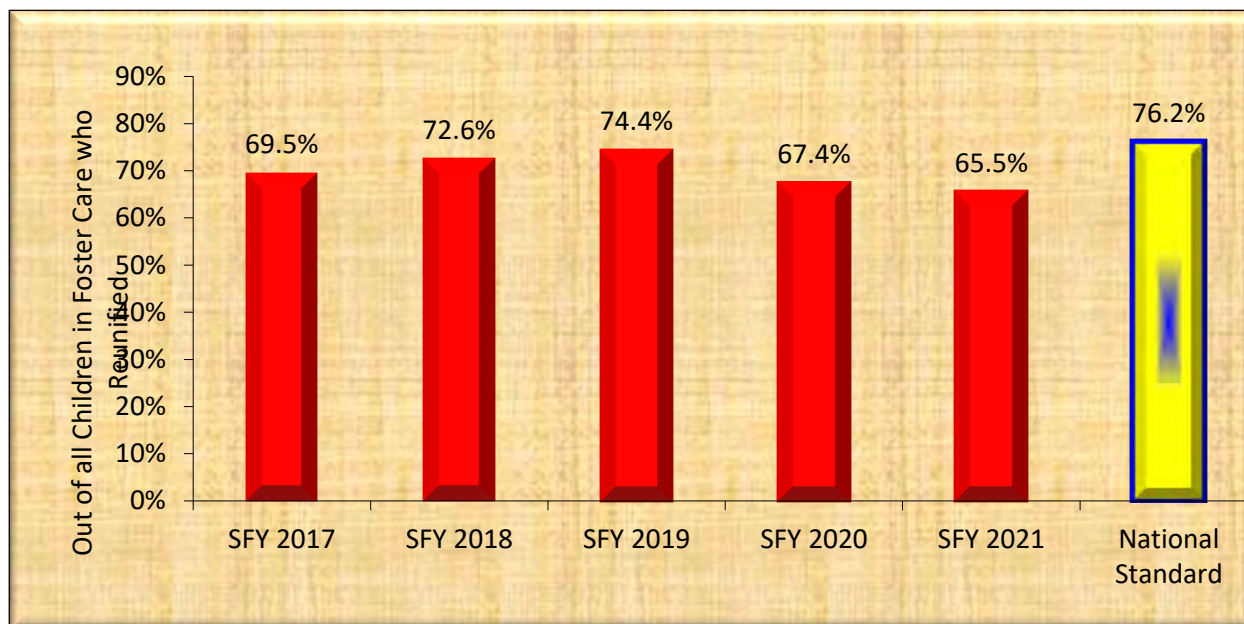
Figure 62: Placement Stability – Two or Fewer Placements SFYs 2017-2021 [Chart]

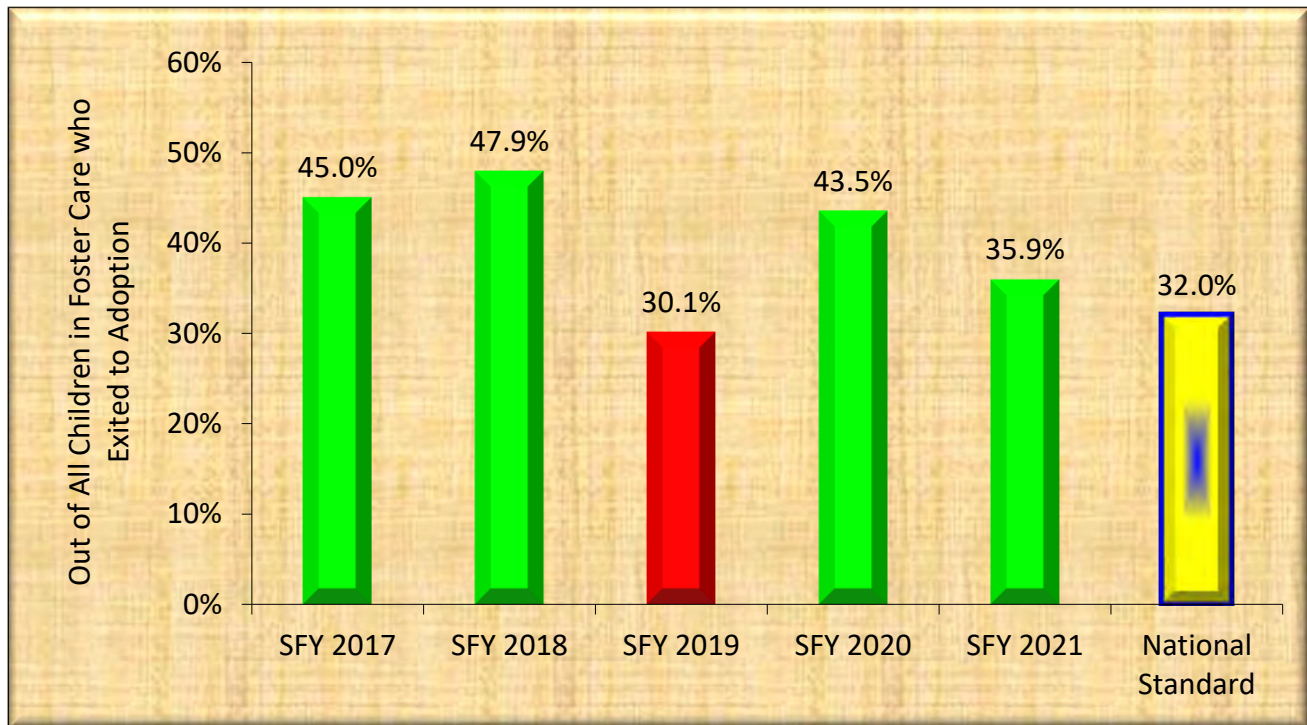
Figure 63: Timely Reunification (Within 12 Months) – SFYs 2017-2021 [Chart]

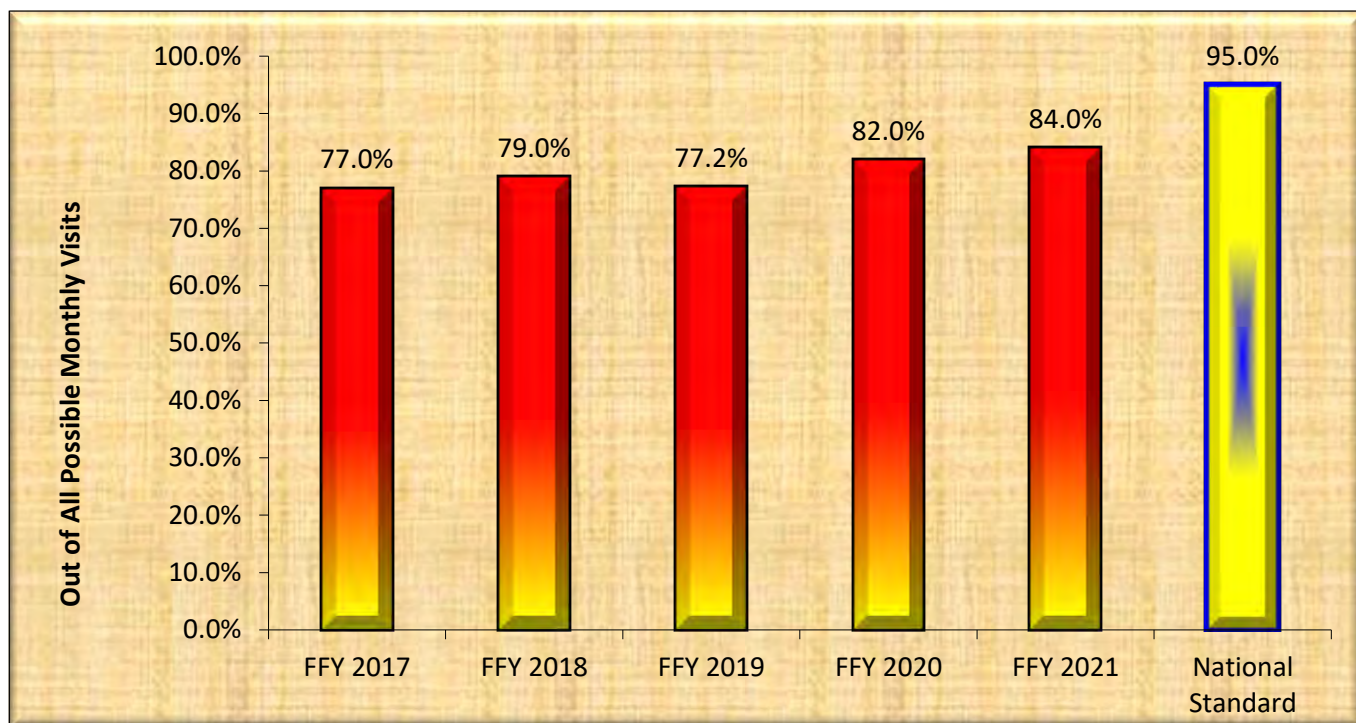

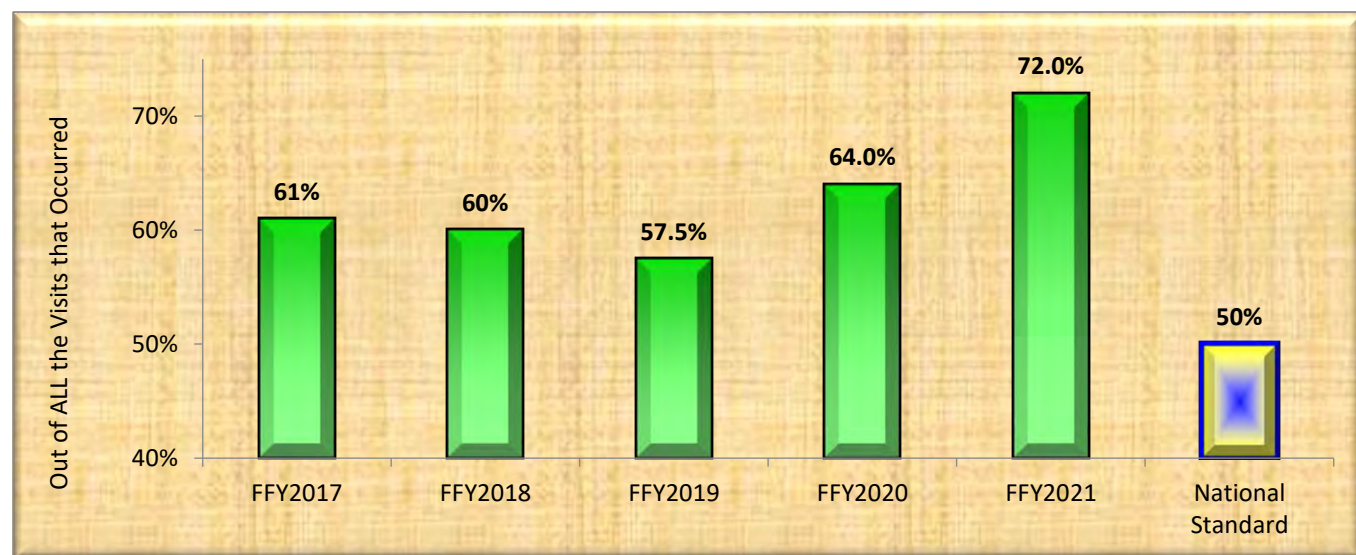
Figure 66: Worker Visit Survey Percentage of Monthly Visits to Children in Care FFYs 2017-2021 [Chart]

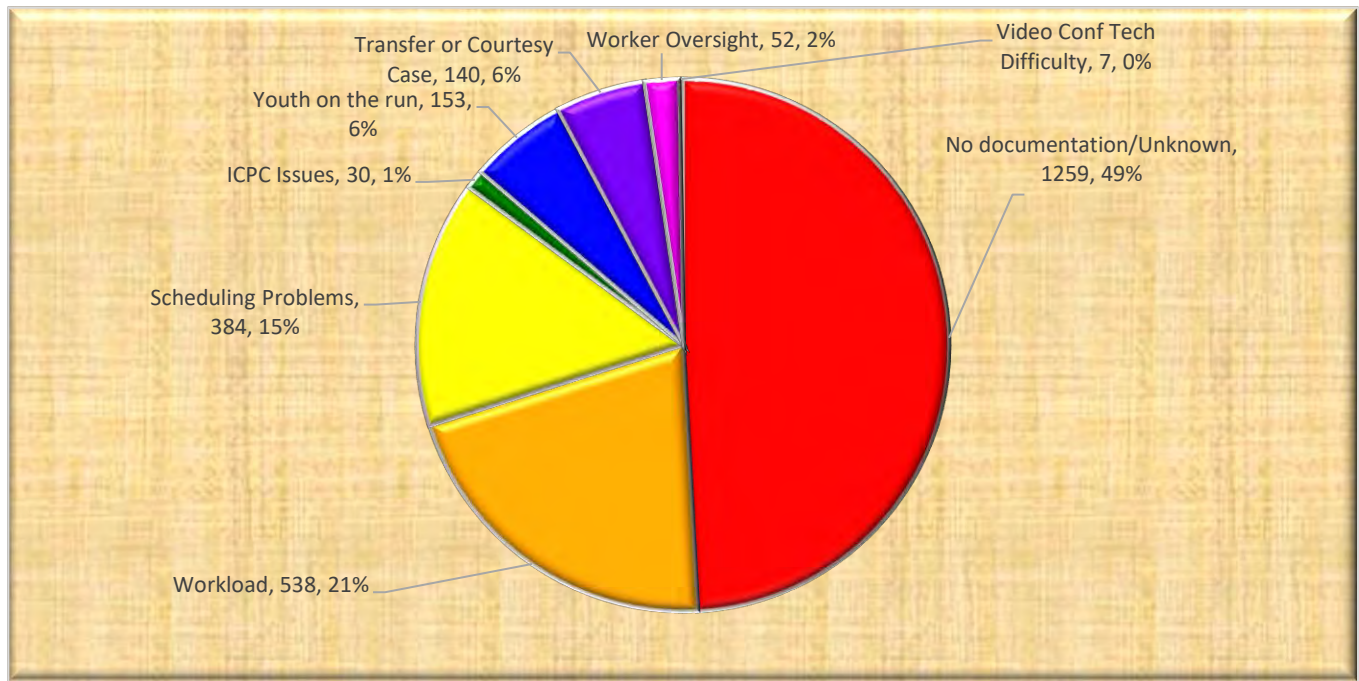
Figure 67: Worker Visit Survey Percentage of Monthly Visits in the Child's Home: FFYs 2017-2021 [Chart]

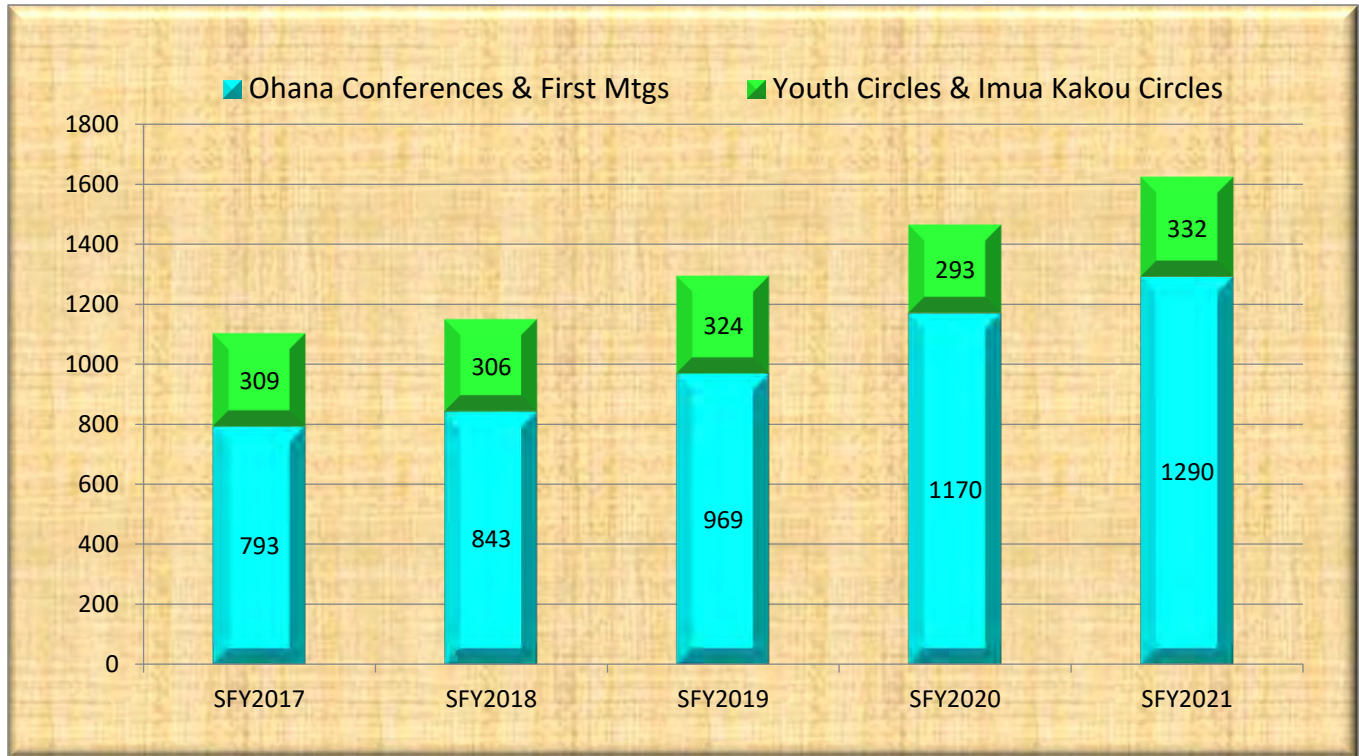

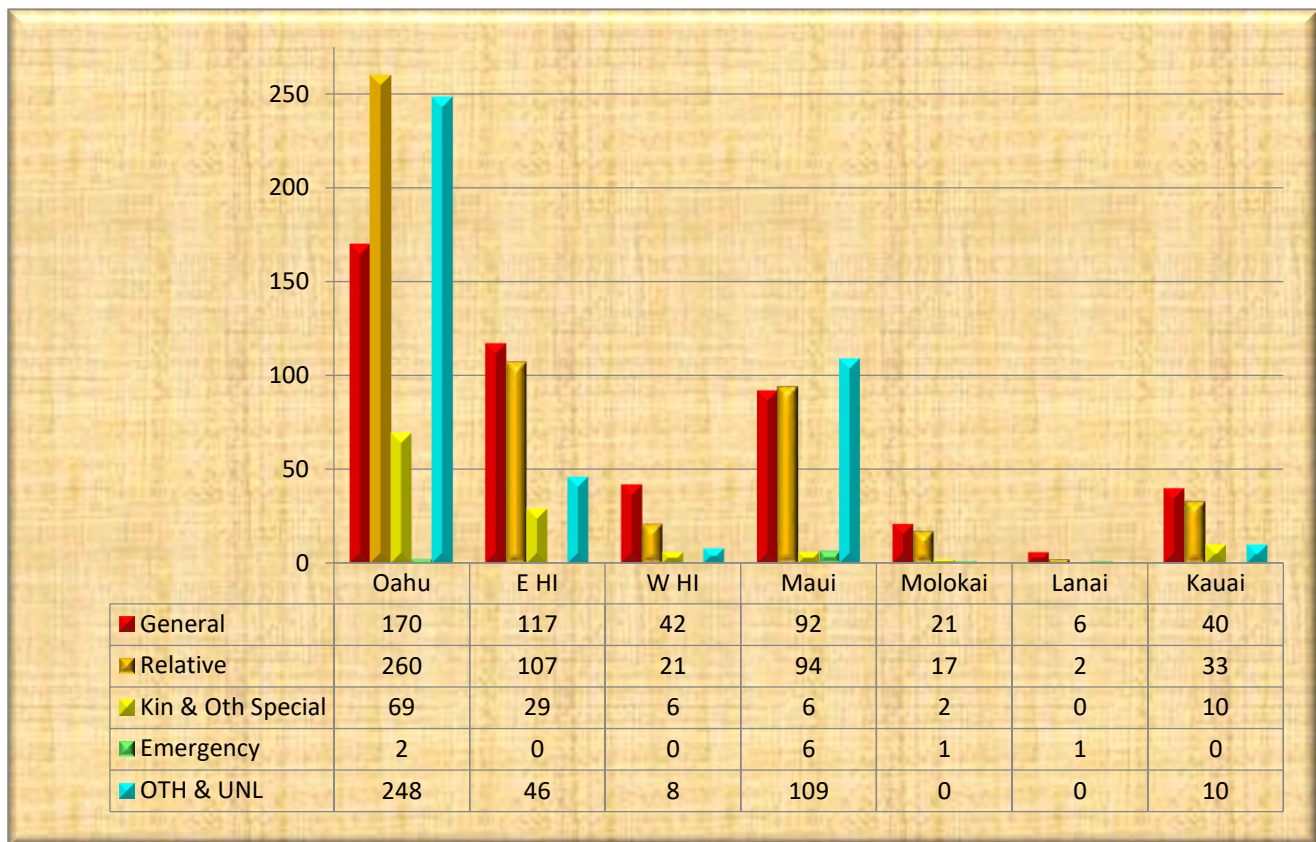
Figure 78: Statewide Targeted Recruitment of Resource Caregivers SFYs 2019-2021 [Table]

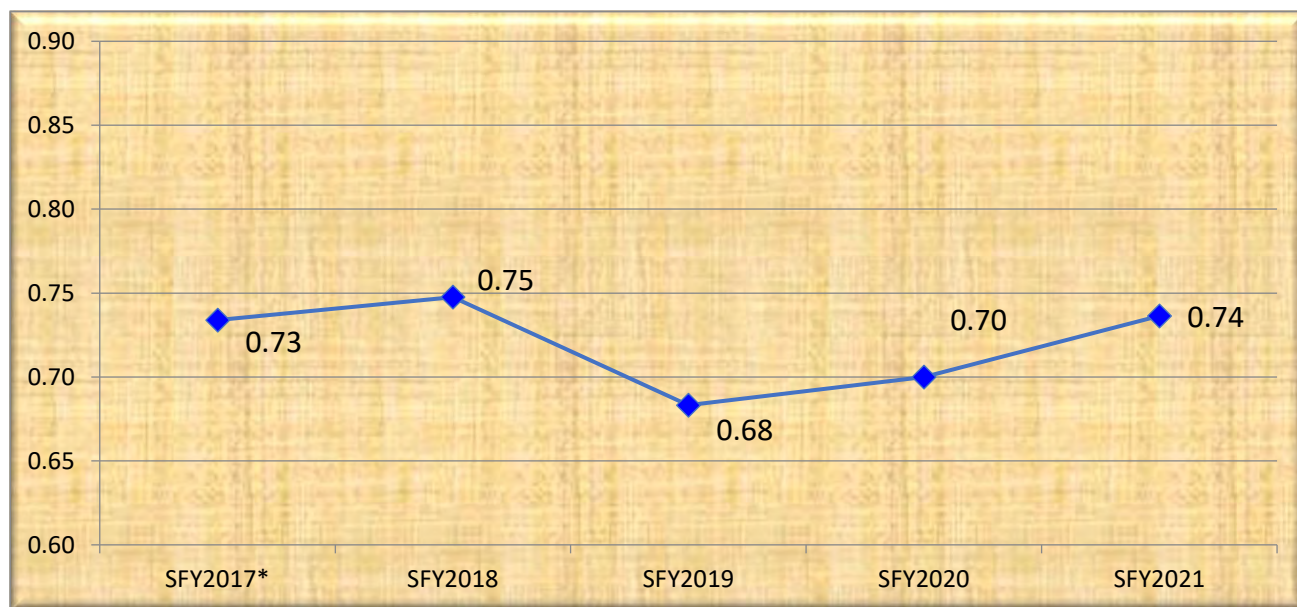

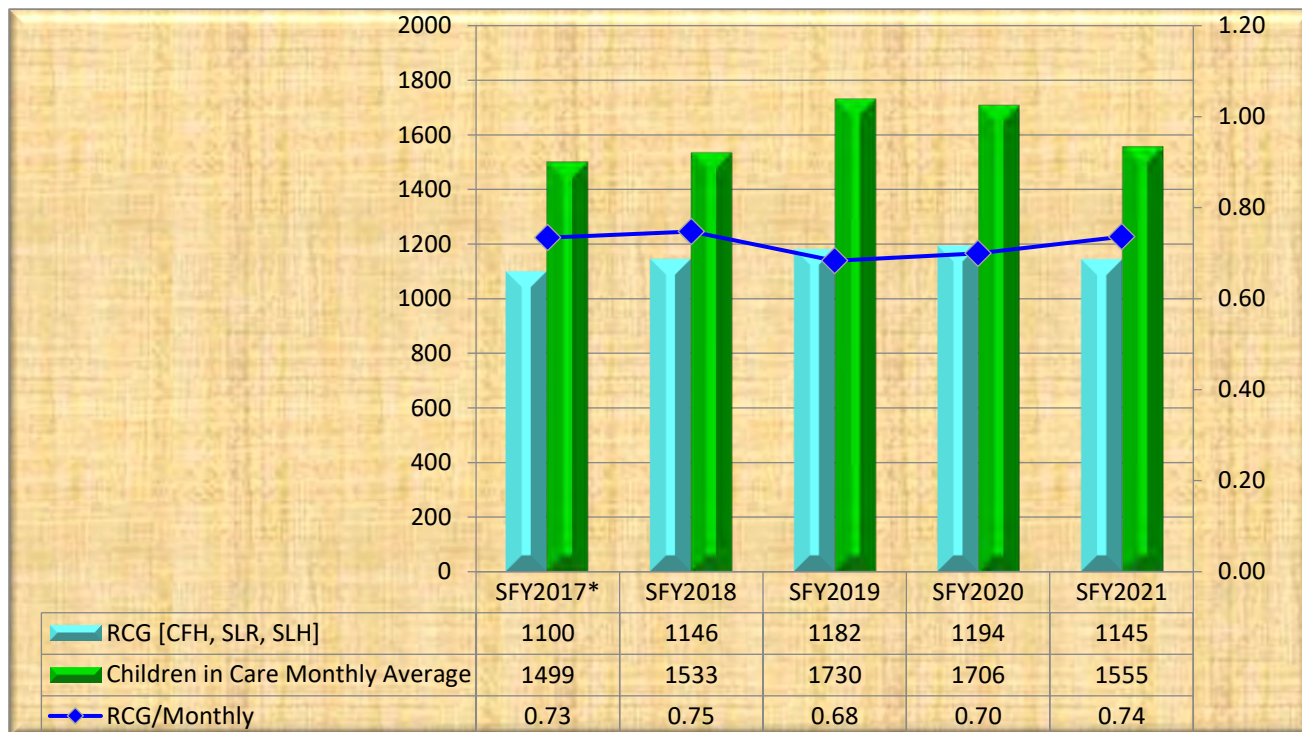


Figure 81: Ratio of Resource Caregiver Homes to Children in Care SFYs 2017-2021 [Chart]

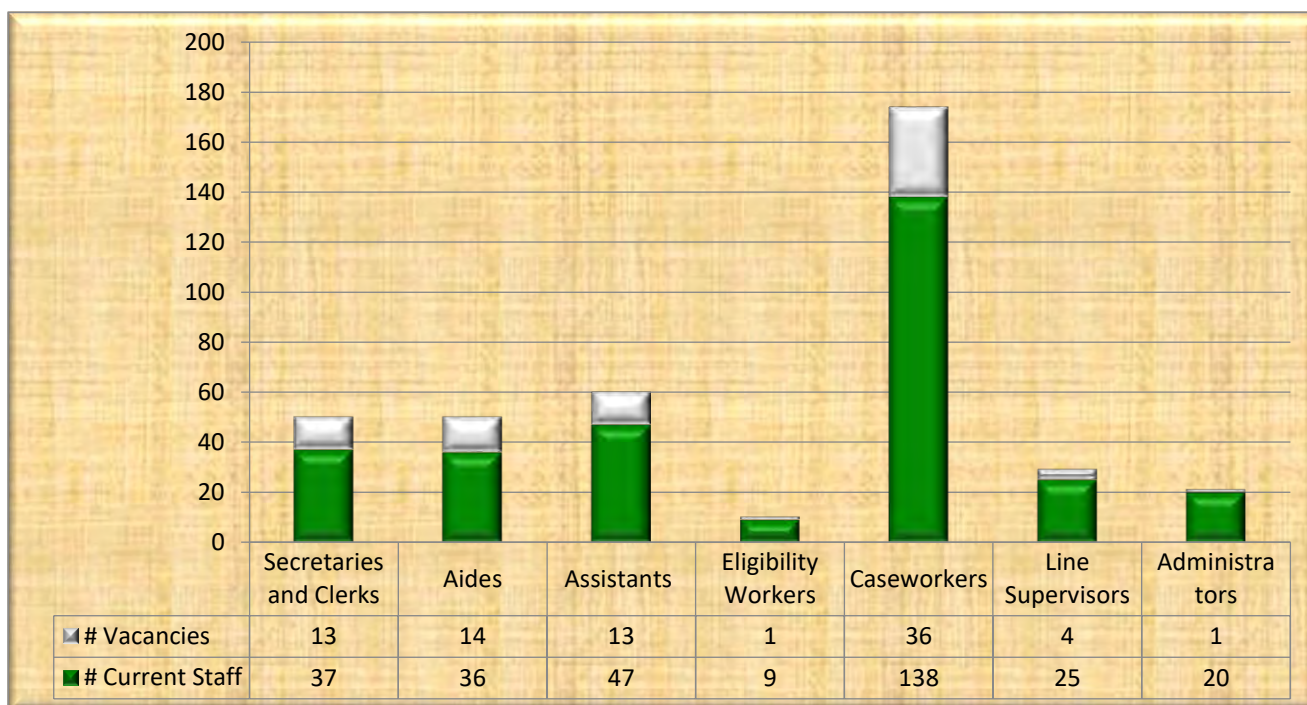

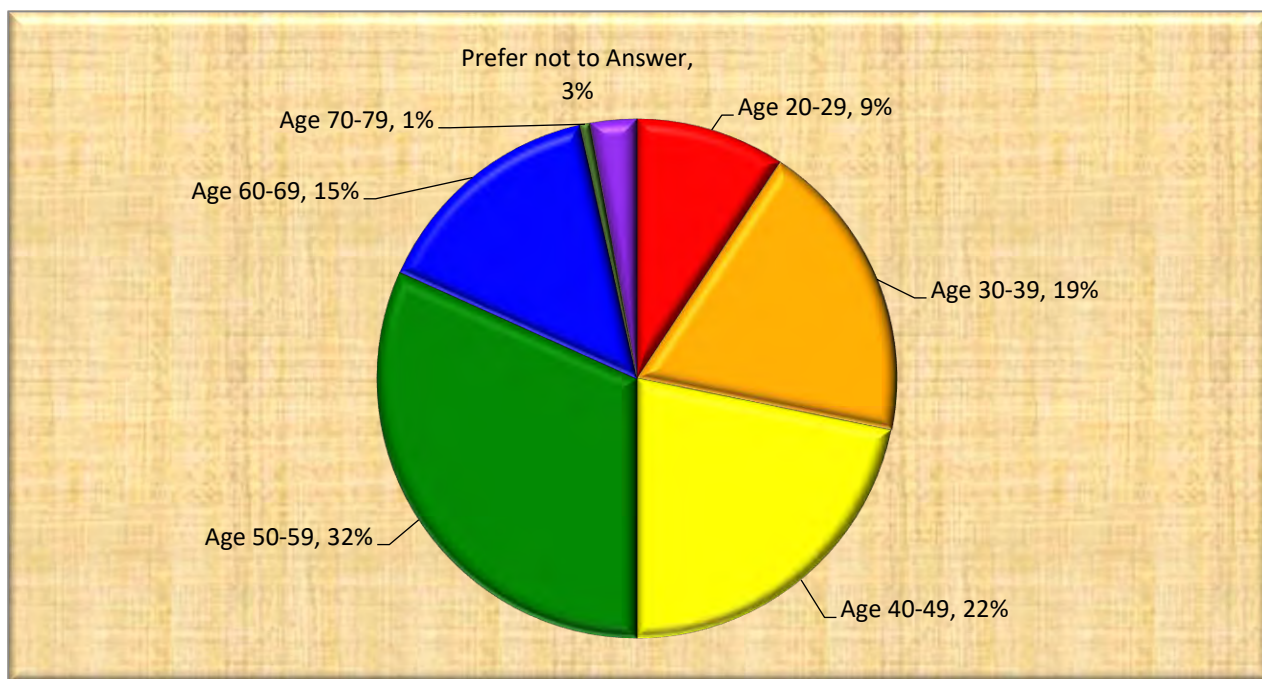

Figure 88: CWSB Staff Position Breakdown – Filled & Vacant – January 2022 [Chart]



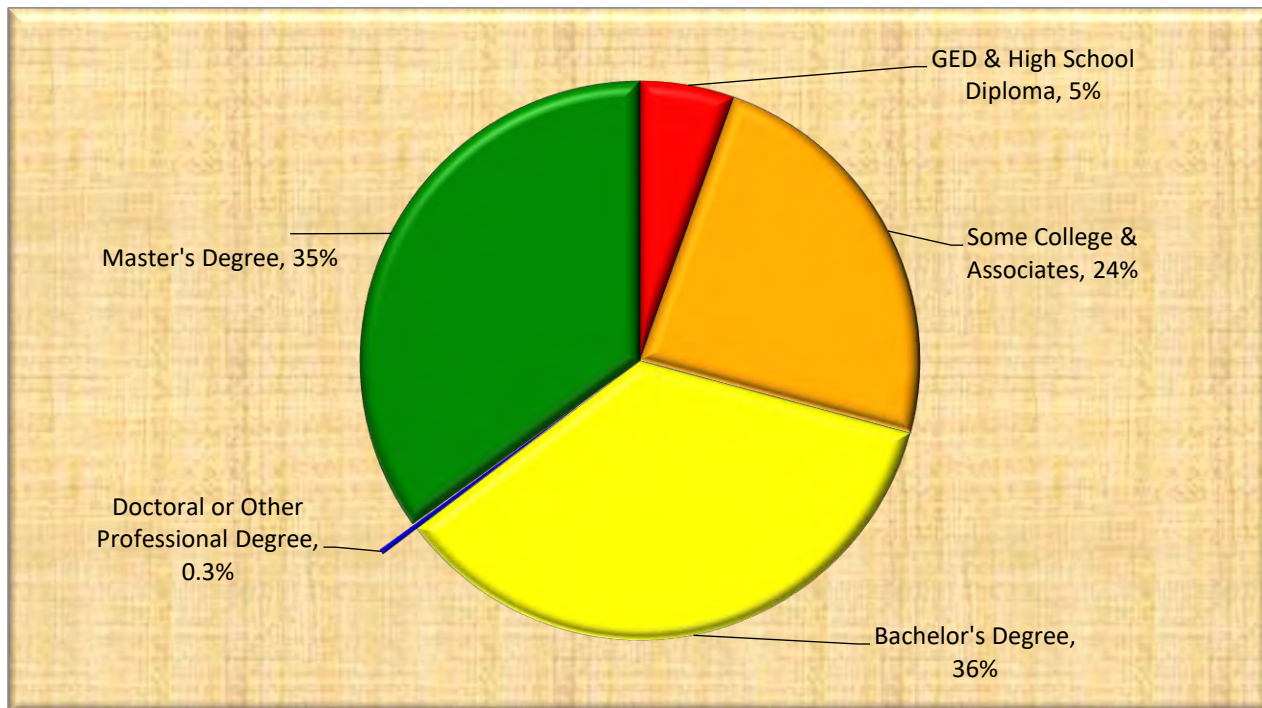

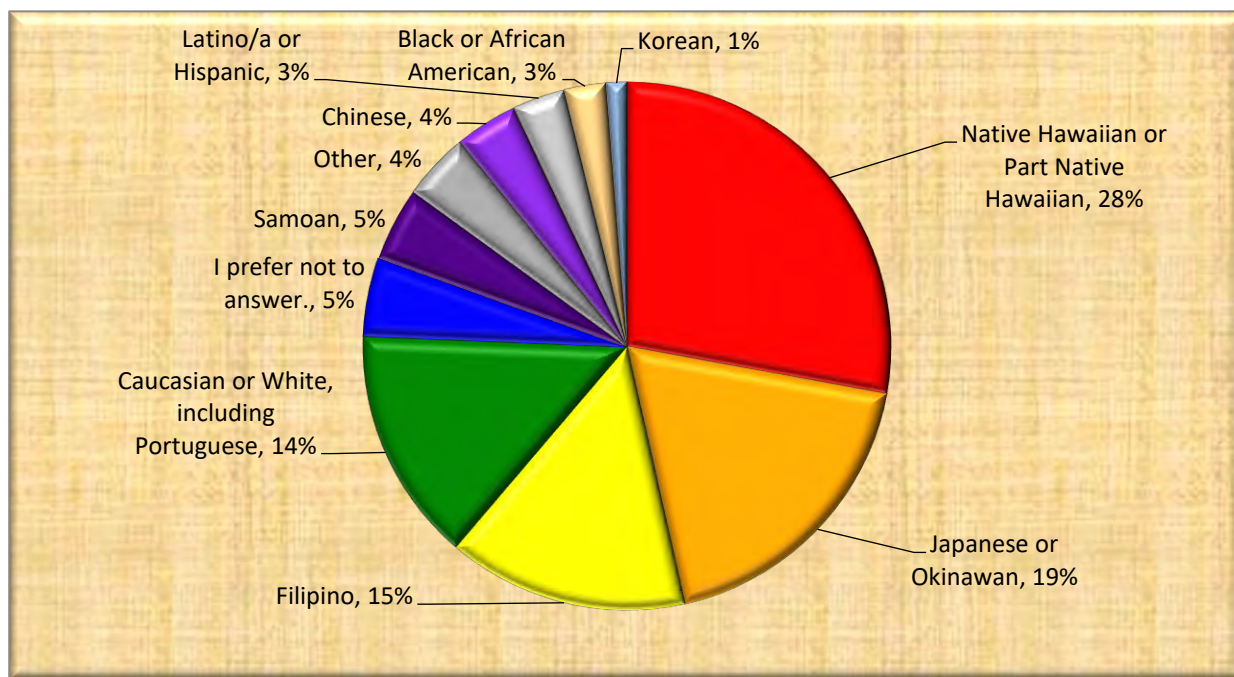
Figure 90: Highest Level of Education – ALL CWSB Staff January 2022 [Chart]

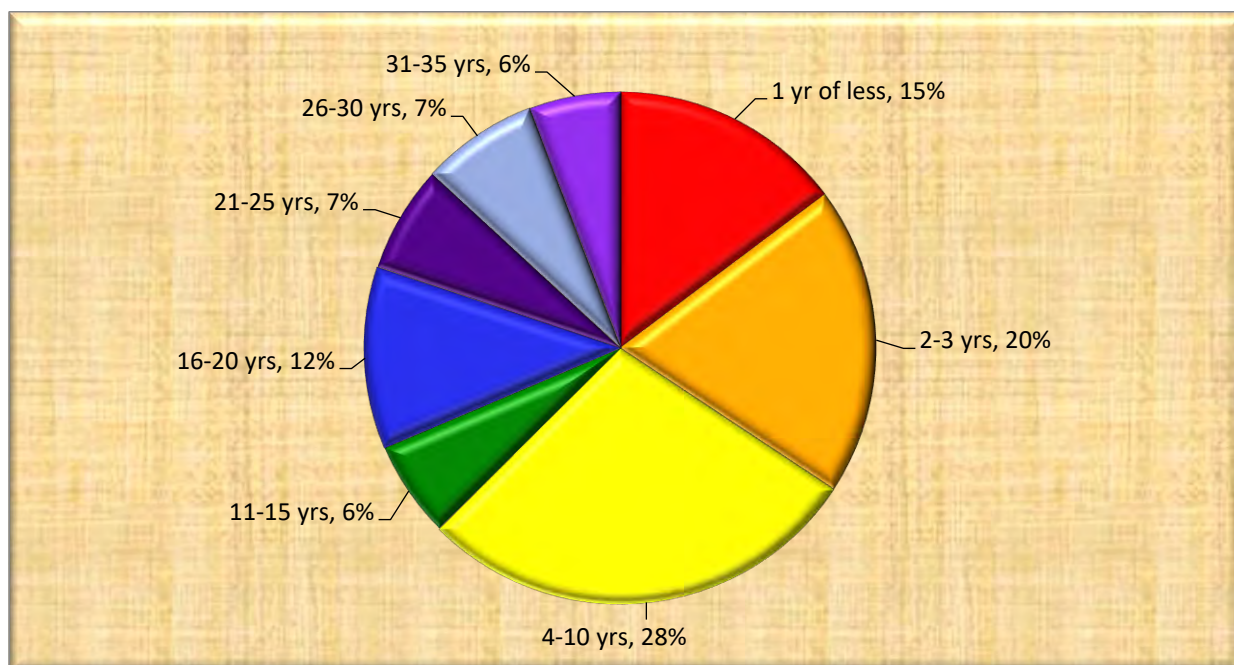
Figure 91: CWSB Staff Ethnicities - Self-Reported – January 2022 [Chart]

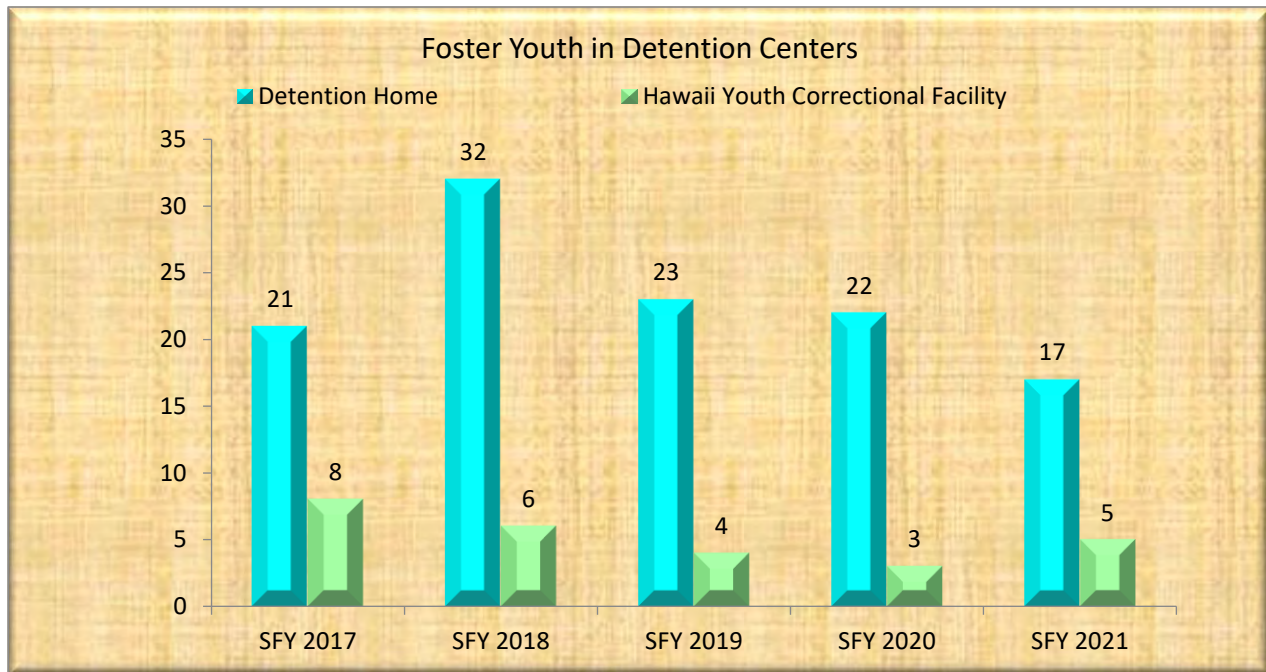


Figure 93: Foster Youth in Detention Centers SFYs 2017-2021 [Table]

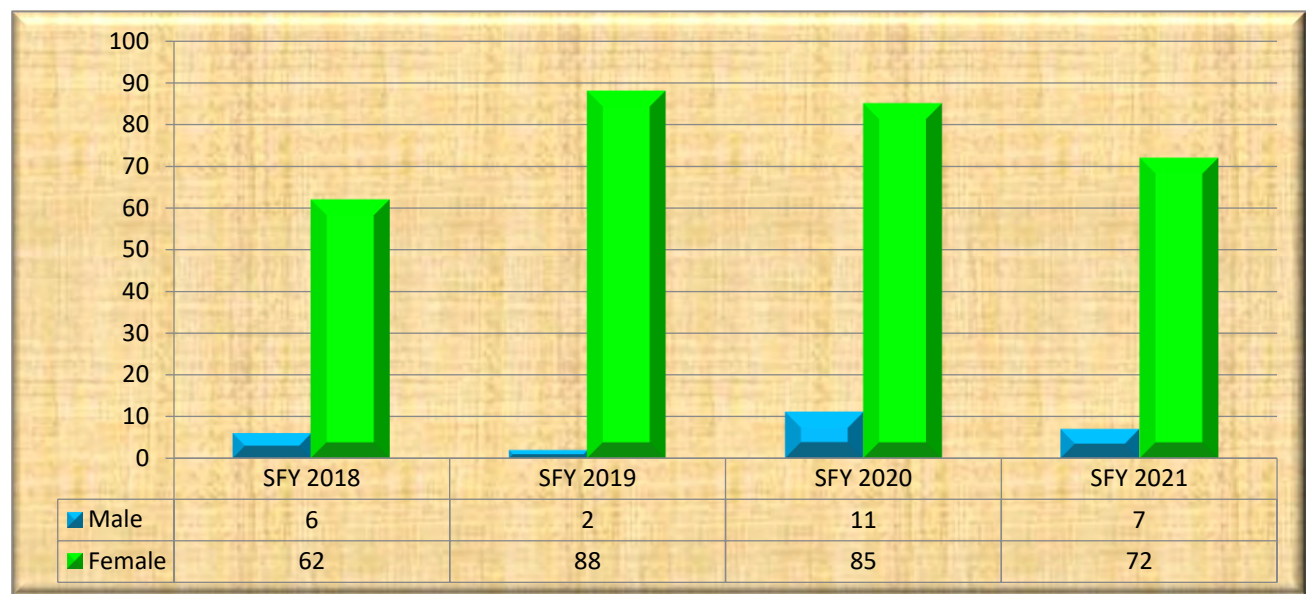
Figure 96: Domestic Violence Services SFYs 2020-2021 [Table]

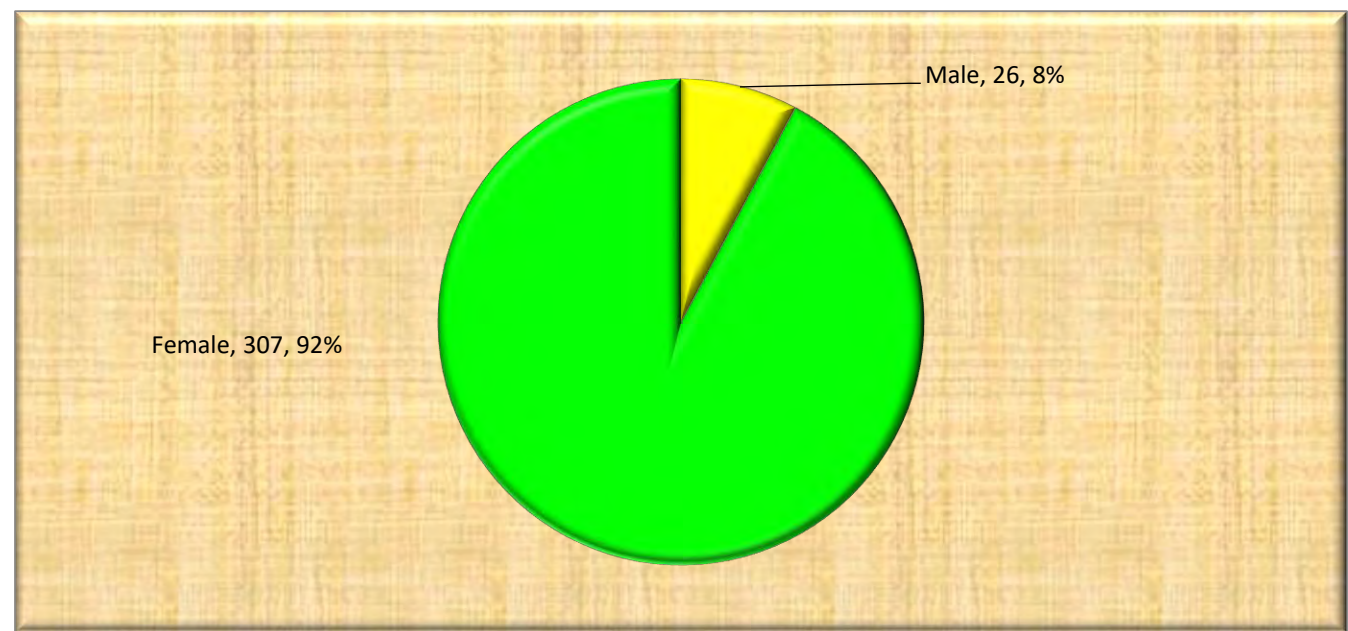

Figure 97: Gender Distribution of Alleged Victims of Human Trafficking - SFYs 2018-2021 [Chart]



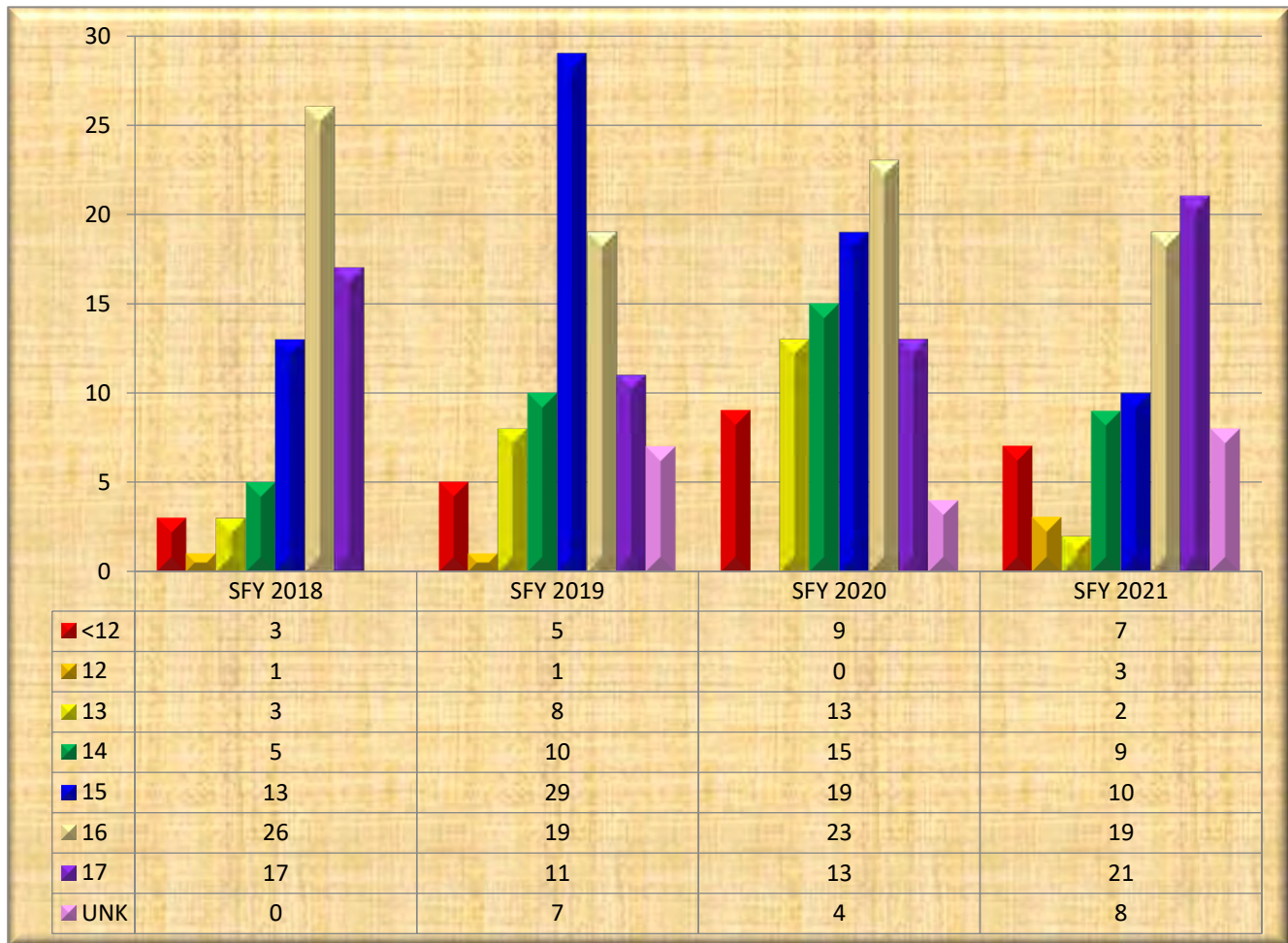

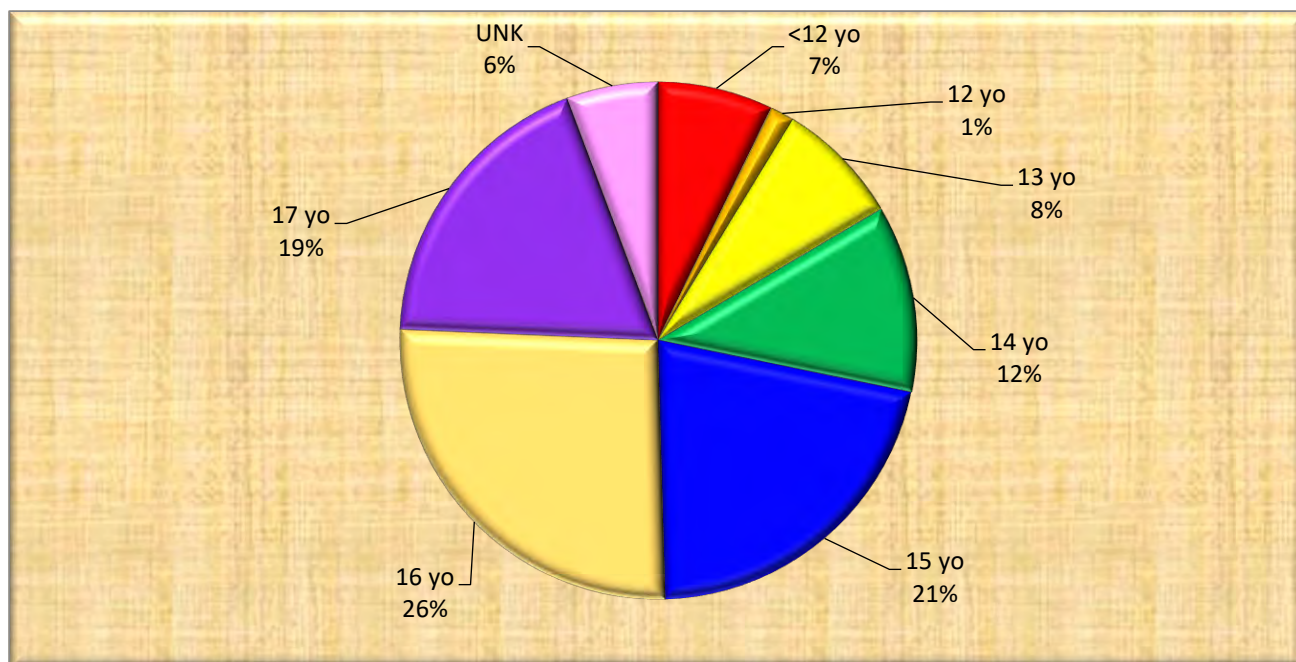
Figure 99: Age Distribution of Alleged Victims of Human Trafficking – SFY2018-2021 [Chart]

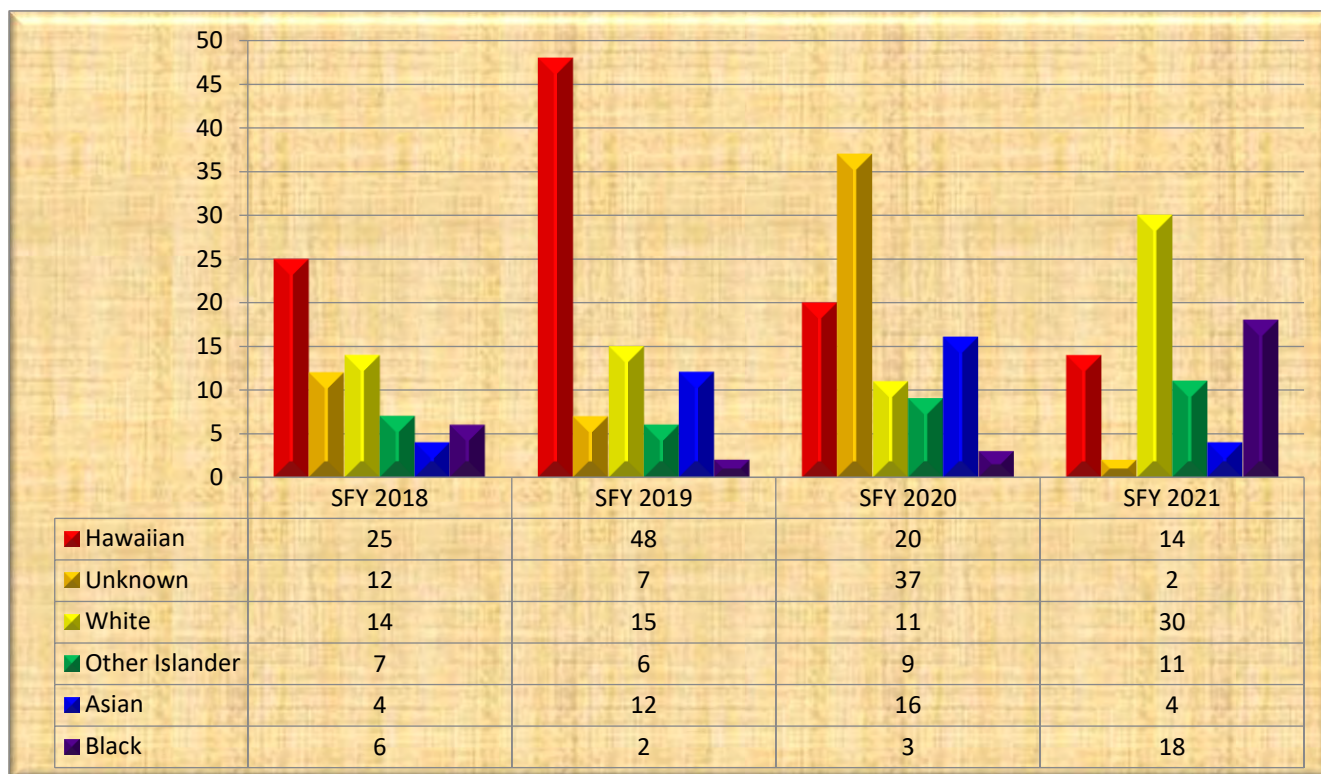


Figure 100: Age Distribution of Alleged Victim of Human Trafficking, Composite for SFYs 2018-2021 [Chart]



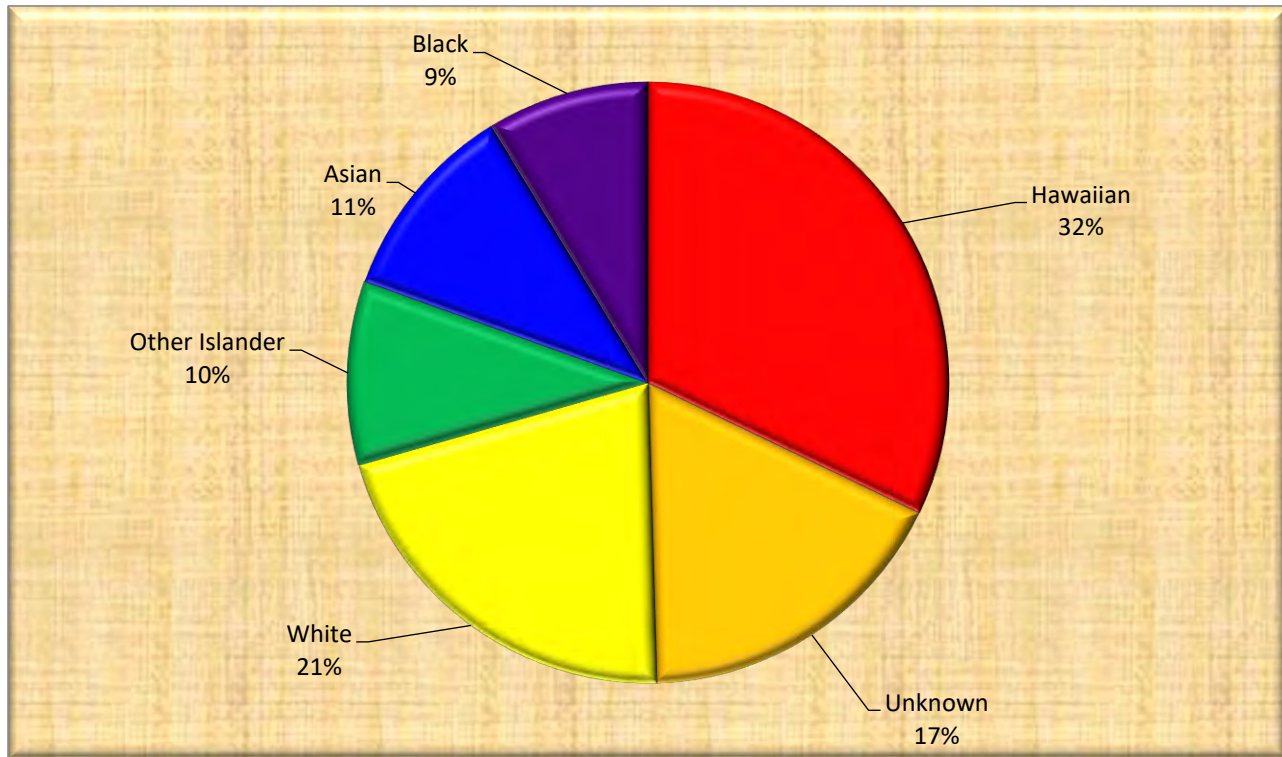

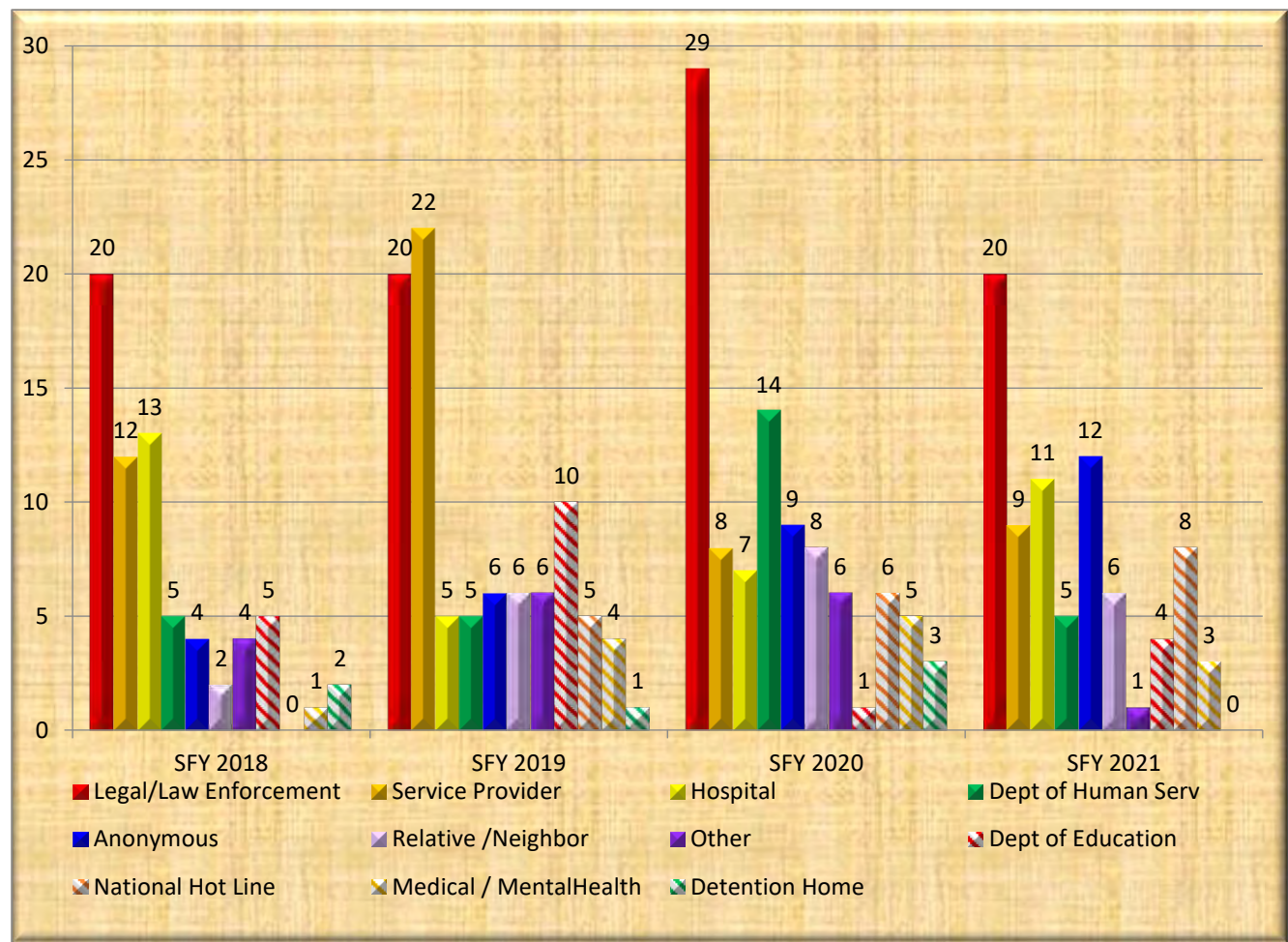
Figure 103: Source of Human Trafficking Referral - SFY2018-2021 [Table]

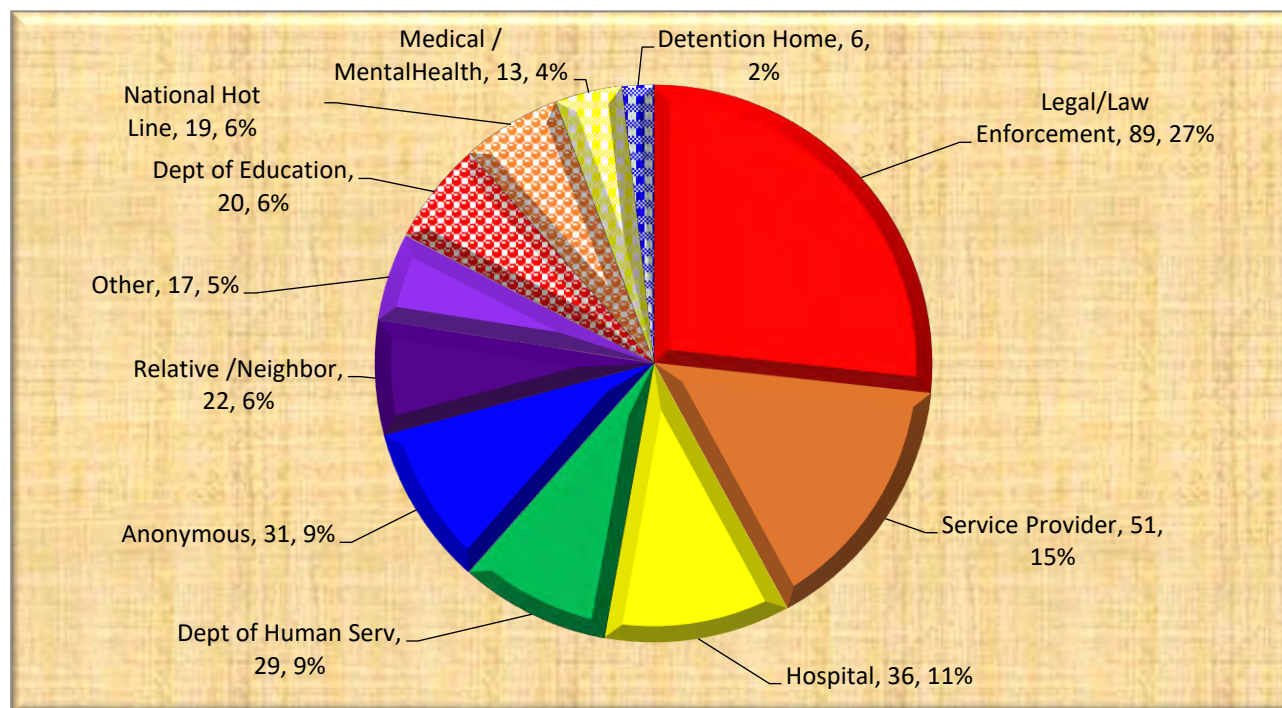


Figure 104: Source of Human Trafficking Referral - SFY2018-2021 [Chart]



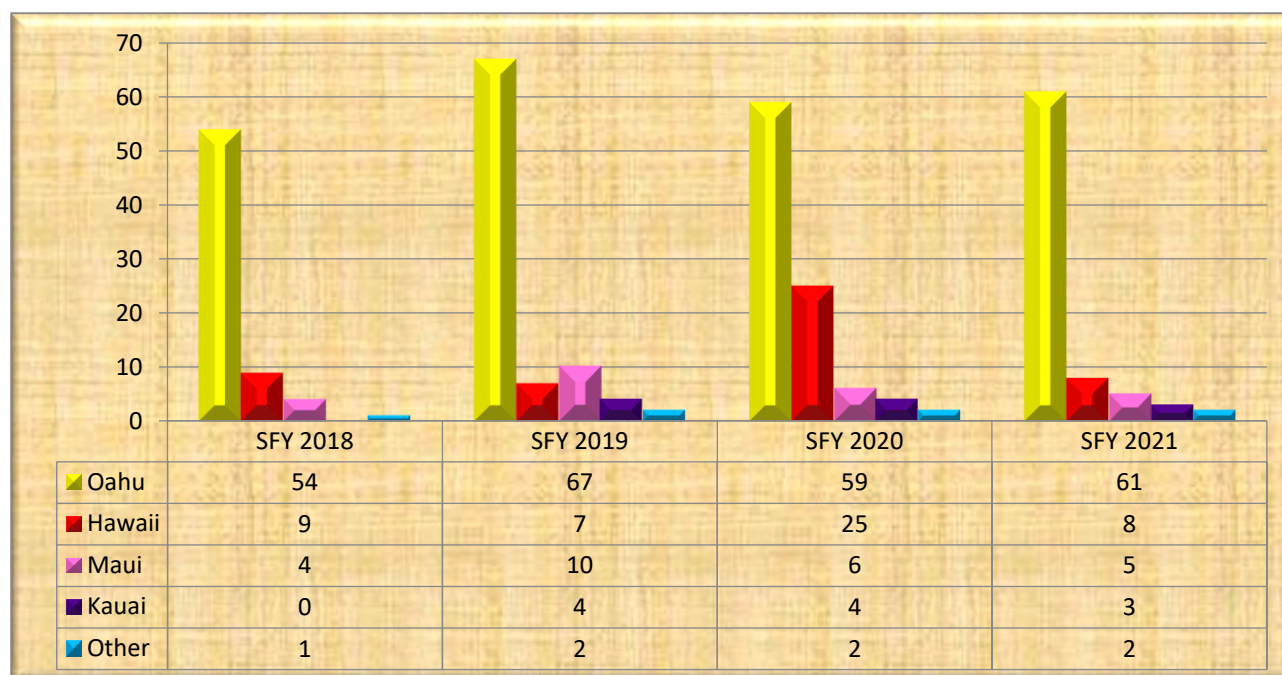

Figure 106: Geographic Distribution of Human Trafficking Reports by Island/County – SFY 2018-2021 [Chart]

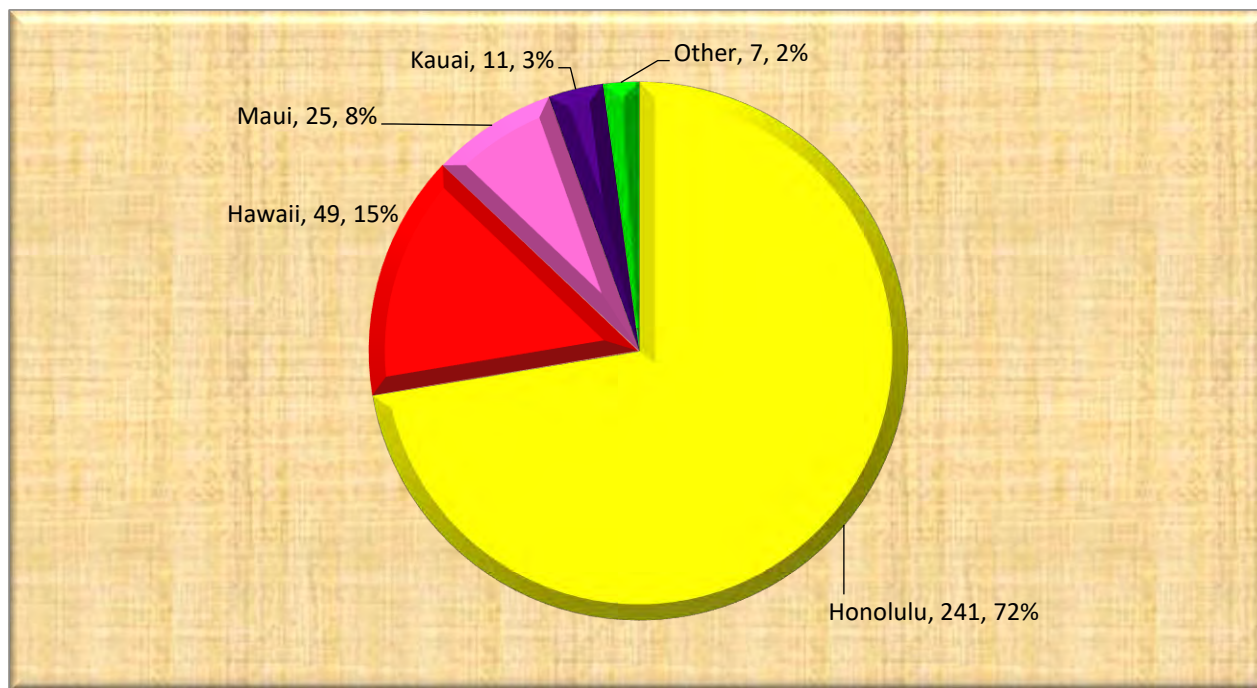

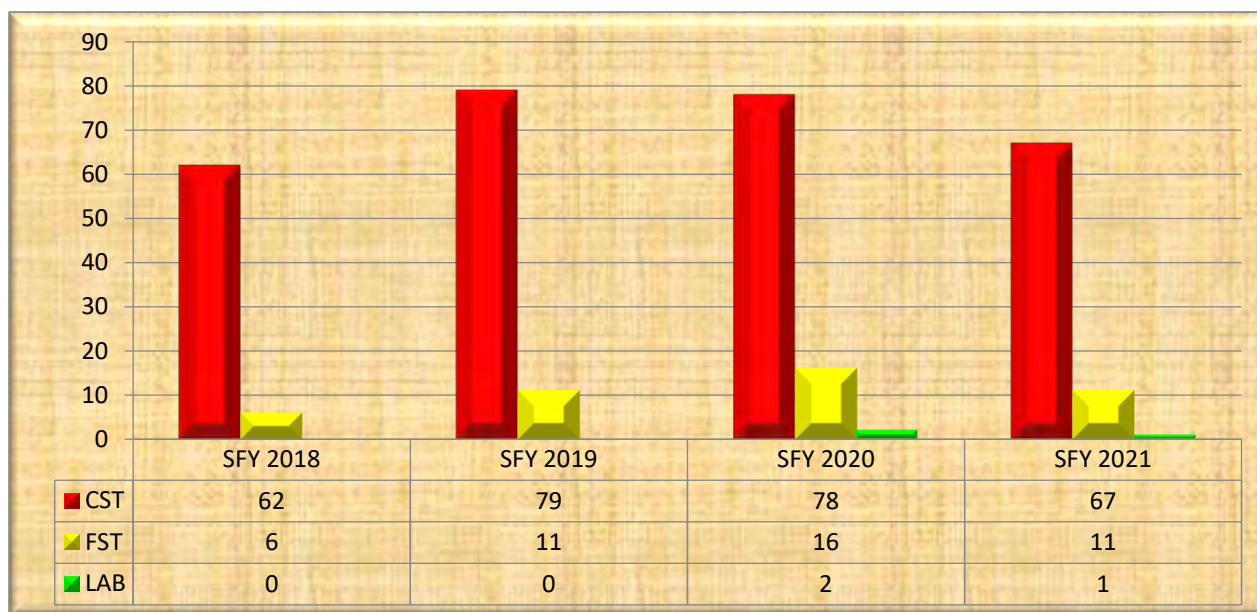

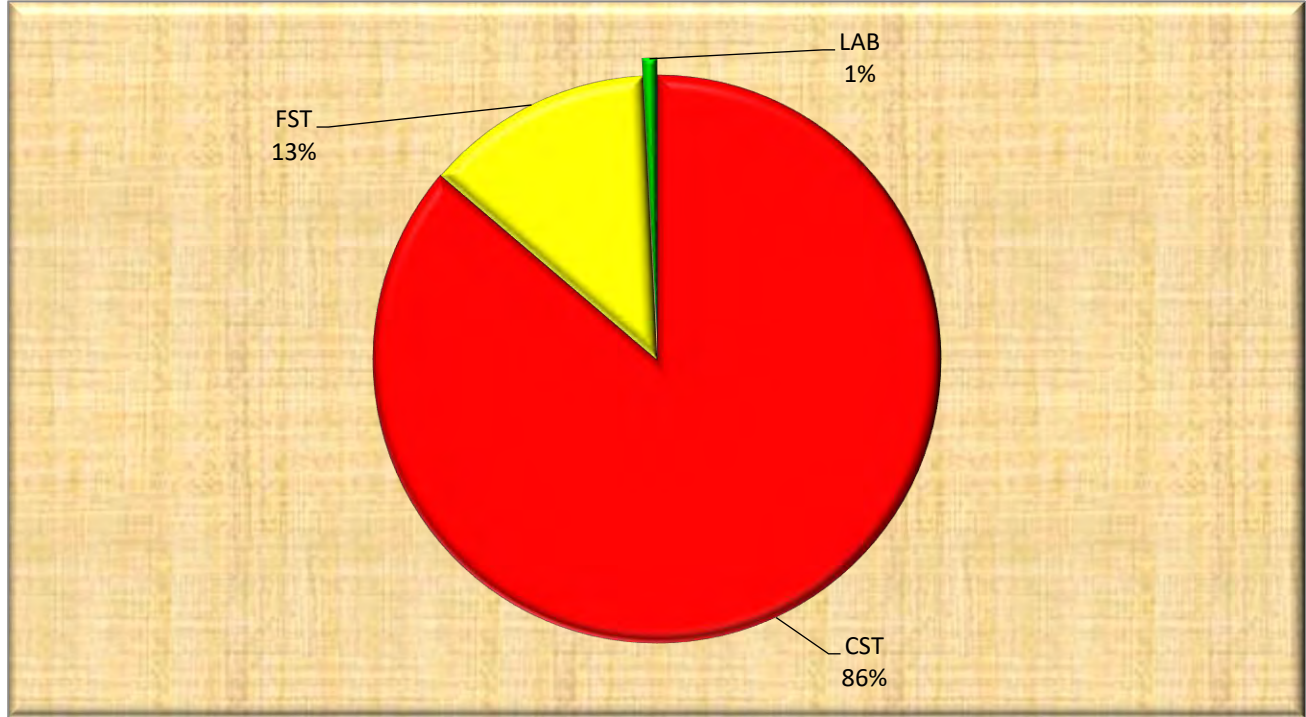
Figure 108: Human Trafficking Reports by Type SFY 2018-2021 [Chart]

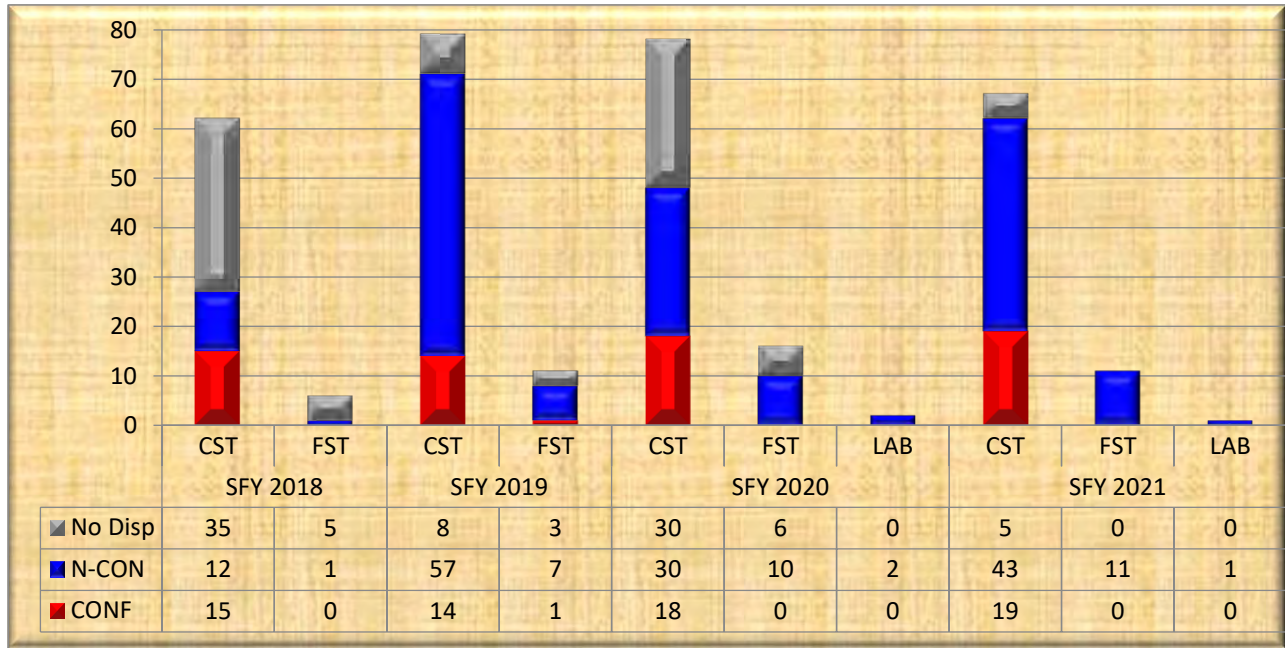

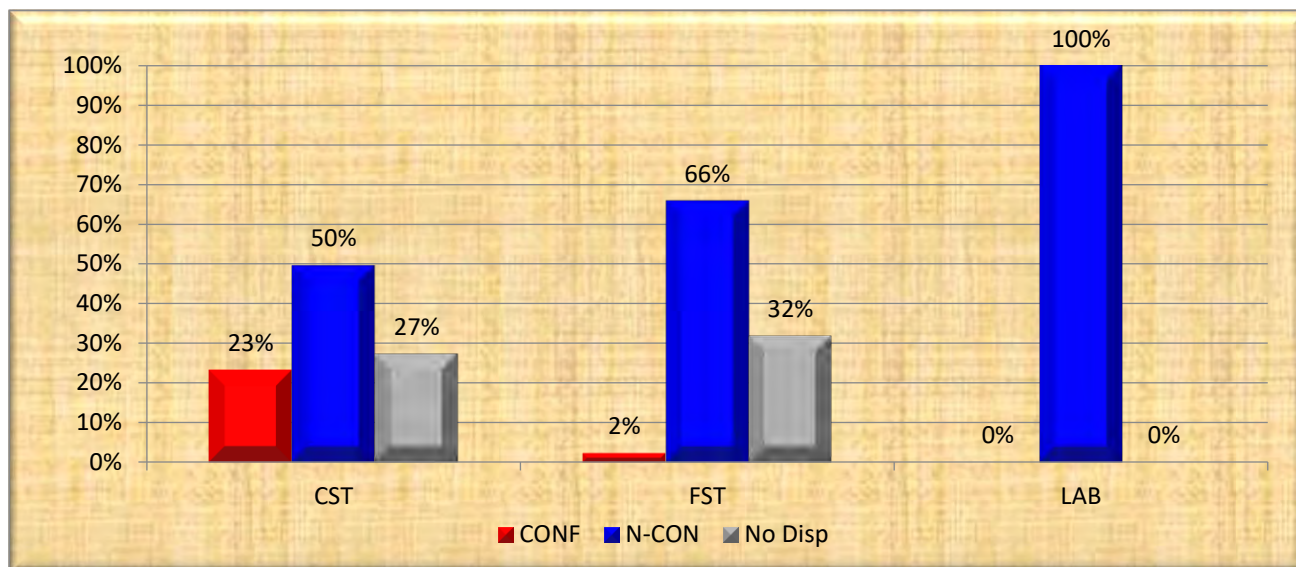
Figure 110: Disposition of Reports of Human Trafficking by Type, SFYs 2018-2021 [Chart]

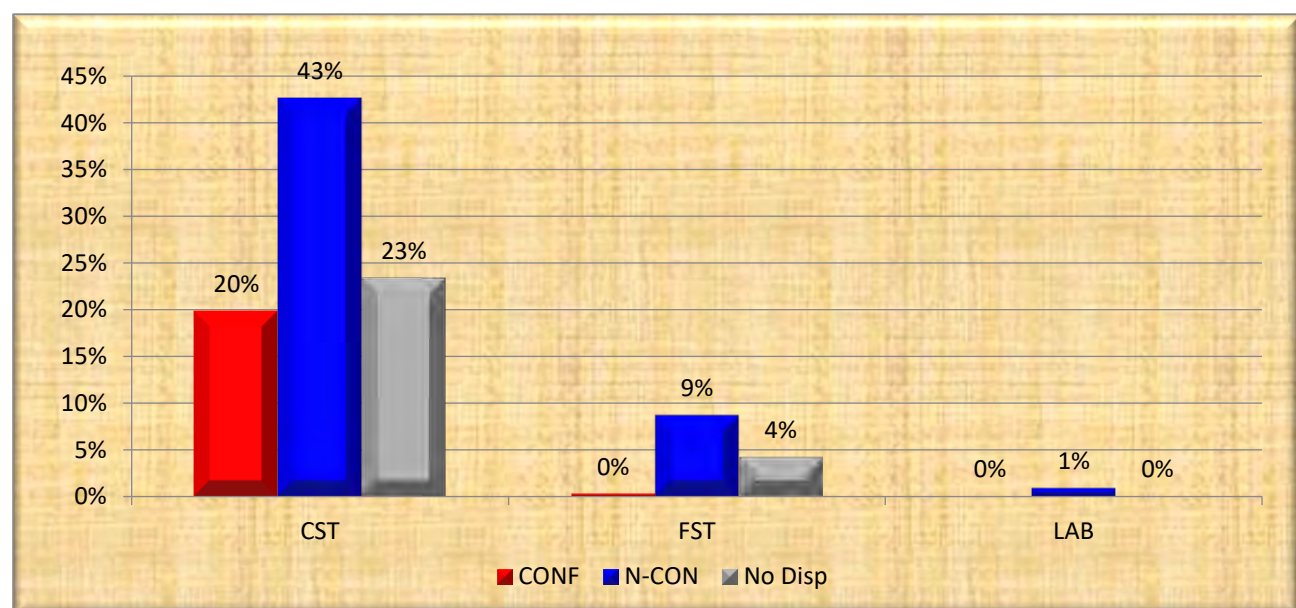
Figure 111: Dispositions of Human Trafficking Reports as Composite Percentage of Type SFYs 2018-2021 [Chart]

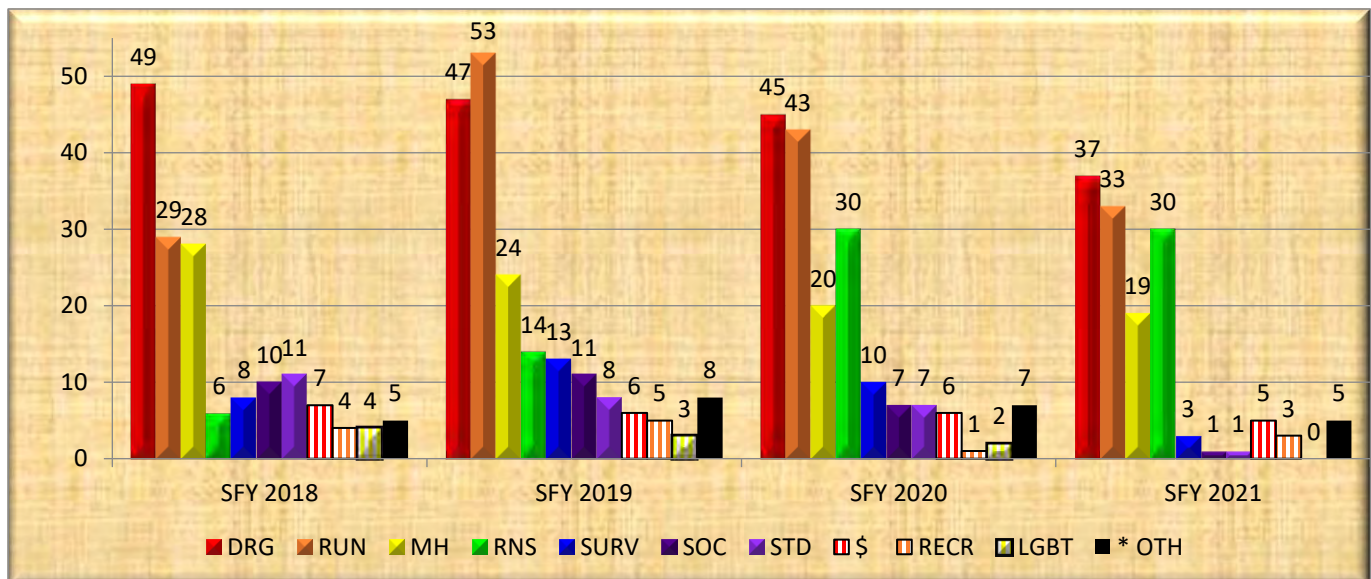
Figure 113: Human Trafficking Risk Factors for SFYs 2018-2021 [table]

Figure 114: Human Trafficking Risk Factors for SFYs 2018-2021 [Chart]

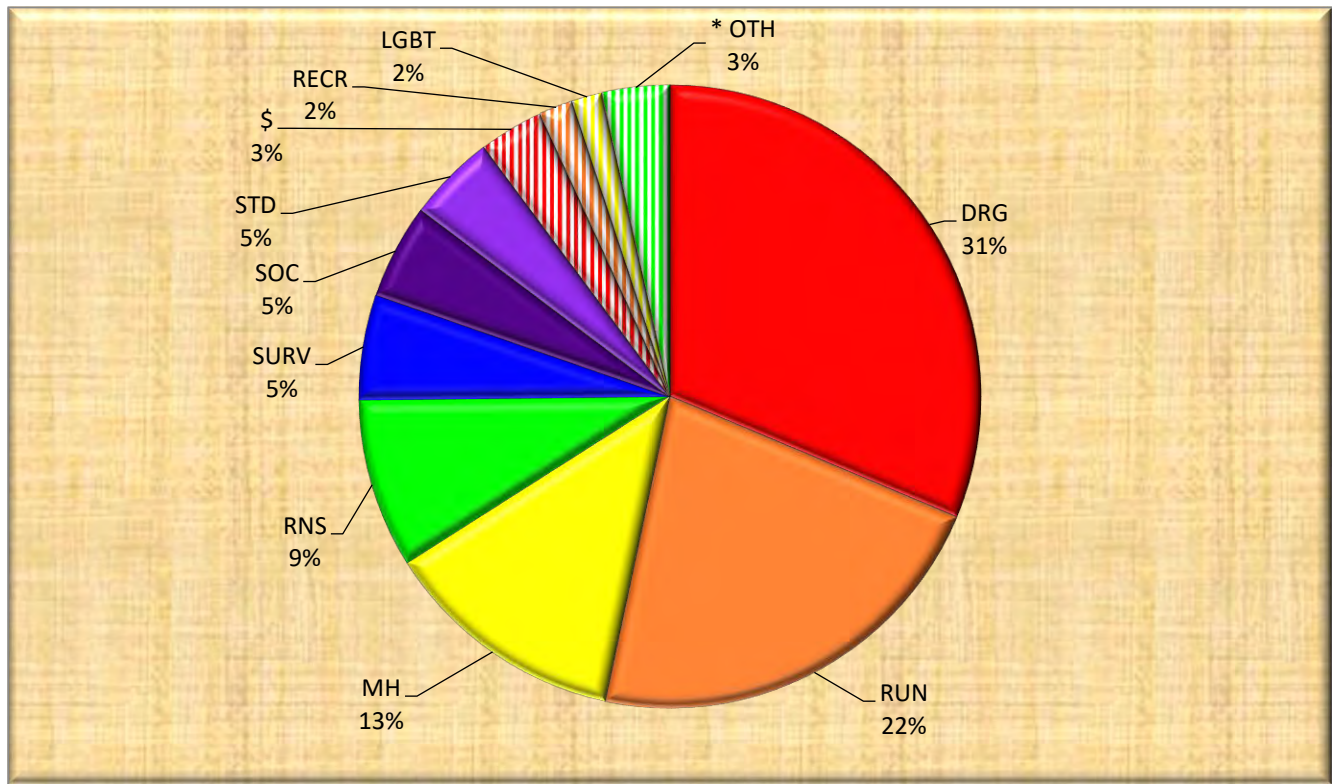

Figure 115: Human Trafficking Risk Factors Percentage Composite for SFYs 2018-2021 [Chart]



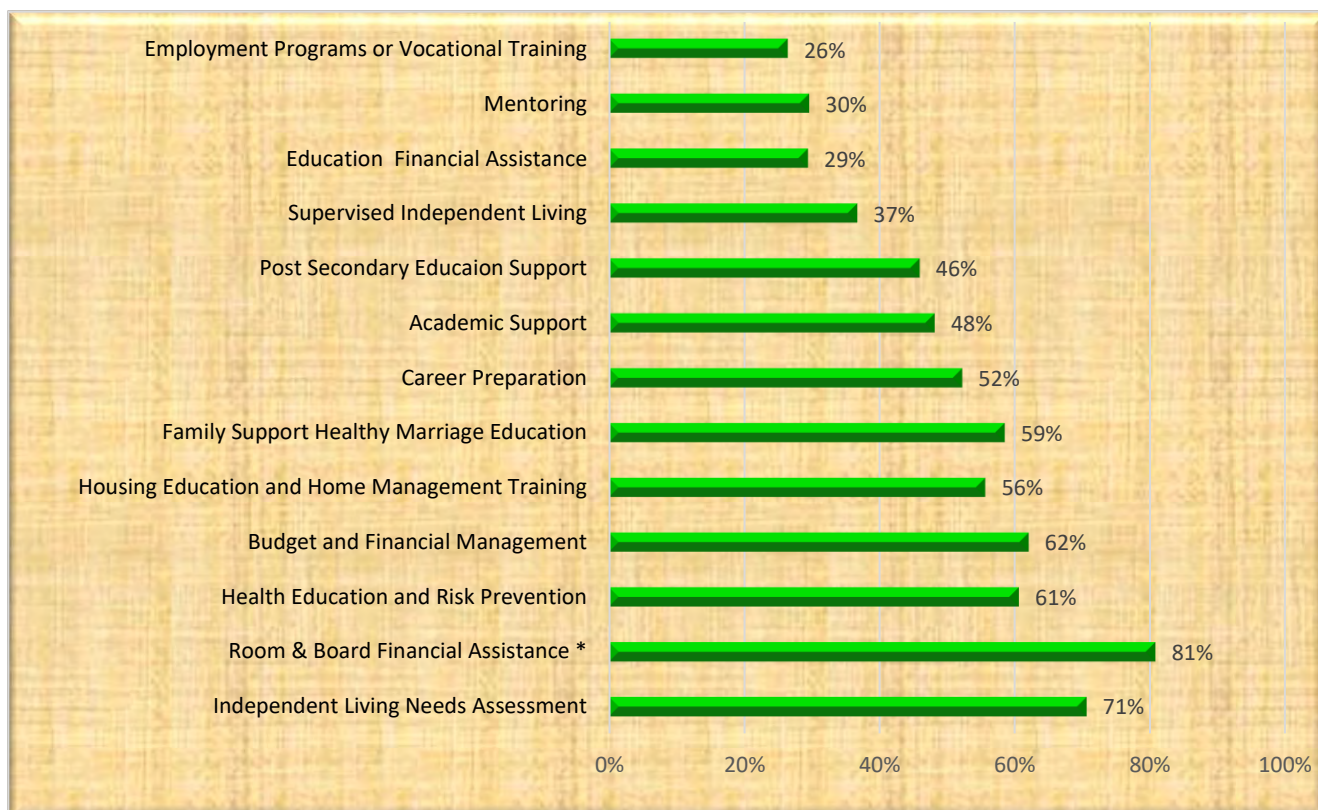

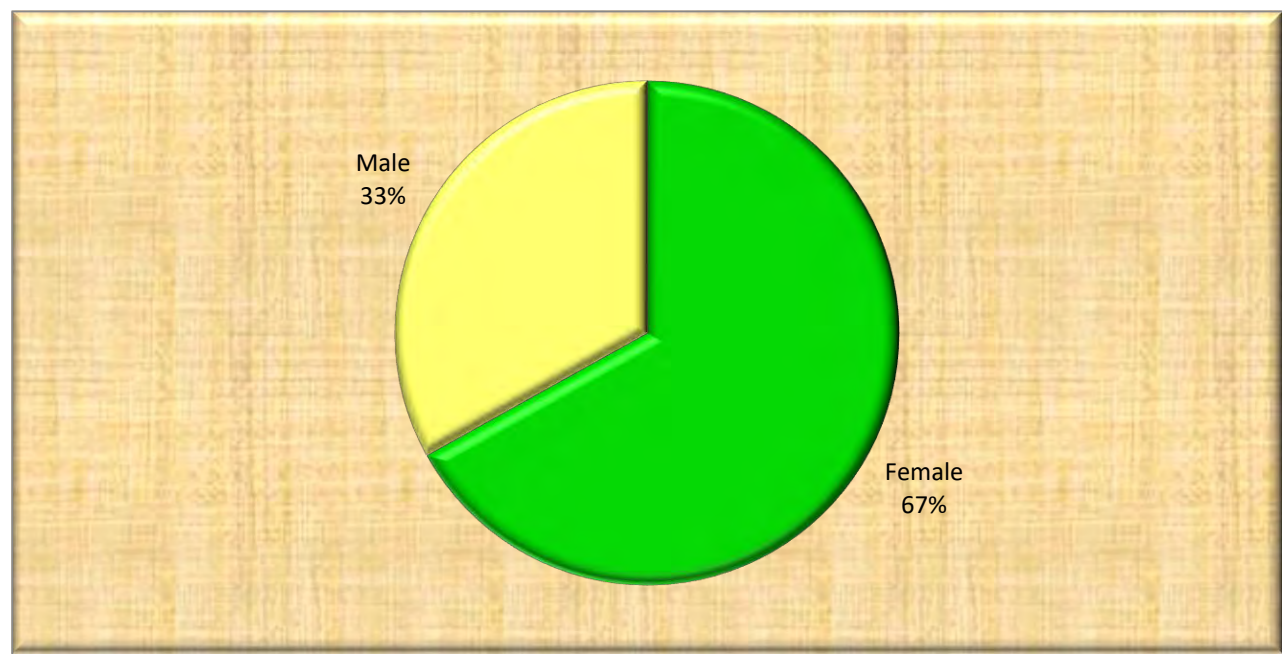
Figure 117: NYTD 2021AB - Services Provided [Chart]

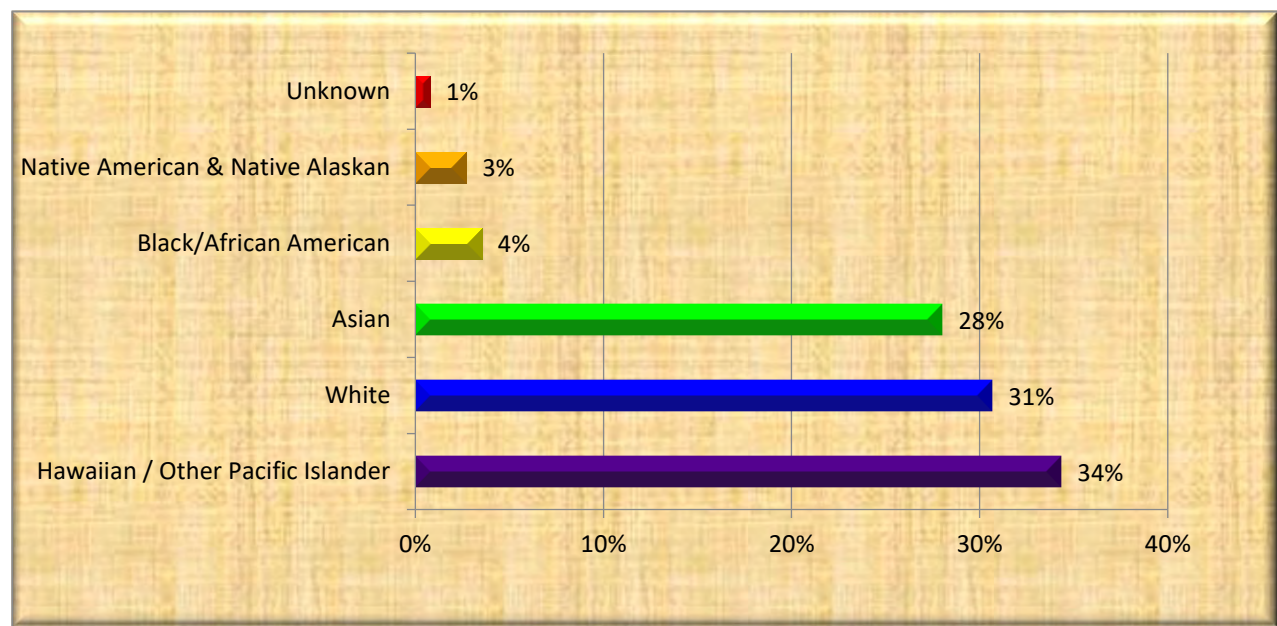

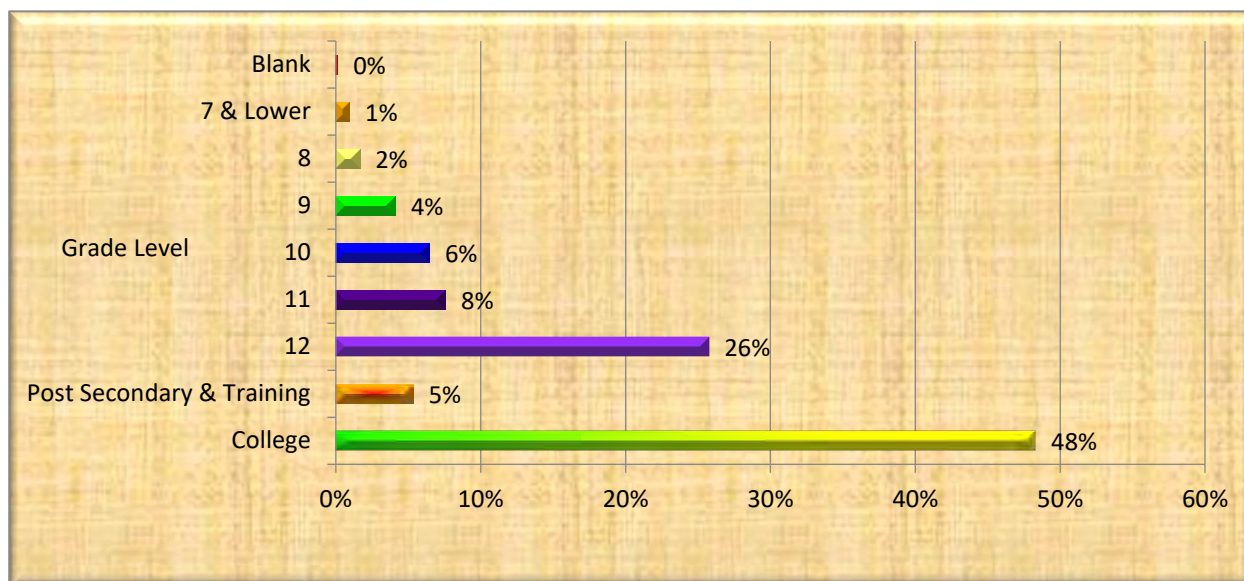
Figure 119: NYTD 2021 AB – Participant Distribution by Race [Chart]

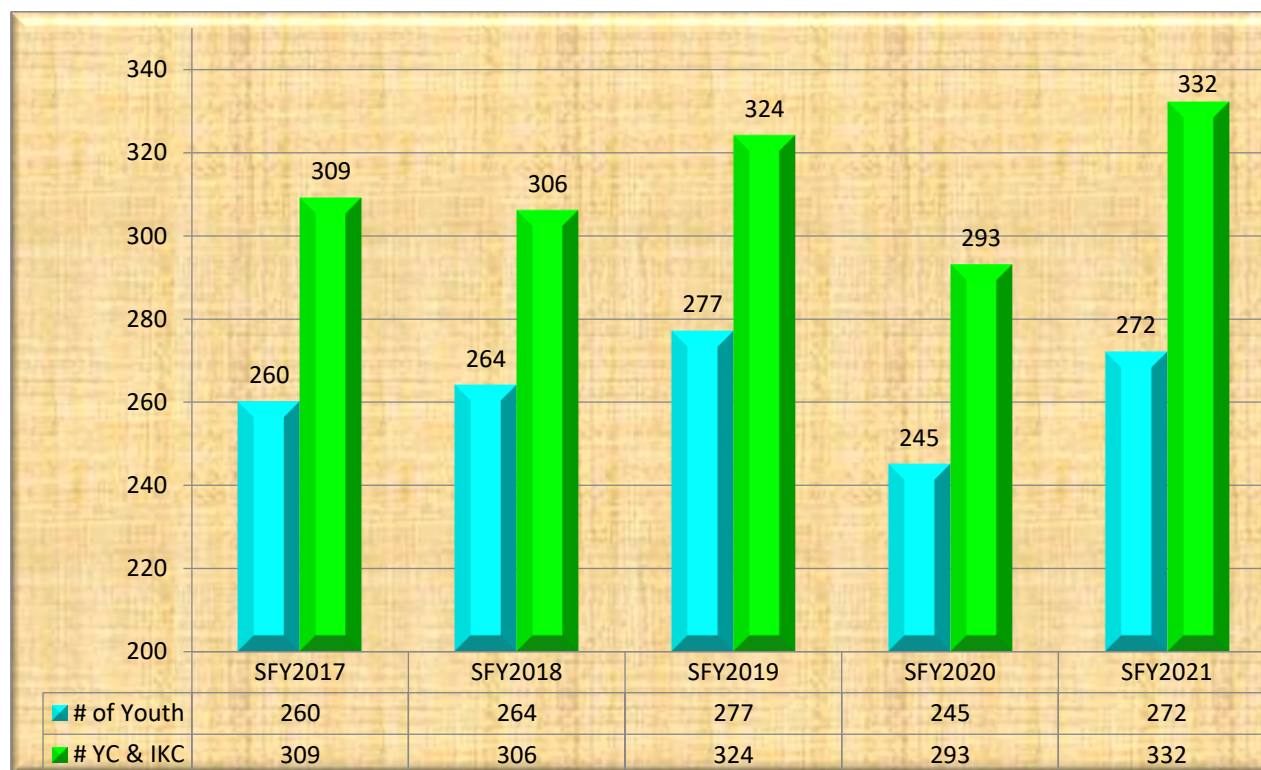


NEW Figure 120: NYTD 2021AB – Participant Distribution by Grade Level [Chart]

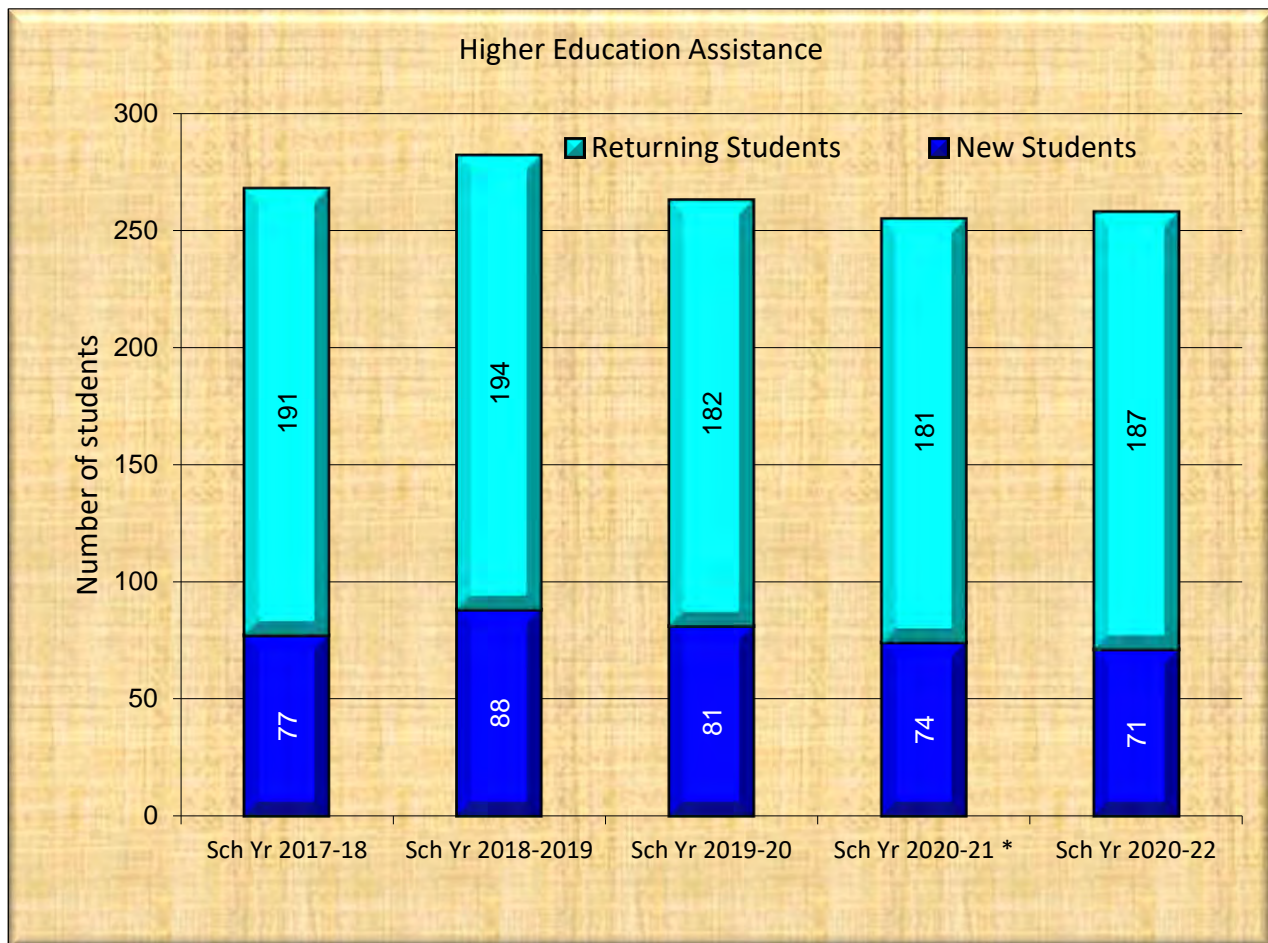
Figure 122: Higher Education Stipends School Years 2017-18 through 2021-22 [Table]

Figure 123: Higher Education Stipends School Years 2016-17 through 2020-21 [Chart]



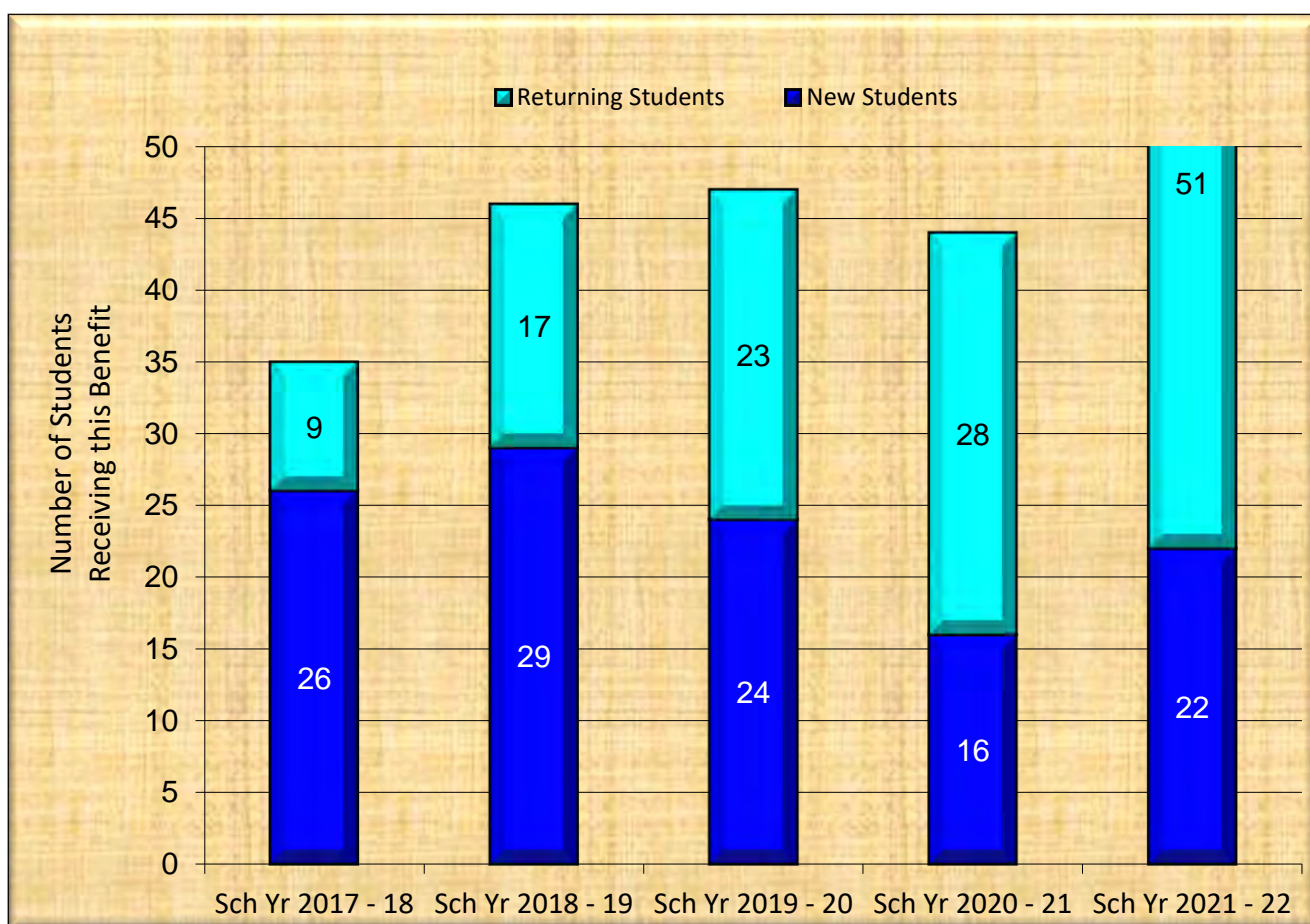

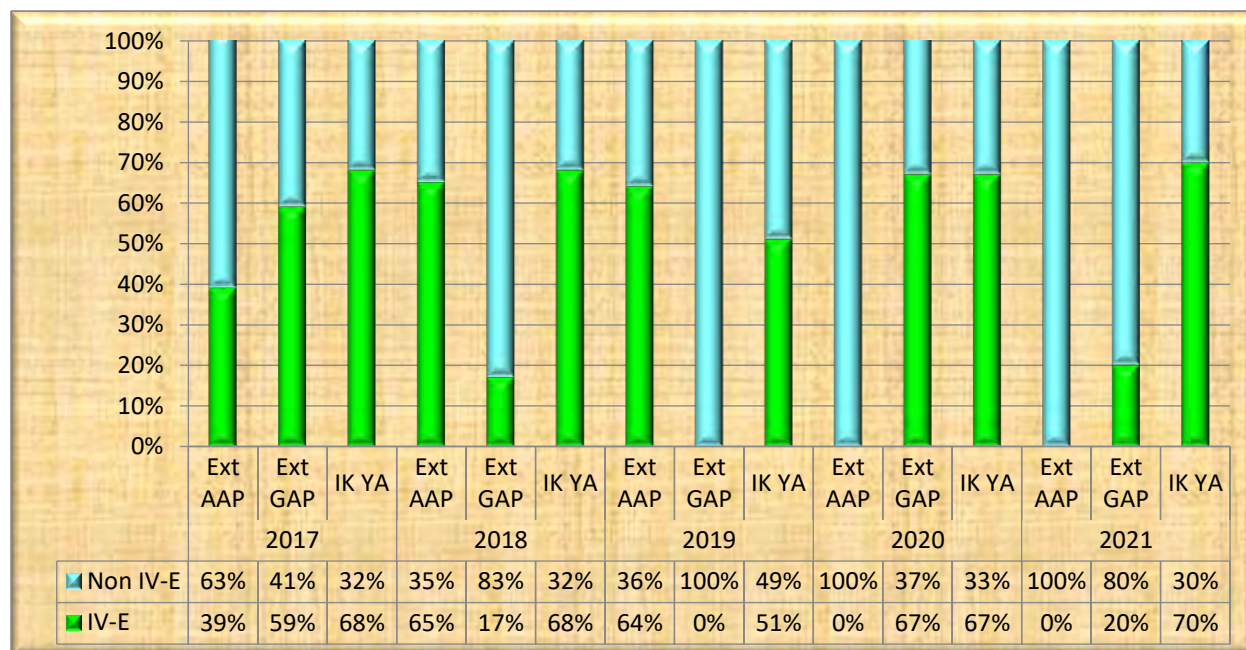

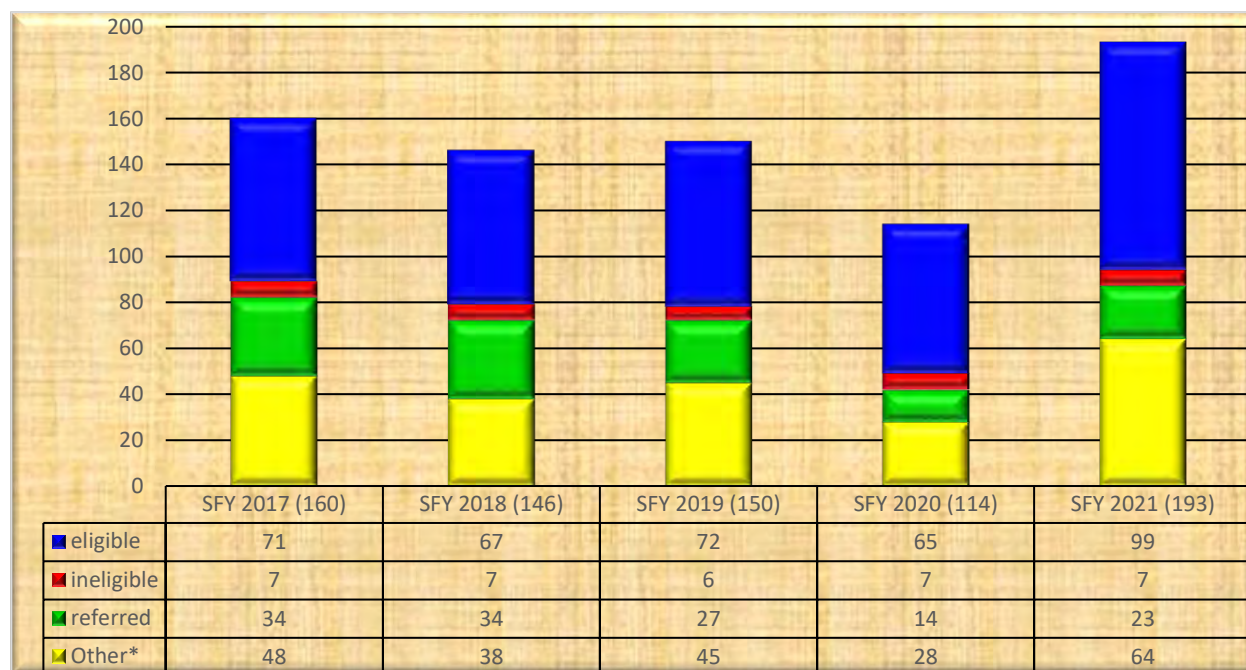

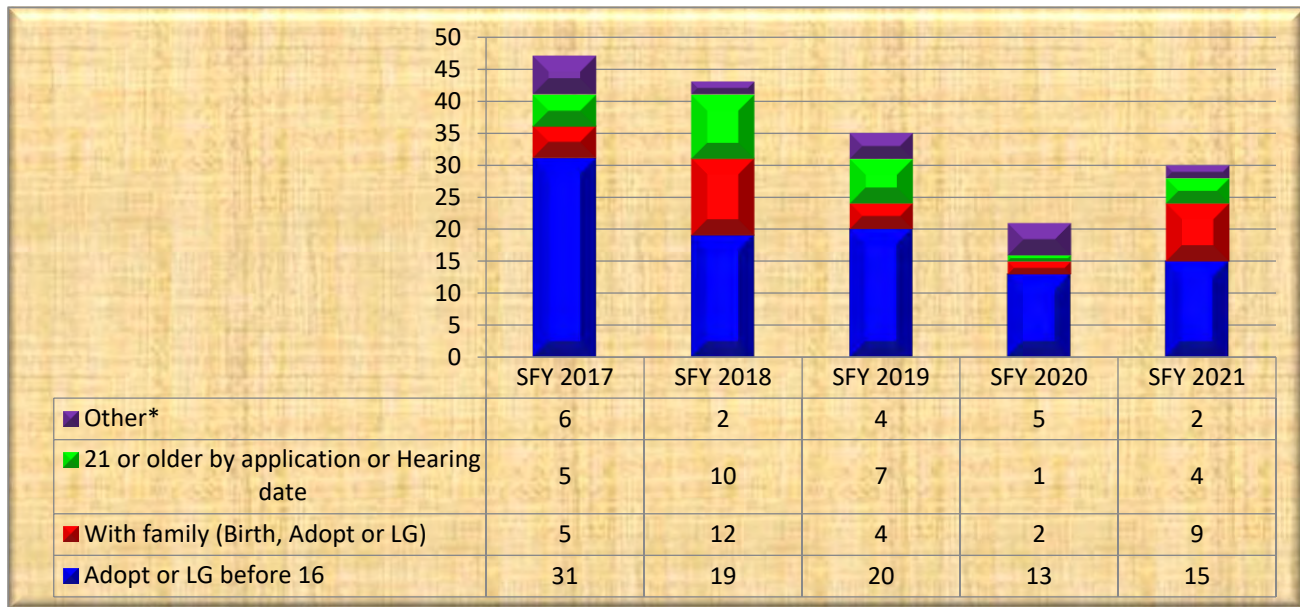
Figure 128: Imua Kakou Applications SFYs 2017 – 2021 [Chart]

**The following information** presents the findings from the Hawaii Child Welfare Continuous Quality Improvement (HCWCQI) Project Quality Case Review for the State of Hawaii, Department of Human Services (DHS), Child Welfare Services Branch (CWSB).

The following information presents the findings from the Hawaii Child Welfare Continuous Quality Improvement (HCWCQI) Project's Case Reviews for the State of Hawaii, Department of Human Services (DHS), Child Welfare Services (CWS).

A period under review (PUR) was identified for each review beginning January 1, April 1, July 1, or October 1 and ending on the first day that the case is reviewed. Ninety-Five (95) cases were randomly selected from both foster care and in-home cases in CPSS. Between 10 and 17 cases were selected from each CWSB Section. The neighbor island sections included cases from their corresponding Voluntary Case Management (VCM) units. Oahu VCM held a separate review with 6 cases. To be eligible for review, an in-home case must have been opened for at least 45 consecutive days during the period under review, and a foster care case must be for a child in foster care for at least 24 hours during the sampling period. For foster care cases, reviewers focused on one target child. For in-home child welfare cases, reviews focused on all children in the home.

The case reviewers thoroughly read the case files including CPSS database and interviewed caseworkers, supervisors, parents, children, resource caregivers, service providers, and/or Guardians ad Litem. HCWCQI staff assured the quality, validity, and accuracy of the results during the on-site review through at least two levels of quality assurance.

Due to COVID -19, from July 1, 2020 to June 30, 2021, the case reviews were conducted by a single trained reviewer from the HCWCQI team. A portion of cases was selected for a third level of QA review by a federal Administration for Children & Families (ACF) representative

Figure C1: Item 1 Timeliness of initiating investigations of reports of child maltreatment

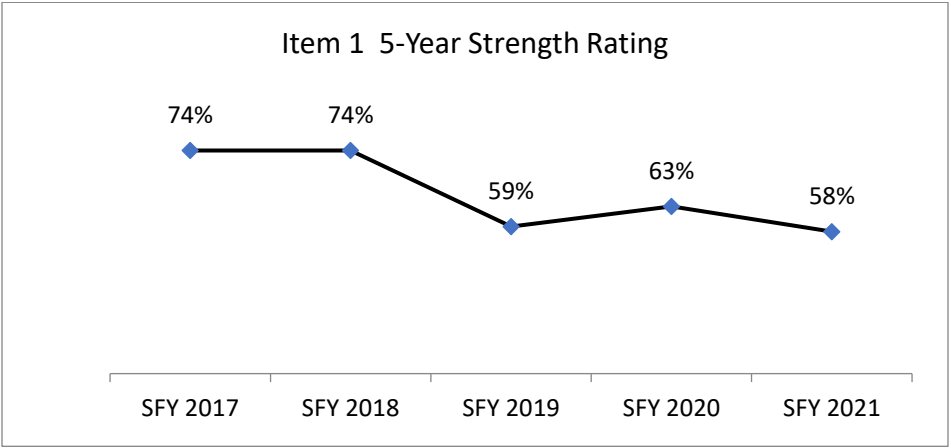


Figure C2: Item 2 - Services to family to protect child(ren) in the home and prevent removal or re-entry into foster care

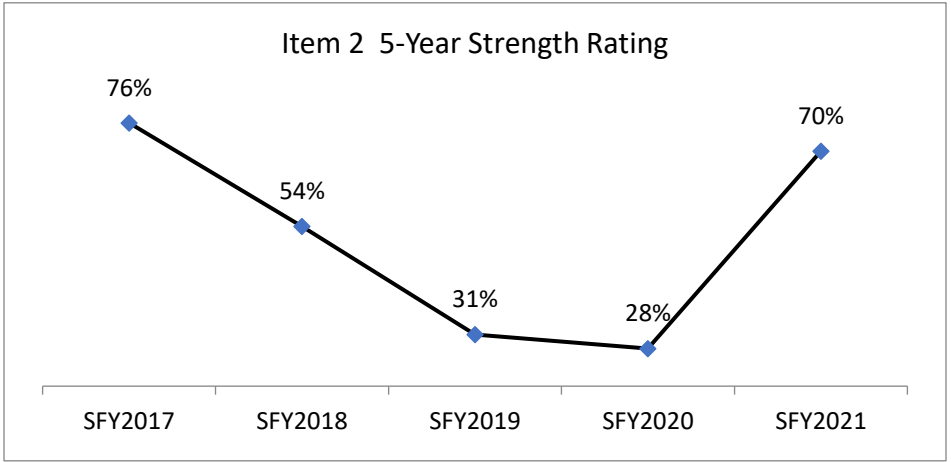


Figure C3: Item 3 - Risk assessment and safety management

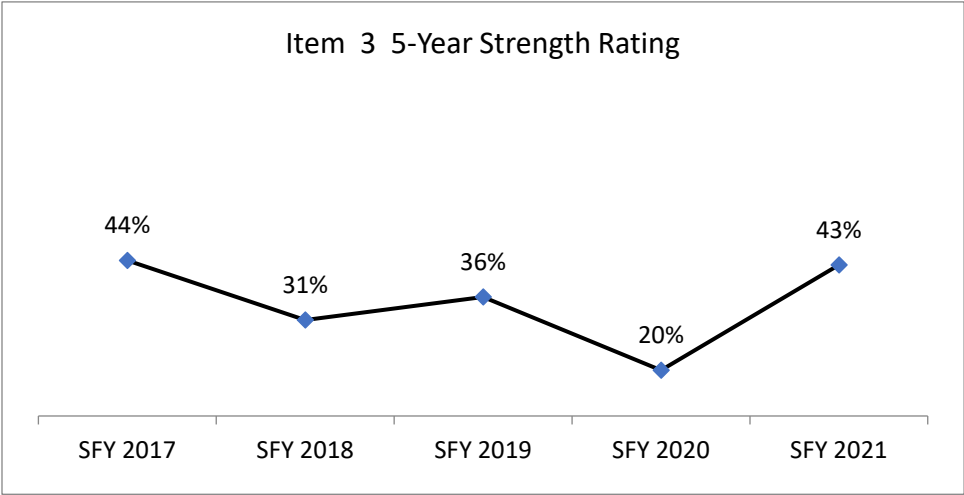


Figure C4: Item 4 - Stability of foster care placement

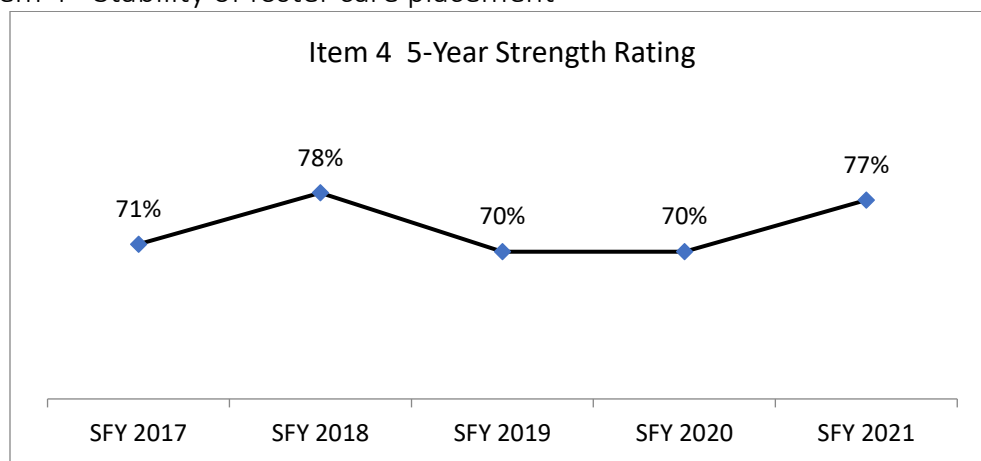


Figure C5: Item 5 - Permanency goal for child

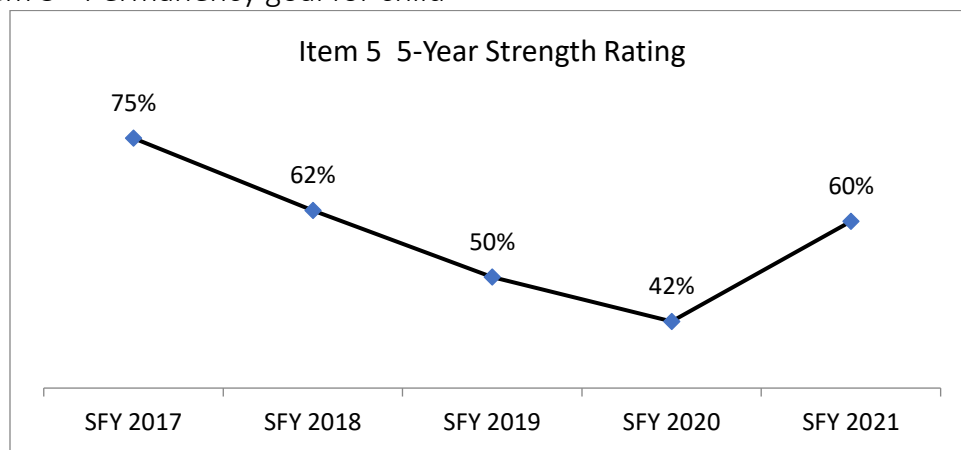


Figure C6: Item 6 - Reunification, guardianship, adoption

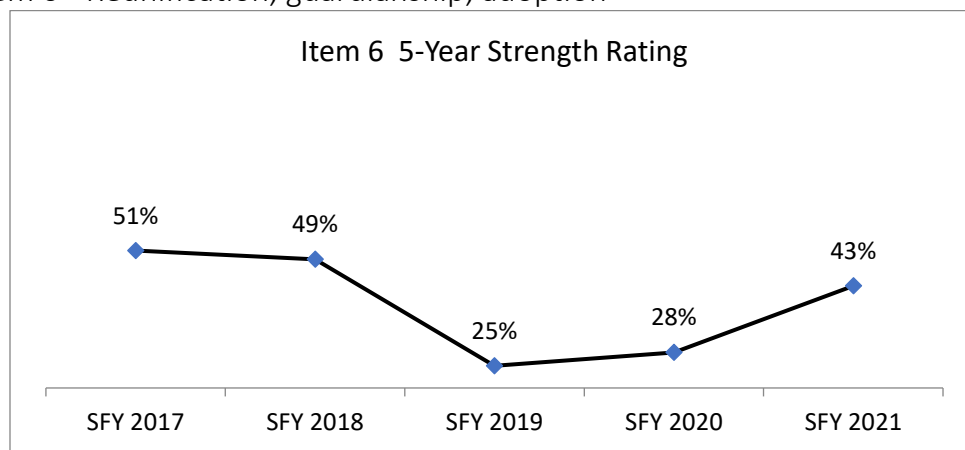


Figure C7: Item 7 - Placement with siblings

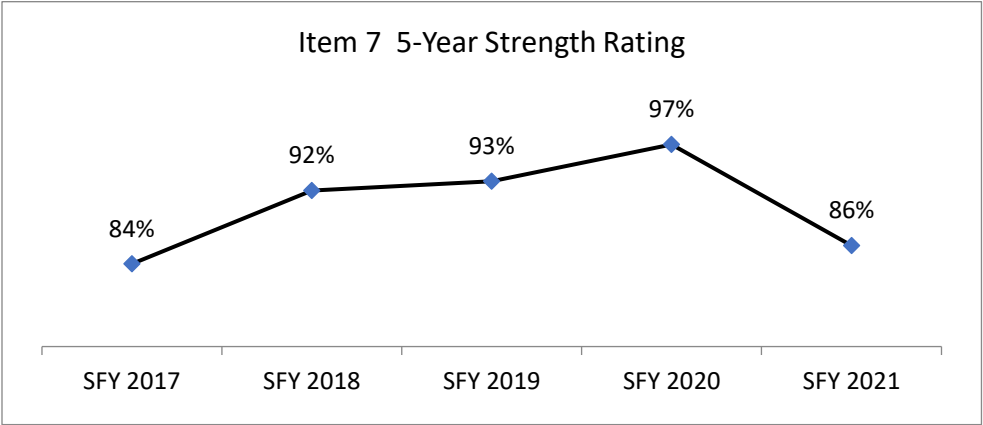


Figure C8: Item 8 - Visiting with parents and siblings in foster care

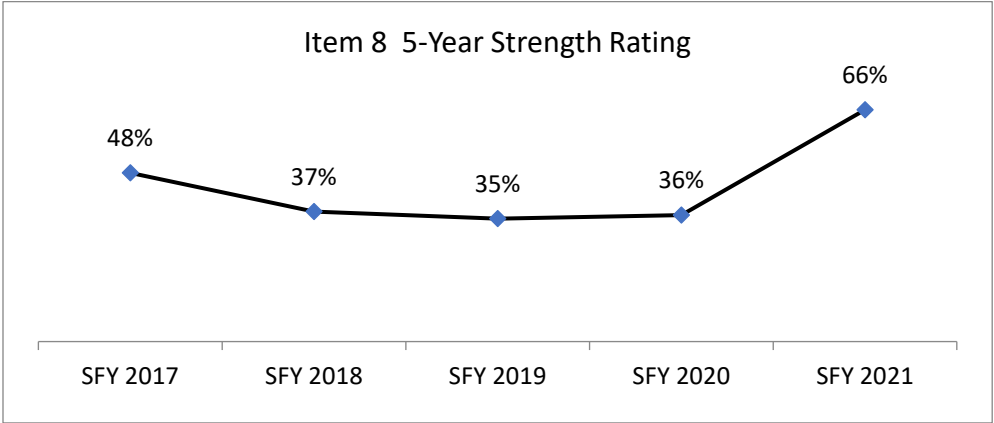


Figure C9: Item 9 - Preserving connections

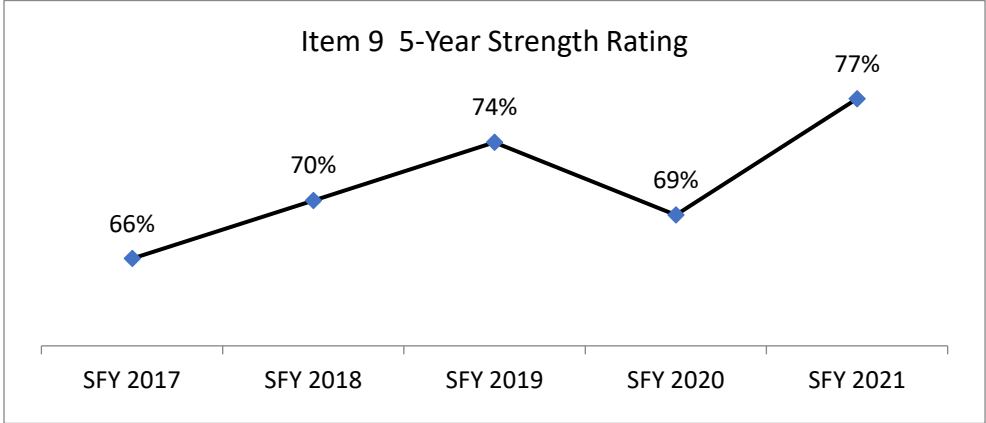




Figure C10: Item 10 - Relative placement

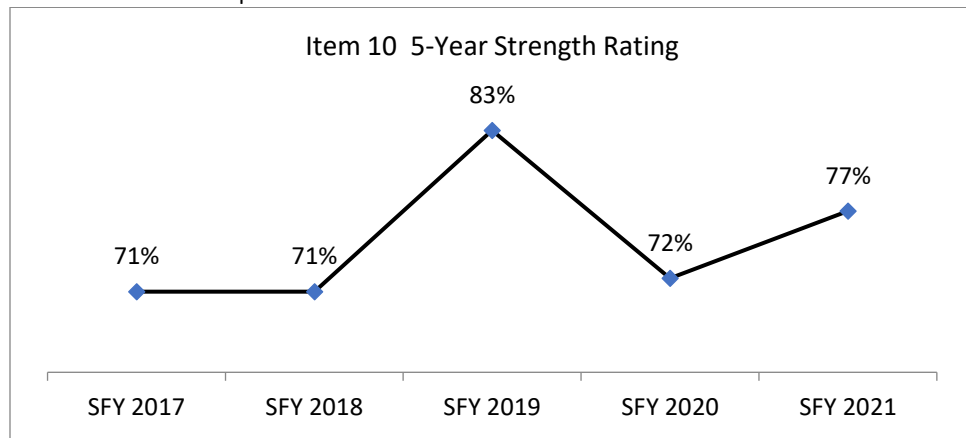


Figure C11: Item 11 - Relationship of child in care with parents

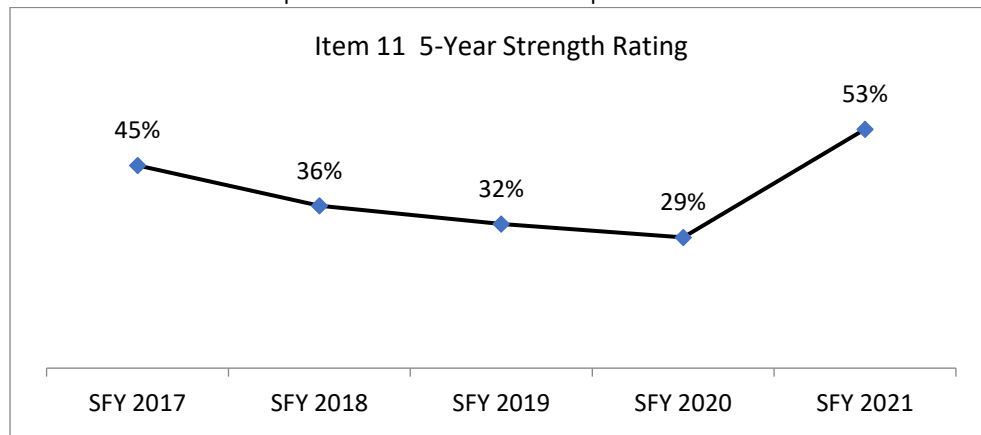


Figure C12: Item 12 - Needs and services of child, parents, and resource caregivers

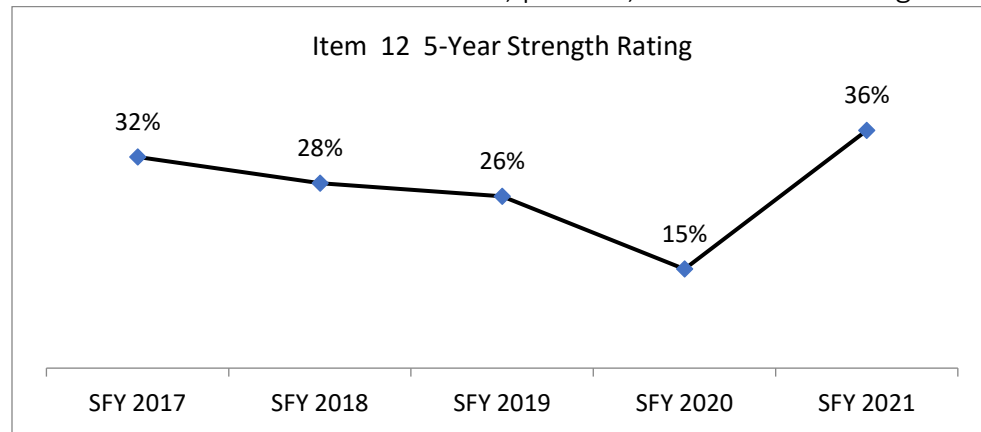


Figure C12a: Needs assessment and services to children

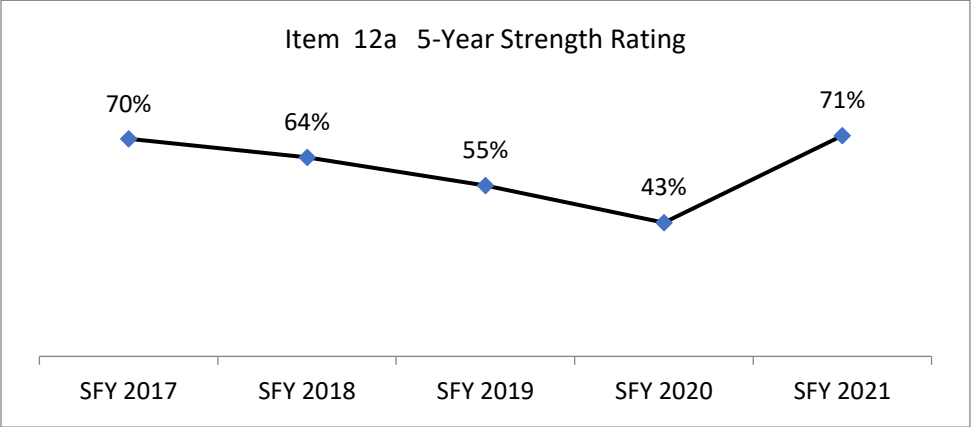


Figure C12b: Needs assessment and services to parents

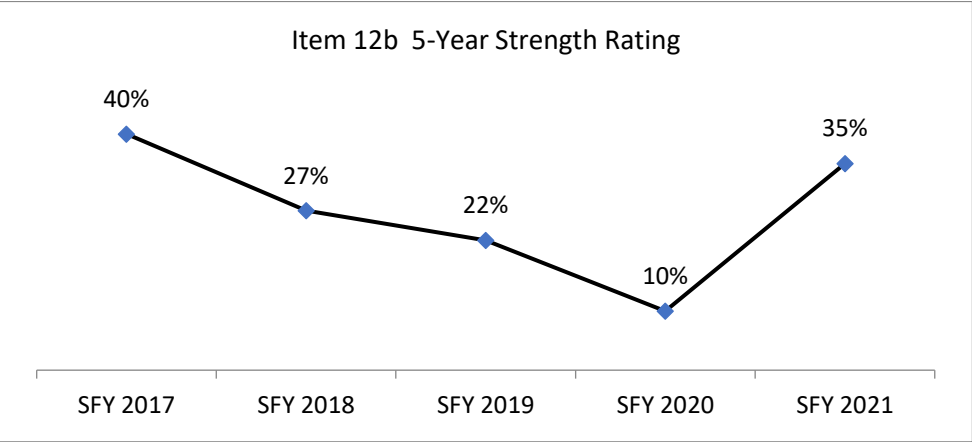


Figure C12c: Needs assessment and services to resource caregiver

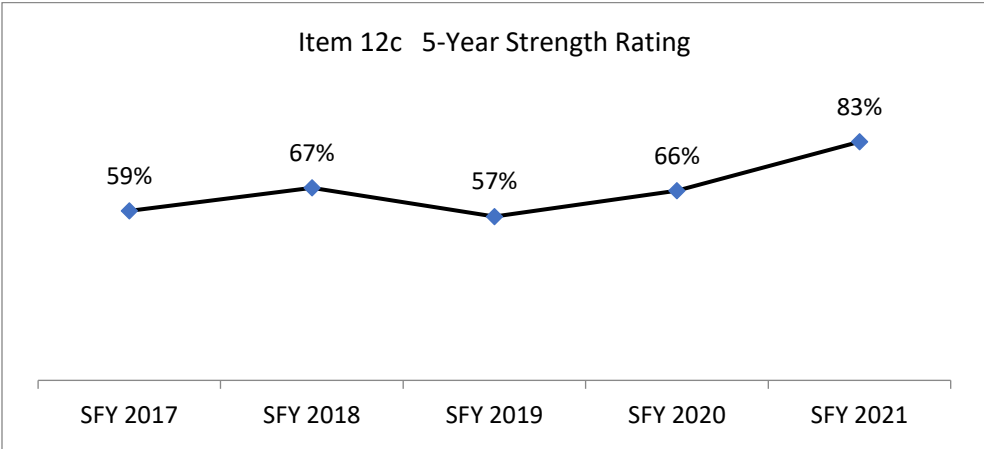


Figure C13: Item 13 - Child & family involvement in case planning

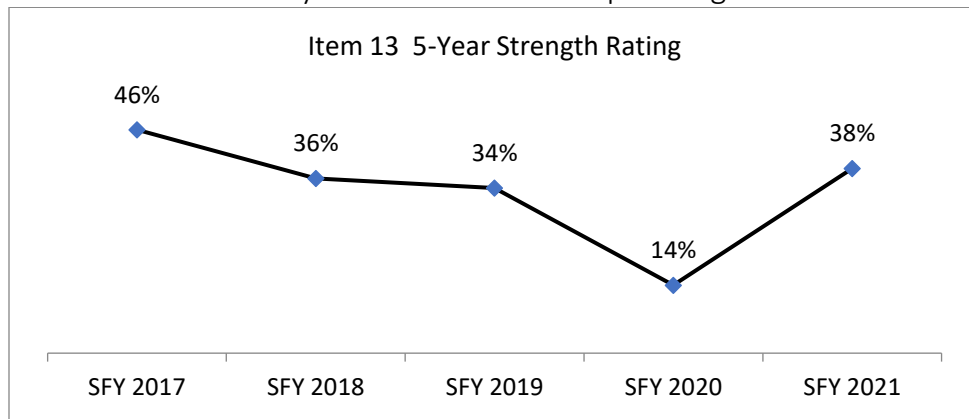


Figure C14: Item 14 - Caseworker visits with child

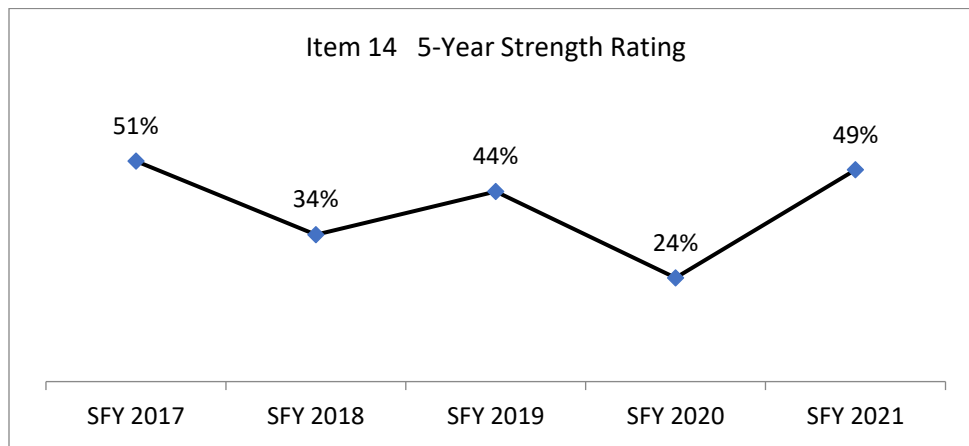


Figure C15: Item 15 - Caseworker visits with parent(s)

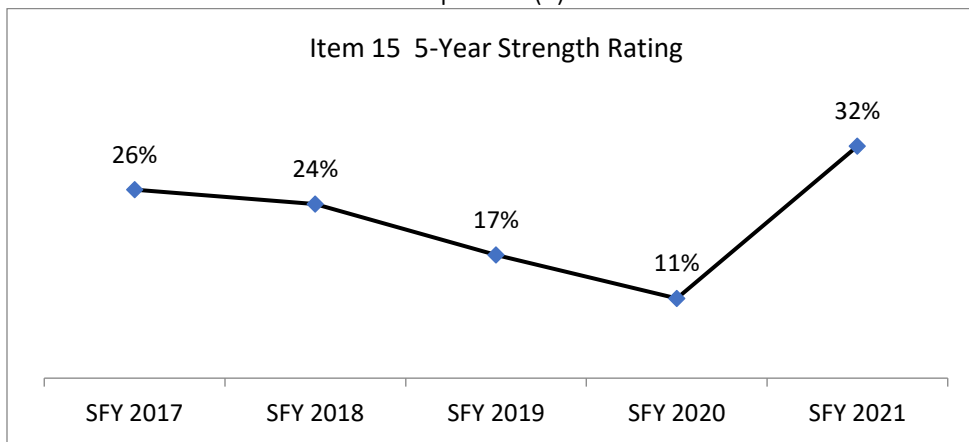


Figure C16: Item 16 - Educational needs of the child

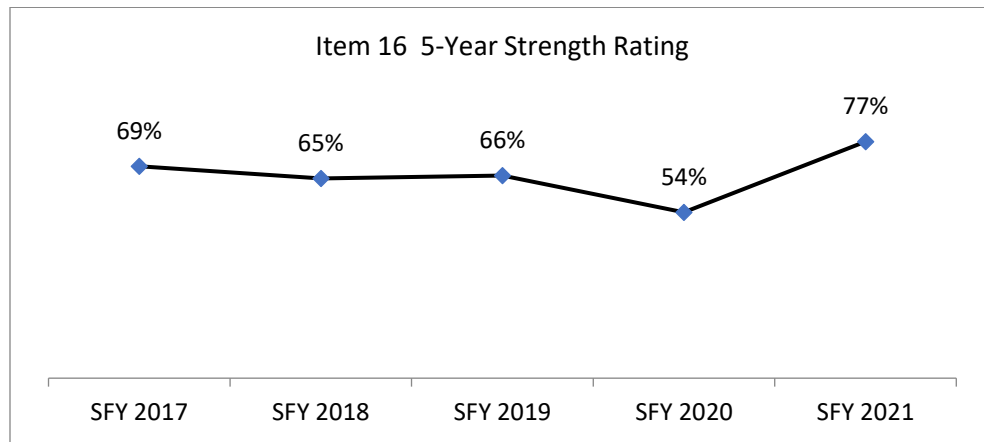


Figure C17: Item 17 - Physical health of the child

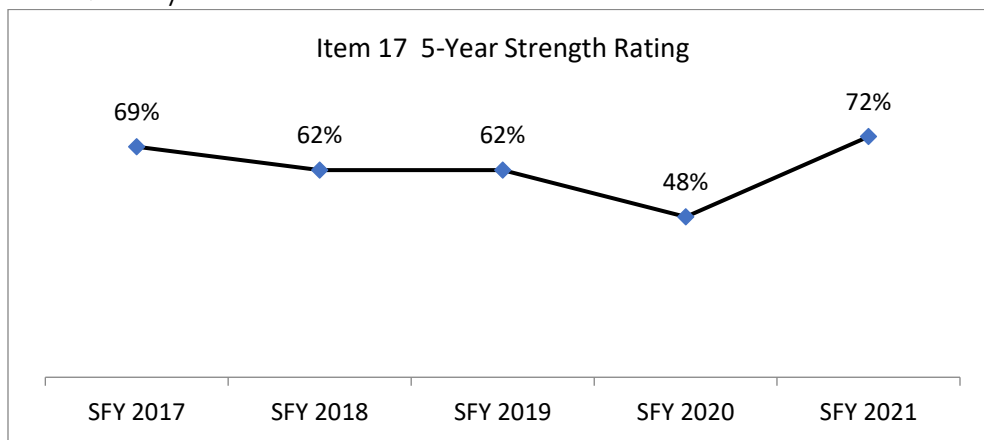


Figure C18: Item 18 - Mental/behavioral health of the child
