## **Projects**

1. Recruitment efforts continue and is an ongoing project. Our goal is to increase Panel membership with people who have diverse life and work experiences, backgrounds, and education. When we have in-person CRP meetings on neighboring islands we have an "Open House" scheduled for interested parties to come and meet us and find out what we're about. This past year we have welcomed five new members to our Panel. This new year, so far, we welcome aboard Heidi Allencastre who hails from Maui and will begin in January 2024.

2. We continue to look into ways that we can collaborate with the Department's Family First Hawai'i program.

3. Staff Wellness baskets are an ongoing project under the Staff Wellness Initiative. Since its start in June of 2021 these baskets contain items that help staff decompress during the day and support wellness in the workplace. Every section has a basket and we've included the Program Development unit this past year.
