PUBLIC NOTICE

Pursuant to 42 C.F.R. 447.205, the Department of Human Services ("DHS") is proposing to continue the increase to Medicaid reimbursement rates to eligible primary care physicians for certain primary care services. The proposed change will be submitted for review to the federal government as part of the Medicaid State Plan Amendment to be effective January 1, 2015.

Under the Affordable Care Act (ACA), the reimbursement rates for certain primary care services provided by eligible primary care physicians increased to 100% of the Medicare rates for a two-year period ending December 31, 2014. The increase was funded entirely with federal funds. DHS is proposing to continue the increased reimbursement for six months from January 1, 2015 through June 30, 2015 at the available lower federal funding rate using additional appropriated State funds.

Payments for certain primary care services provided by eligible primary care physicians will continue to be made in quarterly lump sum payments. Payments will be made by the Med-QUEST Division for claims submitted under the Medicaid Fee-For-Service program and by the health plans for claims and/or encounter data submitted under the Medicaid managed care program. Effective January 1, 2015, funding for the increased primary care payments has been incorporated into the capitation payments from DHS to the health plans; previously under the ACA provision, the health plans were able to separately invoice DHS. Lump sum payments will be calculated based on the difference between 100% of the Medicare rates and the published Medicaid Fee Schedule rates.
