DUTIES SUMMARY

The Health Care Outreach Coordinator works with Marketplace Assister organizations and Navigator organizations to ensure that the necessary and required outreach activities are occurring in the community, and difficult-to-reach and vulnerable populations are targeted to insure the individuals get health insurance coverage. This position assists in training assisters/navigators, problem solves challenges, and escalates to the Outreach Manager as necessary. This position also assists with the day to day Affordable Care Act community outreach and awareness activities.

MINIMUM QUALIFICATION REQUIREMENTS

LEGAL AUTHORIZATION TO WORK REQUIREMENT: The State of Hawaii requires all persons seeking employment with the government of the State shall be citizens, nationals, or permanent resident aliens of the United States, or eligible under federal law for unrestricted employment in the United States.

Bachelor's degree or equivalent community organizing experience.

Knowledge of community organizing techniques and state and federal health care programs, including Medicaid and other public benefits programs is preferred.

One (1) year navigating web-based portals/databases.

Two (2) years of experience in working with vulnerable populations in a medical or other setting is preferred.

Previous experience with health insurance enrollment and/or brokerage is preferred.
