Pandemic Electronic Benefit Transfer (P-EBT) ej kōjlā juon wōt kōtaan ñan baamle ko rekkar kōn kajjojo ajri im ekar bōk kijen mōñā ilo ejjełok wōñean ak edikłok wōñean. P-EBT ej jerbal āinwōt jipañ ko jān Supplemental Nutrition Assistance Program (SNAP) im enaaj jipañ baamle ko ñan ebbōk kijeer mōñā me rej aikuji ilo tōrein nañinmej-in-la] (pandemic) eo kiioki. Department of Human Services (DHS) eo enaaj jakemaanłok P-EBT ilo an karejar ippān Department of Education (DOE) eo.

Kapijukunen ko renabaj bōk jipañ ko āinwōt juon wōt mōñein raelep im juon mabuñ ilo ejjełok wōñean kijen kajjojo ri-jikuuļ me ekkar, \$6.66 kōn kajjojo raan in jikuuļ ilo schedule eo ekkā ñan jemłokin 2019-20 DOE iiō in jikuuļ eo. Men in ej kōpool raan ko ilo allōñ in March, April, im May.

Baamle ko me rej ebbōk jipañ jāān SNAP im/ak jāān wōt jāān DHS im emōj an wōr juon aer Kokua Card renaaj bōk bar jāān in kakoba ilo kaat ko aer me elōn kiiō. Baamle ko me ejañin wōr juon aer Kokua Card renaaj bōk juon kaat in Hawai'i P-EBT kanne-mokta ilo mael eo.

Enaaj wōr 180 raan (6 allōñ) jān allōñ eo im kōmij bōk jipañ ko jān P-EBT kōn baamle ko im elōñ juon aer Kokua Card, ak 180 raan (6 allōñ) jān raan eo im kwōj jinoe Hawai'i P-EBT eo am, ñan jołoke jipañ ko am jān P-EBT mokta jān an maat. Kōn baamle ko im elōñ aer Kokua Cards, enaaj automatic wōt am jołoke jipañ ko jān P-EBT mokta jān jipañ ko am rekkā jān SNAP.
