      - a) Keila Velasquez
    - 2. Budget
      - a) Balance \$4,000 for the reminder of the quarter, may change due balancing accounts during secretary transition. Overall, we have about \$20,000 remainder.
    - 3. Hawai'i Abortion Collective
      - a) August 31 Abortion Guide Launch
        - (1) Successful launch. First guide ever created on abortion rights in Hawai'i.
      - b) Neighbor Island Outreach and Leadership
        - (1) Kaua'i
          - (a) Newly formed abortion access working group, Ignacio-Neumiller is part of this group.
          - (b) Torn over whether to address abortion stigma or just focus on policy advocacy. Kaua'i had a planned parenthood clinic and was funded by the legislature for 2 years, funding ended and the clinic closed due to political opposition from local community. Telltale lesson in need to organize community, not just policy.

- (c) Certified midwife who is the president of The National College of Midwifery, offering to partner with HSCSW to fly to Kaua'i and offer 2-day free training, available the week of November 15<sup>th</sup>.
- (2) Moloka'i December 1
  - (a) Possible event with the faith community.
- (3) Jabola-carolus went over the collective voting results on Hawai'l Abortion Collective policy priorities.
  - (a) Top pick was funding a Statewide abortion access coordinator-train an army of nurses; travel for OB's to travel from Oahu to the neighbor islands; County navigators/coordinators for the neighbor islands.
- c) Accessibility Funding Request
  - (a) Request for funding to produce dissemination materials like brochure of guide and to translate guide into different languages that can fit in a brochure. Materials has been approved to be placed in libraries and we continue to do outreach to community health clinics. Motosue, Adaro, Ignacio-Neumiller, and Stotter agree.
  - (b) Motosue Motioned to approve \$3,000 for the Hawaii Abortion Collective guide to be created into brochure, translated in various languages and be distributed Statewide, seconded by Adaro ALL IN FAVOR, MOTION CARRIED.
- MMNHWG Taskforce
  - a) Report will be released on December 14<sup>th</sup>.
  - b) Secured a grant from the Urban Indian Health Institute for continued work possible for the principal investigator to continue research for the 2<sup>nd</sup> phase.
  - c) A lot of public interest when the report is released. Jabola-Carolus will be available for presentations.
  - d) Stotter asked what the report is expected to cover. Jabola-Carolus responded with quantitative data and the 2<sup>nd</sup> phase will be qualitative research trying to fill in the gaps and answer questions by what wasn't answered and building recommendations.
