IN ACCORDANCE WITH THE PROVISIONS OF SECTION 346-29.5, HAWAII REVISED STATUTES, ON REAL PROPERTY LIENS

Med-QUEST Division Department of Human Services December 2023

Section 346-29.5, Hawaii Revised Statutes (HRS), requires the Department of Human Services (DHS) to submit an annual report to the Legislature, which shall include a list of liens held by DHS on real property. In addition, this report shall include a description of the value of the liens, the legal status of the liens, and when the liens were initiated.
