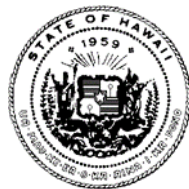

In 1964, Governor John A. Burns created by Executive Order the Hawai'i State Commission on the Status of Women (HSCSW). The work of the HSCSW is detailed in section 367-1 and sections 367-3 (1) through (8), Hawai'i Revised Statutes (HRS), while county Committees on the Status of Women (CSW) duties are outlined in section 367-4.
