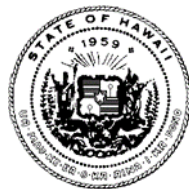

Section 346-29.5, Hawaii Revised Statutes (HRS), requires the Department of Human Services (DHS) to submit an annual report to the Legislature, which shall include a list of liens held by DHS on real property. In addition, this report shall include a description of the value of the liens, the legal status of the liens, and when the liens were initiated.

Please find the attached reports prepared by the Department of Attorney General on behalf of DHS. Attachment 1 is a summary report for recoveries made during the period (July 1, 2024–June 30, 2025). The Department of Attorney General recovered **\$1,667,718.15** on the dates listed.
